TRUTH IN LENDING

AMENDMENT TO REGULATION Z*

26. Effective August 1, 1980, Section 226.5 is amended by adding paragraph (d) to read as follows:

SECTION 226.5—DETERMINATION OF ANNUAL PERCENTAGE RATE

* * * * *

(d) Special rule for irregular mortgage transactions. Notwithstanding any other provision in this section, the annual percentage rate in an irregular mortgage transaction shall be considered accurate if it is not more than one-half of one percentage point above or below the annual percentage rate determined in accordance with either the actuarial method or the United States Rule method. For the purpose of this paragraph, an irregular mortgage transaction is a real property transaction involving one or more of the following features: multiple advances, irregular payment periods (other

than an irregular first period, as defined in footnote, 5c), and irregular payment amounts (other than irregular first and last payment amounts). This paragraph shall cease to be effective on March 31, 1981, after which date the general standard of accuracy in paragraph (b) of this section shall apply.

2. The October 1, 1980 effective date of the amendment to previous § 226.5(a) and of the revocation of previous §§ 226.5(b) through (e), Interpretations §§ 226.502, 226.503, and 226.505, and previous Supplement I to Regulation Z (no. 22 on page 10 of the amendment pamphlet) has been deferred until April 1, 1982. The footnote to no. 20 on page 8 of the amendment pamphlet should be revised to read as follows:

*These revisions will be effective concurrently with those in existence prior to January 10, 1980 until April 1, 1982 when these prior provisions will be rescinded. ***
