1982 PRICING AND BILLING SCHEDULE
FOR THE ELEVENTH FEDERAL RESERVE DISTRICT

TO THE FINANCIAL INSTITUTION ADDRESSED
IN THE ELEVENTH FEDERAL RESERVE DISTRICT:

The Federal Reserve System has developed uniform billing cycles for payment of charges incurred for priced services. A monthly summary statement of service charges incurred over the billing cycle will be provided directly or indirectly to Federal Reserve customers.

Printed on the reverse of this circular is a 1982 calendar indicating the scheduled dates on which (1) the monthly billing cycle ends; (2) the monthly billing statements are prepared; and (3) the date the charges will be assessed.
