# ELECTION OF DIRECTORS REPORT OF NOMINATIONS—VOTING PROCEDURES

# To All Member Banks in the Eleventh Federal Reserve District:

In accordance with the provisions of Section 4 of the Federal Reserve Act, as amended by the Federal Reserve Reform Act of 1977, and my circular dated August 17, 1982, in regard to the election of directors of this Bank to succeed John P. Gilliam, Class A Director, and Robert D. Rogers, Class B Director, whose terms expire December 31, 1982, there are given herein the names of the candidates nominated for such directors and the names of the banks which made the nominations.

Except in the case of any member banks that are subsidiaries of the same bank holding company,\* there is sent herewith to each bank in Group 1 a ballot for use in voting for a Class B Director and to each bank in Group 3 a ballot for use in voting for a Class A Director. Also enclosed are an envelope bearing on its face the certificate in regard to the vote and a colored envelope marked "Ballot—Directors' Election," in which the ballot is to be sealed. When several banks are subsidiaries of a bank holding company, the voting forms are being sent only to the bank designated to participate in this election; therefore, banks in Groups 1 and 3 that will not participate in this election are being sent this circular, without forms, for their information.

The ballot and certificate on the envelope must be executed by an officer who has been authorized to cast the vote. A list of the designated officers, revised to date, forms a part of this circular. In order that the balloting may be secret, the name of the bank and the voting officer should not be written on the ballot but only on the certificate envelope. If the official signature of the officer casting the ballot has not been filed with this Federal Reserve Bank, such official signature should be filed before the polls close.

Please follow carefully the instructions which are printed on the ballot, on the envelopes, and on page 3 of this circular.

The following procedure is required in the case of both the Class A and Class B ballots:

- (1) The preferential ballot should be marked.
- (2) It should be placed in the colored envelope marked "Ballot—Directors' Election" and that envelope sealed.
- (3) Then after the certificate on the white certificate envelope is executed, the colored sealed envelope (containing the ballot) should be placed within the white certificate envelope and that envelope sealed.
- (4) The sealed white certificate envelope containing the sealed ballot envelope should then be returned to me in the enclosed self-addressed envelope.

"...That whenever any member banks within the same Federal Reserve district are subsidiaries of the same bank holding company within the meaning of the Bank Holding Company Act of 1956, participation in any such nomination or election by such member banks, including such bank holding company if it is also a member bank, shall be confined to one of such banks, which may be designated for the purpose by such holding company."

In this connection, the Board of Governors of the Federal Reserve System has ruled that a holding company affiliate, having one or more subsidiary banks in each of the three groups into which member banks of a Federal Reserve district are divided for the purpose of electing directors, may designate one such bank in each group to participate in the nomination and election of each Class A Director and each Class B Director chosen by the group of which such bank is a member, and such member bank so designated may validly participate in such nomination and election. Accordingly, banks in Groups 1 and 3 affected by the foregoing provision of law are requested to take prompt action to have the appropriate bank holding company designate, if it has not already designated, one of such banks to participate in this election.

<sup>\*</sup>Section 4 of the Federal Reserve Act, as amended, reads in part as follows:

Under the law, the ballot must be returned so as to reach me within 15 days after its receipt. The polls will open on October 6, 1982, and close at 2 p.m. on October 21, 1982. At that time, the ballot box will be opened at this Bank, the sealed envelopes containing the ballots will be opened, the votes counted, and the results of the election announced. The candidates are invited to be present or represented on that occasion.

While the banks in Group 2 will not vote in this election, this circular is sent to them, without forms, for their information. Group 2 consists of member banks with combined capital and surplus of over \$1,500,000, but under \$4,000,000.

#### **IMPORTANT**

For your information, there is quoted below an extract from Section 4 of the Federal Reserve Act which sets forth the method of balloting:

"Within fifteen days after receipt of the list of candidates the duly authorized officer of a member bank shall certify to the chairman his first, second, and other choices for director of Class A or Class B, respectively, upon a preferential ballot upon a form furnished by the chairman of the board of directors of the Federal Reserve Bank of the district. Each such officer shall make a cross opposite the name of the first, second, and other choices for a director of Class A and for a director of Class B, but shall not vote more than one choice for any one candidate."

In the case of the Class A ballots (Group 3), where there are two candidates involved, a member bank, in making its first choice, will be deemed to have indicated the other candidate as its second choice.

Ted Enloe is President, a director, and member of the Executive Committee of Lomas & Nettleton Financial Corporation, a mortgage banking company, in Dallas, Texas. In addition, Mr. Enloe serves as President and director of Lomas & Nettleton Mortgage Investors, a business trust engaged in short-term real estate lending, and L&N Housing Corp., a corporation that invests in new multi-family rental projects.

Mr. Enloe was born in Mansfield, Louisiana, and attended Louisiana Polytechnic Institute, graduating in January 1961 with a Bachelor of Science degree in petroleum engineering. He began work with Shell Oil Company U.S.A., but resigned to enter Southern Methodist University School of Law in September 1961. In June 1964, he graduated magna cum laude from Southern Methodist with a Juris Doctorate. While at SMU, he served as Editor-in-Chief of the Southwestern Law Journal. From 1964 to 1969, Mr. Enloe was an associate in the Dallas law firm of Locke, Purnell, Boren, Laney & Neely.

In October 1969, he joined Lomas & Nettleton Financial Corporation and Lomas & Nettleton Mortgage Investors as Executive Vice President. In 1975, he assumed the office of President of both firms. In May 1981, L&N Housing Corp. commenced operations, and Mr. Enloe was named President and a director. All three firms are publicly held and are listed on the New York Stock Exchange.

Mr. Enloe is a director of Templeton Energy, Inc.; Leggett & Platt, Incorporated; LaQuinta Motor Inns, Inc.; and a member

of the Texas Bar Association, American Bar Association, and Board of Governors for the National Association of Real Estate Investment Trusts.

In addition, he serves as a trustee of the Dallas Alliance, a director of the Young Men's Christian Association of Metropolitan Dallas, a trustee of The Hockaday School, a member of the Associate Board of SMU School of Business, a director of the Center for Non-Profit Management, and a member of the Advisory Board of the Junior League of Dallas. He is a past director of the United Way of Metropolitan Dallas and past President of The Dallas Assembly.

Mr. Enloe is a member of Highland Park Presbyterian Church, Young Presidents' Organization, and The Dallas Assembly.

He is married to the former Bess Fraser, and they have two daughters, Rebecca and Elizabeth, who attend The Hockaday School.

#### JOHN P. GILLIAM

President and Chief Executive Officer First National Bank in Valley Mills Valley Mills, Texas

John P. Gilliam is President and Chief Executive Officer of the First National Bank in Valley Mills. His banking career began in 1956 when, following graduation from public schools in Clifton, Texas, he was selected as a recipient of a scholar-ship from The Citizens National Bank of Waco to study banking at Baylor University. While at Baylor, Mr. Gilliam worked at the Waco bank during the summers, earned a letter in baseball, and received a B.B.A. in 1960.

His post graduate work was done at the Wharton School of Finance at the University of Pennsylvania, and he received an M.B.A. from Baylor University. Mr. Gilliam was selected for a summer exchange program and worked in 1961 for the Royal Greenland Trade Department in Denmark.

In 1961, he joined The Citizens National Bank of Waco and became an officer in 1963. In 1968, Mr. Gilliam purchased controlling interest in The First National Bank in Valley Mills, and has served as President since then.

From 1971 to 1974, he continued his academic interests by teaching in the Hankamer School of Business at Baylor University.

Mr. Gilliam served as Chairman of District IV, Texas Bankers Association in 1974, and as director of the Texas Bankers Association from 1975 to 1977. He is past President of the Central Texas Chapter of the Bank Administration Institute.

From 1976 to date, Mr. Gilliam has served as Bosque County's Chairman of the Easter Seal Appeal and the American Cancer Society. In addition, he served a three-year term as member of Leon-Bosque Resource Conservation and Development Project of Texas. Mr. Gilliam is a member and past President of the Valley Mills Chamber of Commerce and served on the Valley Mills Planning Commission.

He is a member of The First Baptist Church in Valley Mills and did serve on the Business and Audit Committee of the Baptist General Convention of Texas from 1975 to 1981. He presently serves on the Board of Directors of the Baptist Church Loan Corporation.

Mr. Gilliam married the former Allison Goff of Dumas, Texas, and they have a son and a daughter who are still in school in Valley Mills.

This year, Mr. Orr was named Headliner of the Year by the Press Club of Dallas and Man of the Year by the Dallas County Chapter of the National Association for the Advancement of Colored People. He was Outstanding Man of Oak Cliff in 1976, Outstanding Man Under 35 in DeSoto in 1963, and Outstanding Man Over 35 in DeSoto in 1975. In addition to these honors, County Line Road has been renamed Roy Orr Boulevard and a park in DeSoto has been named after him.
