Comparison Chart of Old and New Regulation X Sections

AGENCY: Board of Governors of the Federal Reserve System.

ACTION: Regulation X Comparison Chart.

SUMMARY: On December 16, 1983, the Board approved a completely revised and simplified Regulation X. The new regulation is effective as of January 23, 1984. To facilitate an understanding of the new regulation, this chart provides a cross-reference of section numbers in the old Regulation X to their corresponding section numbers in the new regulation and vice versa. This chart will serve as an aid to persons tracing the regulatory treatment of specific issues addressed in Regulation X.
