SUBJECT:

New services available over the RESPONSE network

SUMMARY:

On October 1, depository institutions will be able to receive Treasury tax and loan advices and various cash letter advices over the Federal Reserve Bank of

Dallas' RESPONSE network.

DETAILS:

The Federal Reserve Bank of Dallas has announced two new services to be available through the Generalized Advice Retrieval System (GARS) beginning October 1, 1984, for those institutions connected with the Bank's RESPONSE communications network. GARS provides a common system for accessing advices of all types from the Dallas Fed.

Beginning October 1, depository institutions will be able to receive Treasury tax and loan advices over the RESPONSE network. Treasury tax and loan withdrawal and redeposit information as well as call report information will be made available generally around 4:30 p.m. daily. One advantage of this system is that depositors will be able to look at their statements directly.

In addition to the Treasury tax and loan service, several cash letter availability advices also will be added to the RESPONSE network. With the implementation of this new service, many of the conventional check processing advices can be accessed using the network. For the Dallas office, advices of credit and charge will be available to both the correspondent and the respondent. For the branch offices -- El Paso, Houston and San Antonio -- a mixed cash letter summary advice will be available to the correspondent.

Advices of charge and commingled cash letters also will be provided. Multiple advice codes will be used to provide report segregation. For the Dallas office only, reports on RCPC/group sort items will be available around 5:00 to 7:00 a.m. and reports on city/country items will be available around 4:00 to 6:00 p.m. daily.

Those correspondent banks with dedicated equipment in other areas of their bank may want to acquire a personal computer to be located conveniently for this use or they may want to add more equipment to the controller they have now and put another printer and CRT in another location. Those who already have a personal computer link to the RESPONSE network also have the option of acquiring another personal computer for convenient use.

Hard copy Treasury tax and loan advices and cash letter advices will continue to be mailed.
