SUBJECT

**Official announcement of changes to staff and operational functions
of the Federal Reserve Bank of Dallas and its Branches**

DETAILS

It is a pleasure to announce that the Board of Directors of the Federal Reserve Bank of Dallas has made the following changes in the official staff of the Bank, effective January 1, 1985:

Robert J. Langlinais, formerly Assistant General Auditor, has been promoted to Vice President and General Auditor.

Helen E. Holcomb, formerly Director of the Corporate Banking Department, has been elected Assistant Vice President with continuing responsibilities in that department.

Stephen M. Welch, formerly Manager of the Statistics Department, has been elected Assistant Vice President with direct supervision over that department.

In addition, the Bank has regrouped its principal operational functions under two main divisions. These two divisions will report to two Senior Vice Presidents located at the Dallas Office, and a new organizational entity, the Dallas Branch -- which will be accorded equal status with the three existing Branches -- has been created.

Tony J. Salvaggio will be responsible for the Financial Services Division which will include the Corporate Banking Department and the four Branches: Dallas (encompassing the Cash, Mail, Payments Mechanism and Securities functions), El Paso, Houston and San Antonio.

Neil B. Ryan will be responsible for the Corporate Services Division -- encompassing the Data Services; Facilities Services, Management, and Records; Financial Planning and Control; Operations Analysis; Personnel; Protection; and Purchasing Departments. This Division will have a District-wide scope of responsibility.

James L. Stull, formerly Vice President and General Auditor, has been designated Vice President in Charge of the Dallas Branch.

In addition, the following changes have been made in the assignments of certain other officers, effective January 1, 1985:

Uzziah (Earl) Anderson, Assistant Vice President in the Supervision and Regulations Department, will be responsible for the Holding Company Inspections Division and the Surveillance Division.

Basil J. Asaro, Assistant Vice President in the Supervision and Regulations Department, will be responsible for the Applications Division.

Robert D. Hankins, Assistant Vice President in the Supervision and Regulations Department, will be responsible for the Bank Examinations Division.


Andrew W. Hogwood, Jr., formerly Assistant Vice President at the Houston Branch, has been reassigned to the Corporate Banking Department at Dallas.
