The Federal Financial Institutions Examination Council (FFIEC) has announced that the June 1985 UBPR is ready for distribution and sale to the public. The use of quarterly UBPR permits both summary and in-depth analysis of a commercial bank's financial performance and trends.

## Press Release

The June 1985 Uniform Bank Performance Report (UBPR) is now being distributed to all insured commercial banks and is available for sale to the public.

The quarterly UBPR is designed for use by bank examiners, financial analysts and bank managers, and permits both summary and in-depth analysis of a commercial bank's financial performance and trends.

The June 1985 UBPR includes several changes from the March 1985 edition:

- the Analysis of Repricing Opportunities pages (formerly pages 10, 10A and 10P) have been reorganized into new pages 10 and 10A.
- the Capital Analysis page (UBPR page 12) now incorporates revised agency definitions of primary capital. Revised figures using the new primary capital formulations appear on this page and on UBPR Pages 01, 11 and 13.

- Analysis of Past Due, Nonaccrual & Renegotiated Loans & Leases page (UBPR Page 8A): The version distributed to small banks (034 reporters) will now consist of the version previously distributed to medium banks (033 reporters), to reflect expanded reporting by small banks. For both small and medium banks, this version now incorporates detail on nonperforming agricultural loans.
- the Commitments and Contingencies page (UBPR Page 6A) now incorporates dollar amounts and percent of assets of interest rate swaps.

These new and changed UBPR pages are documented in a User's Guide revision. All recipients of June 1985 UBPR reports and new recipients of UBPR User's Guides will receive a copy of the User's Guide revision.

Copies of individual bank UBPRs may be obtained by the public for \$25 per report, with quantity discounts available. UBPR User's Guides can be obtained for \$6.00 each. June 1985 Peer Groups Reports and State Average Reports are also available for \$25 per copy. Detailed instructions for ordering UBPRs and ancillary reports are attached.
