The June 1986 Uniform Bank Performance Report (UBPR) is now being distributed to all insured commercial banks and is available for sale to the public.

The June 1986 UBPR includes changes in the following areas:

- Analysis of Past-Due, Nonaccrual and Restructured Loans and Leases.

  The analysis covers "non-current" loans and leases, which includes those past due 90 days or more and those in nonaccrual status. Formerly, this analysis covered "non-performing" loans and leases, which also included those in renegotiated status. The new analysis also covers restructured debt in compliance with modified terms, apart from "non-current" debt. This affects UBPR pages 8A, 01 and 13.
- Deposit Presentations. To reflect the deregulation of deposit interest rate ceilings as of April 1, 1986, distinctions between "regulated" and "unregulated" deposits have been removed. Also, deposit presentations have been modified to conform to revised categorizations of deposits in Call Report instructions. This affects UBPR Pages 6, 7, 9, 10 and 11.

Presentation of New Call Report Items. "Real Estate Acquired for Investment Purposes" (state-chartered nonmember banks only) and "Total Current Restructured Debt" are presented on UBPR Page 05. "Special Category Net Charge-Offs" (national banks only) is presented on UBPR Page 12.

These UBPR changes have been documented in a revision to the UBPR User's Guide. This User's Guide revision will be distributed with June 1986 UBPR's.

The quarterly UBPR is designed for use by bank examiners, financial analysts and bank managers, and permits both summary and in-depth analysis of a commercial bank's financial performance and trends.

All copies of individual bank UBPR's may be obtained by the public for \$30 per report. UBPR User's Guides may be obtained for \$15 each. June 1986 and prior State Average Reports are available for \$30 per copy, and Peer Group Reports are \$50 per copy.
