**Announcement of changes in the official staff of the Federal Reserve  
Bank of Dallas**

**DETAILS**

It is a pleasure to announce that the Board of Directors of the Federal Reserve Bank of Dallas has taken the following actions with regard to the official staff of the Bank, effective January 1, 1987:

Promotions:

Robert Smith, III, currently Vice President in the Corporate Banking Department and Secretary of the Board of Directors, has been promoted to Senior Vice President and Secretary. Mr. Smith will move to Houston in mid-1987 to assume responsibilities as Officer in Charge of the Houston Branch, where he will replace Senior Vice President J. Z. Rowe, who has announced his intention to retire around mid-year.

James L. Stull, currently Vice President over the Dallas Branch, has been promoted to Senior Vice President. He will have senior responsibility for the Corporate Services Division, which will include the following departments: Financial Planning and Control; Human Resources; Operations Analysis; Protection; Purchasing; and Services.

Sammie C. Clay, currently Assistant Vice President at the Houston Branch, has been promoted to Vice President in Charge of the El Paso Branch. He will replace Joel L. Koonce, Jr., who is being transferred to the Head Office.

New Officer:

Rene G. Gonzales, currently Manager of Payments Mechanism at the San Antonio Branch, has been promoted to Assistant Vice President at the Houston Branch, with supervision of the Accounting, Loan, Personnel, Facilities, and Protection Departments.

Assignment Changes:

Neil B. Ryan has been designated Senior Vice President and Senior Advisor. He has announced his intention to retire effective March 31, 1987.

J. K. Mast, currently Senior Vice President of the Automation Program Office, will have senior supervision of the new Information Services Division, which will include the Data Services Department and the Automation Program Office.

Tony J. Salvaggio, Senior Vice President, will continue to have senior supervision of the Financial Services Division, which includes the Corporate Banking Department and the Dallas, El Paso, Houston, and San Antonio Branches.

Joel L. Koonce, Jr., currently Vice President in Charge of the El Paso Branch, will assume general supervision of the Cash Department and Securities and Fiscal Services Department at the Head Office. Additionally, he will assume general supervision of the Corporate Banking Department at the time of Mr. Smith's departure for Houston.

The current Payments Mechanism Department will be divided into two departments -- Electronic Payments and Check Collection. Vice President Lyne H. Carter will assume general supervision for the Electronic Payments Department, along with the Management Systems Group. Vice President Jack A. Clymer will have general supervision of the Check Collection Department.

Millard E. Sweatt, Jr., currently Vice President and General Counsel, will assume the additional responsibility of Assistant Secretary of the Board of Directors and will succeed Mr. Smith as Secretary of the Board at mid-year.


