SUBJECT

Fee and availability schedule for commercial check and return check services

DETAILS

Effective September 1, 1988, new check collection and return check service fees and availability schedules will be implemented at all Federal Reserve Banks. It is anticipated these prices will remain unchanged through 1989. These changes are in response to new services being introduced in conjunction with Regulation CC which implements the Expedited Funds Availability Act.

To help expedite the return of unpaid checks, Federal Reserve Banks will implement later deadlines for unqualified returns and new qualified return check deadlines that mirror normal forward check collection deadlines. The Federal Reserve will now accept checks for return that were not originally presented for payment through the Federal Reserve System. There also will be a same-day notification service for large-dollar returns.

For financial institutions in the Eleventh District, raw return check fees will increase, but fees for qualified returns will decrease significantly. Federal and fine sort check fees will be lower at all offices in this district.

Information about deposit deadlines, availability and prices for check collection and return services offered to local depositors at each of the four Eleventh District offices is provided in the enclosure. Deposit deadline and price schedules for interterritory check collection and return services offered by other Federal Reserve Banks are available upon request.
