SUBJECT

1988 revised fee schedule for financial services

DETAILS

Enclosed is the newly revised 1988 fee schedule for the Federal Reserve Bank of Dallas and its Branch offices. The schedule includes the new check collection and return check service fees established in conjunction with the Expedited Funds Availability Act and Regulation CC. These fees become effective September 1, 1988, as announced in our Circular 88-42, dated July 1, 1988.

The fee schedule also includes new accounting services fees currently in effect. Announced in our Circular 88-25, dated April 1, 1988, many of the accounting services fees are now based on a monthly fee with single item fees charged only for special orders. These monthly charges reduce the work associated with tracking charges on a per item basis, and in some cases, result in a cost reduction to the financial institution using these services.

The revised fee schedule covers the following services: advices, transfer of funds, net settlement, check processing, federal agency book-entry securities, definitive safekeeping, noncash collection, currency and coin, automated clearinghouse, electronic access, payor bank, and accounting services.

*Deposited via the CATIE or dedicated terminal methods, returns are assessed a flat per-item fee of \$1.25. No other basic fees or surcharges apply. (NOCs cannot be handled using these methods at present).

*Deposited in paper form, each return and NOC is assessed a \$3.75 handling fee in addition to all fees that would apply if the item were deposited electronically.

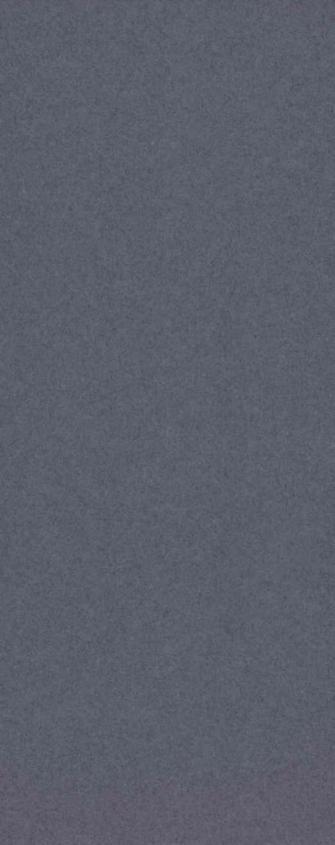
