DETAILS

The Federal Financial Institutions Examination Council (FFIEC) has announced that the June 1989 UBPR is ready for distribution and sale to the public. The FFIEC is again making available computer tapes of UBPR data for the June 1989 edition. The use of quarterly UBPR permits both summary and in-depth analysis of a commercial bank's financial performance and trends.

The June 1989 Uniform Bank Performance Report (UBPR) is now being distributed to all insured commercial banks and is available for sale to the public.

The quarterly UBPR is designed for use by bank examiners, financial analysts and bank managers, and permits both summary and in-depth analysis of a commercial bank's financial performance and trends.

The FFIEC is again making available computer tapes of UBPR data for the June, 1989 UBPR edition. These tapes contain bulk data for banks, peer groups or states, and are expected to be of interest to requestors who make use of large-scale bank data such as quarterly Call Report tapes.

All copies of individual bank UBPR's may be obtained by the public for \$30 per report. UBPR User's Guides may be obtained for \$15 each. State Average Reports are available for \$30 per copy, and Peer Group Reports are \$50 per copy. UBPR data tapes and associated documentation are \$400 for each of several tapes.

Instructions for ordering UBPR's and ancillary reports are attached.
