Statement of Detail Service Charges

DETAILS

The Federal Reserve Bank of Dallas currently provides Eleventh District financial institutions a weekly Statement of Detail Service Charges that lists detailed information concerning all charges incurred for Federal Reserve services. With the implementation of our new billing system, the detail statements will no longer be available each week. Beginning with the October billing cycle, the Statement of Detail Service Charges will be produced on a monthly basis presenting the same level of detailed information each month.

However, it has been brought to our attention that some financial institutions have no interest in receiving the Statement of Detailed Service Charges. Since the new billing system allows us the option of not producing these detail statements, please complete the attached form indicating whether or not your organization wishes to continue receiving the Statement of Detailed Service Charges. The form should be returned to the Dallas Fed by September 30, 1992.

Your response will not affect the production and delivery of your other monthly summary statements.


