#### **SUBJECT**

#### New Dallas RCPC Premium Group Sorts

#### **DETAILS**

Effective November 21, 1994, the Federal Reserve Bank of Dallas will offer new RCPC Premium Group Sort deposit options at the Dallas Office. The Fed will provide immediate availability for Group Sort cash letters that contain items drawn on specified RCPC financial institutions and that are deposited by 7:30 a.m. Central time.

The new RCPC Premium Group Sort deposit option offers a much later deposit deadline, with immediate availability, which provides depositors the ability to extend processing windows and to take advantage of alternative transportation arrangements to the Fed. The two new Premium Group Sorts contain 50 endpoints at present. These are the same endpoints contained in our regular RCPC Group Sorts #4 and #5 with a 4:00 a.m. deposit deadline. Unless specifically marked "Non-Premium," RCPC Group Sort #4 or #5 received after the 4:00 a.m. deadline but prior to the 7:30 a.m. deadline will be credited and charged the premium price.

Cash letter fees for the new RCPC Premium Group Sort deposit option will be \$1.75 for all in-district depositors. The per-item fee will be \$0.05.
