**DETAILS**

Effective March 1, 1995, the price for a set of Regulations and Operating Circulars binders will increase from \$30.00 to \$40.00. The price for an Operating Circulars binder will remain at \$15.00. Regulations are now divided into two binders—Volume 1 and Volume 2. The price for the two-volume set of Regulations binders is \$25.00.
