SUBJECT

Implementation of the Electronic Federal Tax Payment System (EFTPS)

DETAILS

We are pleased to announce the implementation of EFTPS on October 28, 1996. Effective this date, electronic tax payments will be accepted for processing by the EFTPS utilizing the Automated Clearing House (ACH) credit or debit options as the primary methods of payment. As you are aware, prenotifications are required for both payment options. Your institution may receive a debit prenote from one of the Treasury Financial Agents on behalf of your corporate taxpayer as early as October 21, 1996. If you are offering the ACH credit payment option, please remember to submit a zero-dollar entry 10 days prior to actual payment transactions for your corporate taxpayer. **Please note that prior to originating a zero-dollar entry, your customer must receive their enrollment confirmation package from EFTPS, which will be distributed beginning Oct 28.**

For your information and review, the proposed regulations that govern Treasury Tax and Loan depositaries and the payment of Federal Taxes via EFTPS were published for comment in the *Federal Register* September 30, 1996. As you may be aware, a provision has been included in the Small Business Job Protection Act that has delayed the requirement for the 1.2 million taxpayers to pay their taxes electronically from January 1, 1997, to July 1, 1997. However, taxpayers are still encouraged to enroll early in EFTPS and begin paying their taxes electronically as soon as they receive their enrollment confirmation package. Over the next six weeks, you will be receiving the following information under separate cover:
