The *Reserve Maintenance Manual* outlines the fundamental rules of reserve calculation and account maintenance for institutions that file the *Report of Transaction Accounts, Other Deposits and Vault Cash* (FR 2900), either weekly or quarterly. This manual was completely revised in 1998 to reflect the adoption of a single master account structure and the return to lagged reserve maintenance for weekly FR 2900 reporters.

In the future, the manual will be maintained and revised exclusively in electronic format. The web site also contains a separate document composed solely of pages revised as of January 1999, which you may print and substitute for the corresponding pages in the previous printed version of the manual.

The new *Account Management Guide* was first published in 1998 and is designed as a practical reference to make it easier for financial institutions to manage reserve accounts. The guide assumes a familiarity with accounting practices and provides a detailed discussion of each major aspect of reserve account management, together with descriptions and samples of the reports and other information tools available from the Federal Reserve System. Like the *Reserve Maintenance Manual*, the *Account Management Guide* will be maintained and revised exclusively in electronic form.
