Highlights of this Issue

- Most Western states held their own in civilian employment during the summer months following the trend set in the U.S. as a whole. As a result of the increased employment, unemployment rates moved downward in most states (B-2,3). . . The employment gains in the Twelfth District in August were in the construction, trade, services and government sectors (B-4).
- Total construction was up sharply in the Twelfth District in August with sharpest increases in the non-residential sector (D-2). . . . Housing starts in the West continued to rise at a steady pace (D-4).

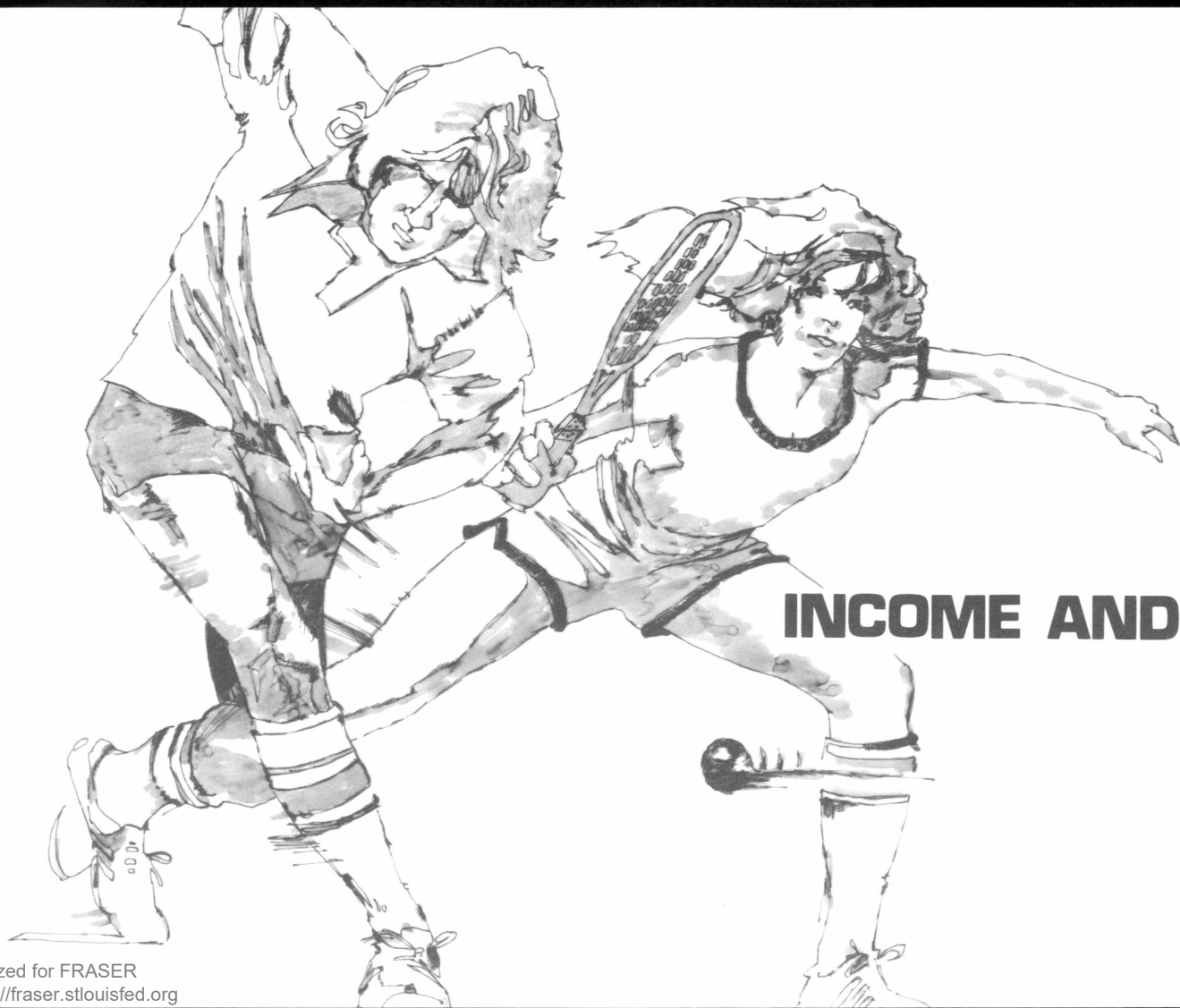
Note to Readers

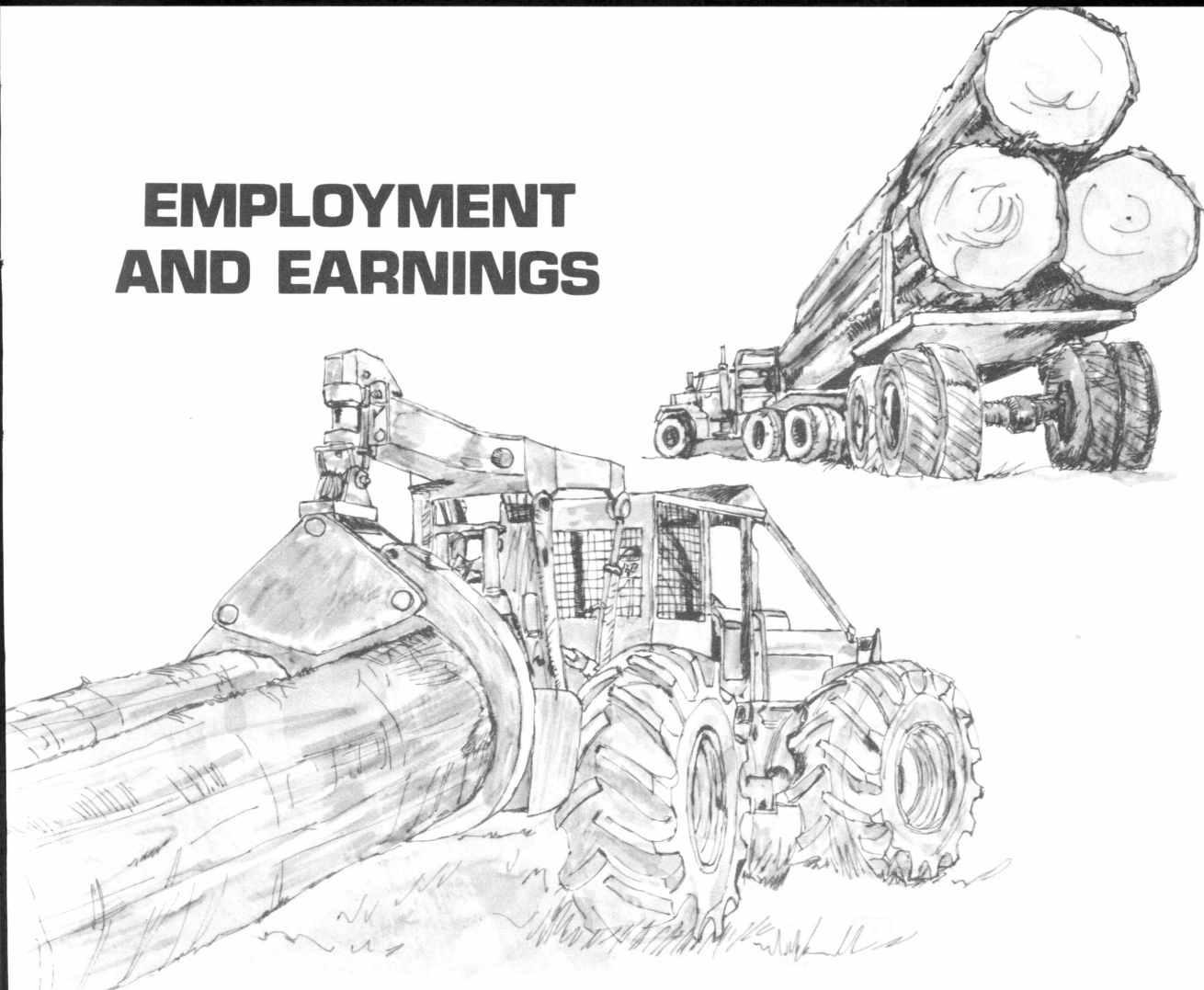

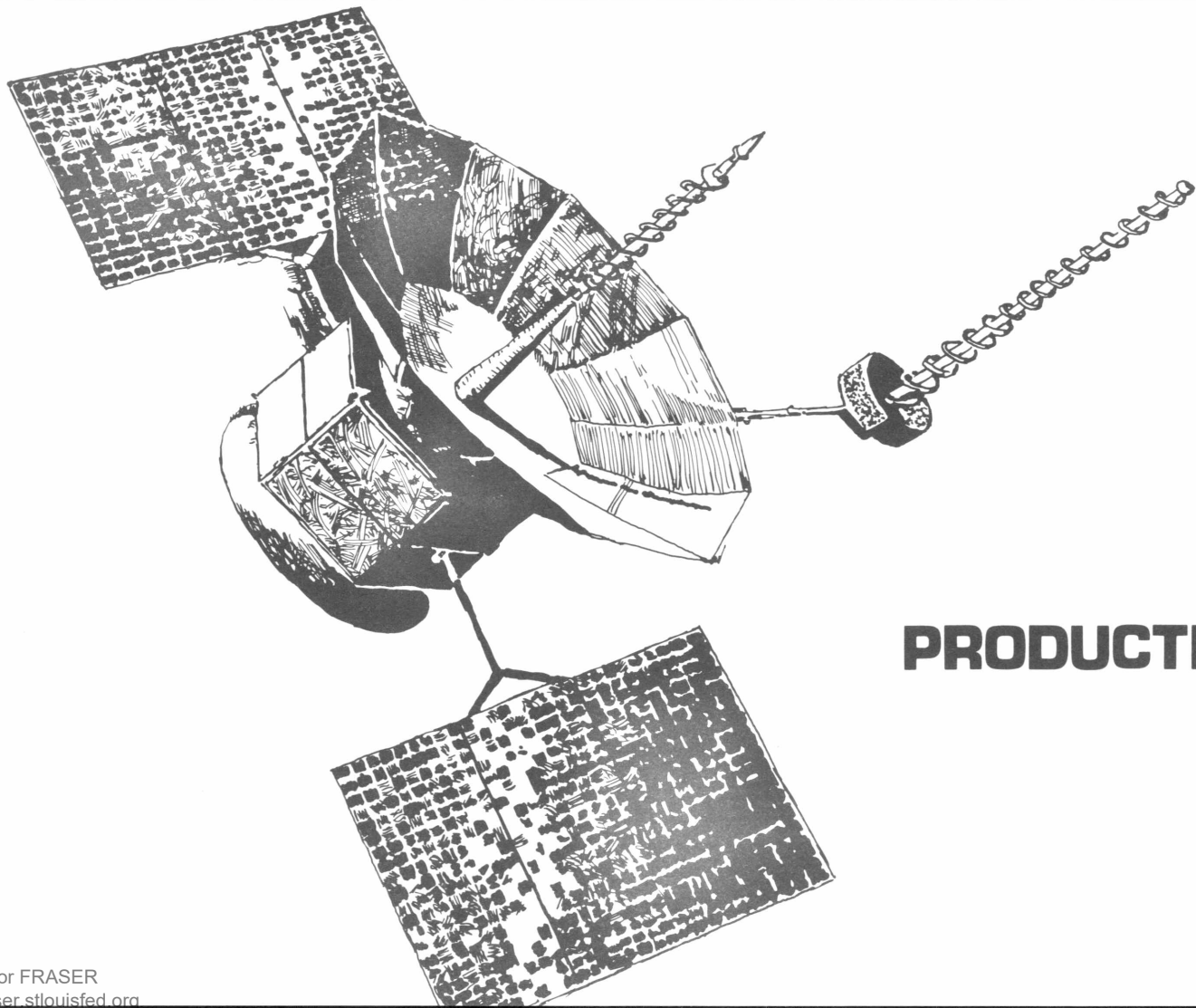

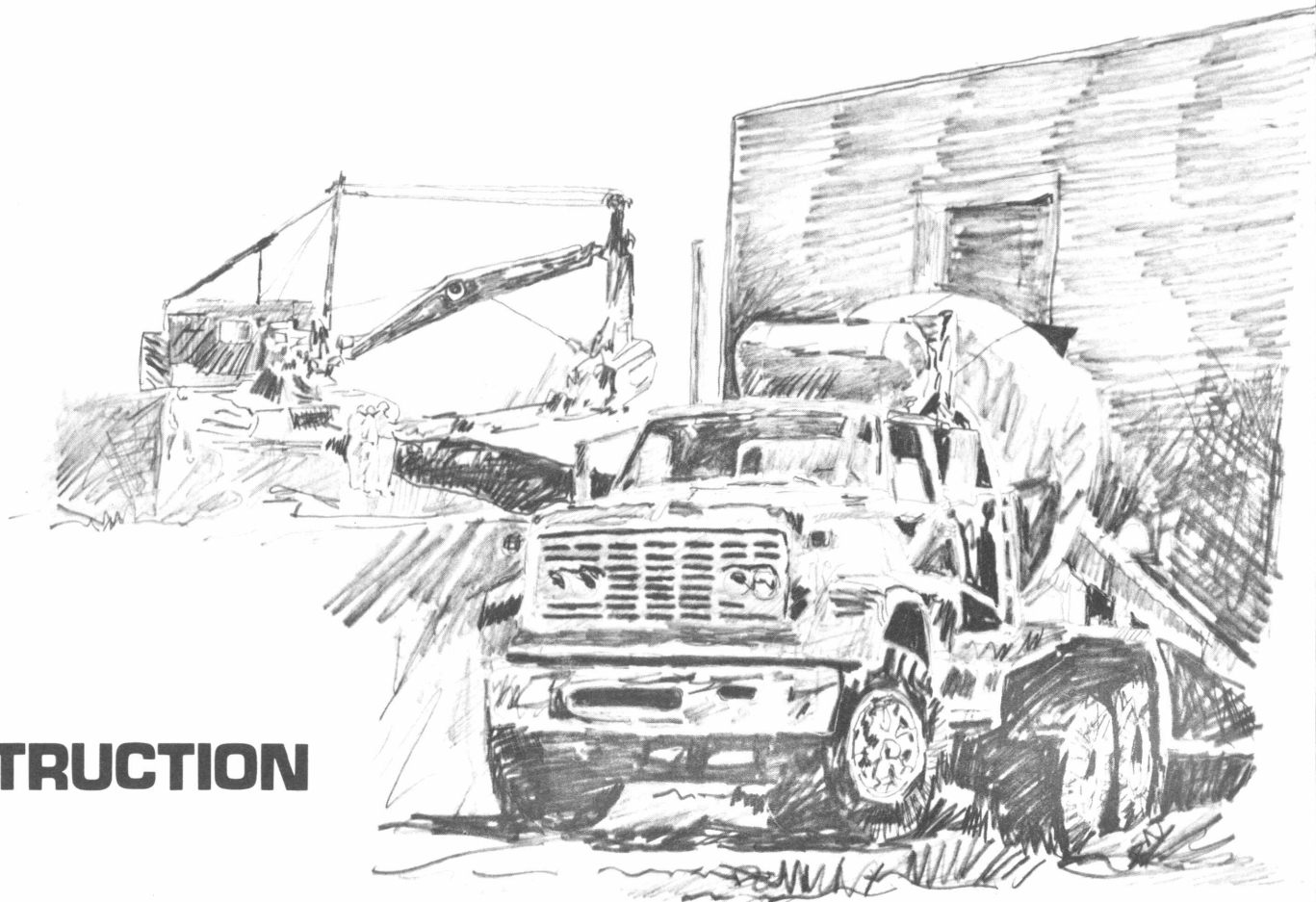

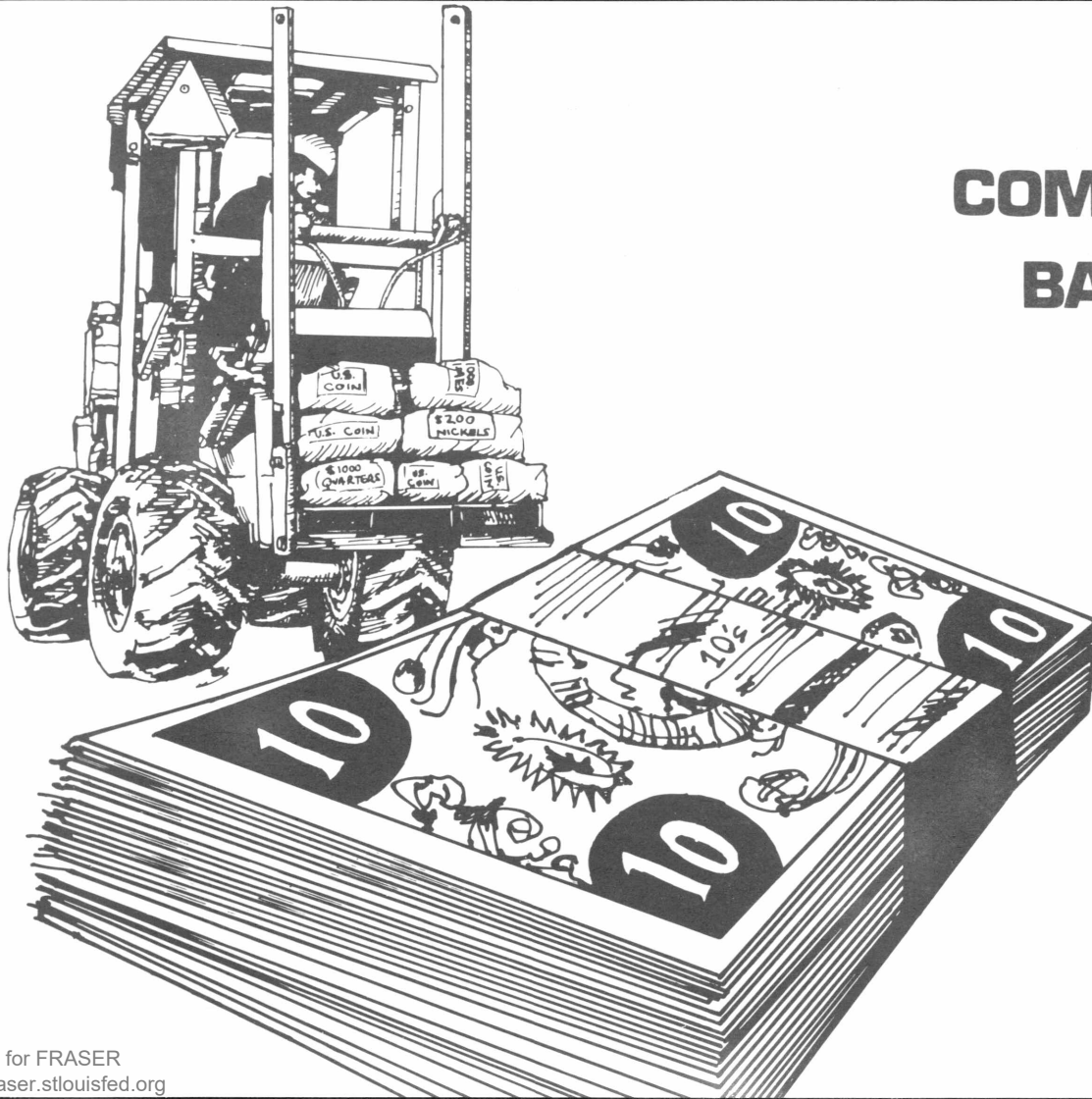
