The election of directors of the Federal Reserve Bank of St. Louis to succeed Mr. Bradford Brett, Class A director, and Mr. Mark Townsend, Class B director, whose terms end December 31, 1970, has been duly held in accordance with the requirements of Section 4 of the Federal Reserve Act and the provisions of the circular issued by this office under date of September 18, 1970.

Mr. Bradford Brett, President, The First National Bank of Mexico, Mexico, Missouri, was reelected by member banks in Group 3 as a Class A director.

Mr. Fred I. Brown, Jr., President, Arkansas Foundry Company, Little Rock, Arkansas, was elected by member banks in Group 2 as a Class B director.

Each director was chosen for a term of three years to begin January 1, 1971.
