RESULTS OF ELECTION

To the Member Banks of the
Eighth Federal Reserve District:

The election of directors of the Federal Reserve Bank of St. Louis to succeed Mr. Wm. E. Weigel, Class A director, and Mr. Tom K. Smith, Jr., Class B director, whose terms end December 31, 1975, has been duly held in accordance with the requirements of Section 4 of the Federal Reserve Act and the provisions of the circular issued by this office under date of September 12, 1975.

The results of the election are as follows:

Mr. Wm. E. Weigel, Executive Vice President and Chief Executive Officer, First National Bank and Trust Company, Centralia, Illinois, was reelected by member banks in Group 2 as a Class A director.

Mr. Tom K. Smith, Jr., Group Vice President, Monsanto Company, St. Louis, Missouri, was reelected by member banks in Group 1 as a Class B director.

Each director was chosen for a term of three years to begin January 1, 1976.

Wm. E. Weigel, Director, Executive Vice President and Chief Executive Officer, First National Bank and Trust Company, Centralia, Illinois, was reelected by member banks in Group 2 as a Class A director of the Federal Reserve Bank of St. Louis for a three-year term beginning January 1, 1976.

A native of Hoyleton, Illinois, Mr. Weigel has been a director of this bank since January 1, 1973. In addition to being affiliated with numerous civic organizations, Mr. Weigel is Director and Secretary of Centralia Industries, Inc.; Trustee, Centralia Foundation; and Director, Hoyleton State and Savings Bank, Hoyleton, Illinois, Ashley State Bank, Ashley, Illinois, and Friendship Shelter Care Homes, Inc.

Tom K. Smith, Jr., Group Vice President, Monsanto Company, St. Louis, Missouri, was reelected by member banks in Group 1 as a Class B director of the Federal Reserve Bank of St. Louis for a three-year term beginning January 1, 1976.

Born in St. Louis, Missouri, Mr. Smith has been a director of this bank since November 1974. Active in various state and local civic organizations, Mr. Smith also is Managing Director of Monsanto Commercial Products Company, an operating unit of Monsanto Company, and a Member of the Board of Directors and Corporate Administrative Committee of Monsanto Company.

The Board of Directors of the Federal Reserve Bank consists of nine members, six of whom (Classes A and B) are chosen by the member banks and three (Class C) by the Board of Governors in Washington.
