REPORT OF NOMINATIONS — VOTING PROCEDURES

May 4, 1983

To the Member Banks of the Eighth Federal Reserve District:

In accordance with the provisions of Section 4 of the Federal Reserve Act and my circular dated April 4, 1983, in regard to the election of a Class B director of this bank to succeed Mary P. Holt who was appointed by the Board of Governors as a Class C director and designated Deputy Chairman of the Board of this bank, there are given herein the name of the candidate nominated for such Class B director and a listing of the banks which made the nominations. The elected director will serve for a term ending December 31, 1985.

There is sent herewith to each bank in Group 2 a ballot for use in voting for a Class B director. An envelope bearing on its face the certificate in regard to the vote and a colored envelope marked "Ballot" in which the ballot is to be sealed also are enclosed.

The ballot and certificate on the envelope must be executed by an officer who has been authorized to cast the vote. A list of the designated officers, revised to date, forms a part of this circular. In order that the balloting may be secret, the name of the bank and of the voting officer should not be written on the ballot but only on the certificate envelope.

The following procedure is required:

- (1) The ballot should be marked.
- (2) It should be placed in the colored envelope marked "Ballot" and the envelope sealed.
- (3) Then after the certificate on the certificate envelope is executed, the sealed ballot envelope should be placed within the certificate envelope and the latter sealed.
- (4) The certificate envelope containing the sealed ballot envelope should be returned in the enclosed self-addressed envelope.

Under the law, the ballot must be returned so as to reach me within fifteen days after its receipt. The polls will open on May 9 and close at 2 p.m. on May 24, 1983. At that time the ballot box will be opened in the Board Room of this bank, the sealed envelopes containing the ballots will be opened, the votes counted, and the results of the election announced.

While the banks in Groups 1 and 3 will not vote in this election, this circular is sent to them, without forms, for their information.
