P R E F A C E

This Inventory of Government-wide Financial Reports on the Federal Government provides an annotated listing of all published financial reports of a Government-wide nature issued by the Treasury Department, Bureau of the Budget, and other Federal agencies. It does not include reports covering operations of a single agency, but only those prepared from the central accounts and records of the Treasury covering the financial operations of the Government as a whole and those prepared from reports issued or financial data supplied by two or more agencies on particular programs or activities of the Federal Government.

The reports included in this inventory are printed or processed documents and are available to the public from the U. S. Government Printing Office or the issuing agency. Most are periodic publications, with a few special compilations of historical data related to certain current publications. The table of contents lists each report by its short title, grouped by issuing agency and identified by a three-digit reference number. This number is used in referring to the reports in the index and in cross-references in the body of this inventory.

Each of the reports is described in the body of the inventory. A brief description of the publication as a whole is given under the heading "General content." Each financial statement, table, or group of tables within the publication is identified for reference purpose by a decimal suffix and described by indicating the data contained in the statement or table(s), the basis on which the data is classified, and the period covered. If the report is a monthly or quarterly publication, the data which is published regularly in each issue is described, as well as any additional data published less frequently. The source of the data is indicated where this information might be of assistance in using the data or in seeking other or more detailed data on the subject.

The appendix contains a list of the reports described in the inventory, in bibliographic style, indicating whether it may be obtained from the U. S. Government Printing Office or the issuing agency, the price (if any), and the date or frequency of its issuance.

An index is provided to assist the user in identifying a report or reports which contain data on particular subjects, i.e., types of financial data or broad functional programs.

This inventory was prepared as a staff paper for use in the Government-wide Financial Reporting Project under the Joint Financial Management Improvement Program. It was prepared by the joint project team under the direction of the Steering Committee for the Joint Program.

General content: A report to Congress on the operations of the Treasury Department and on the financial activities of the Government as a whole. Contains summary and detailed, current and historical data on receipts and expenditures; public debt; stock and circulation of money; gold and currency transactions; assets, liabilities, and operations of trust funds and business enterprises; and other Federal financial data. The report is arranged in four parts as follows:

Review of Fiscal Operations

- 101.01 This part contains summary narrative material, with 6 charts and 24 text tables, on the overall financial operations of the Government, comprising sections on budget receipts and expenditures (pp. 5-16); trust account and other transactions (pp. 16-18); account of the Treasurer of the United States (pp. 18-19); public debt operations and ownership of Federal securities (pp. 19-36); corporations and certain other business-type activities of the United States Government (pp. 36-40); securities owned by the United States Government (p. 40); taxation developments (pp. 40-49); and international financial and monetary developments (pp. 49-66).

Administrative Reports

- 101.02 This part contains narrative material and text tables covering the fiscal year activities and operations of each bureau and office of the Treasury Department, including the Bureau of Accounts and its central accounting and reporting activities.

Exhibits

General content: Official annual combined statement of the Federal Government, to the Congress, on receipts and expenditures and the balances of appropriation and fund accounts. Contains descriptive and explanatory text material and summary and detailed statements on receipts, appropriations, expenditures, and balances and the Treasury's cash operations; informational tables pertaining to the financial condition and operations of the Government as a whole or of particular segments or programs of the Government; and summary data on foreign currencies acquired by the Government without payment of dollars.

Fiscal Year 1959 Summaries

This part consists of 14 tables of summary data for the fiscal year 1959, as follows:

103. Monthly Statement of Receipts and Expenditures of the United States Government. Washington: U. S. Government Printing Office, 16 pages. \$6.00 per year, including the Daily Statement of the United States Treasury (see item 105). Issued monthly since March 1954.

General content: Official monthly report on receipts and expenditures, the public debt, and the status of the budget. The June report each year contains preliminary figures for June and the fiscal year; revised figures for June and the fiscal year are published in November in a Final Statement of Receipts and Expenditures of the United States Government. The monthly and final statements contain the following data, on a cash basis:

- 103.01 Summary (Table I). Totals for the current fiscal year to date on budget receipts, budget expenditures, budget surplus or deficit, public debt outstanding, and balance in the Treasurer's account, with annual totals for the three preceding fiscal years and estimates for the current and coming fiscal years.
- 103.02 Budget Summary (Table II). Summary data for the current fiscal year to date on budget receipts by major source, budget expenditures by agency, and the budget surplus or deficit, with related budget estimates for the full fiscal year.
