A letter from R. C. Biggs asking \$1,500 gold per month to Caracas for salary payments at that point; read and referred to State Department.

1140. Kountze Brothers, New York to Compania

Fundidora y Afinadora, "Monterrey", Mexico. \$100,000 gold coin, shipment to be made via Milmo National Bank, Laredo, Texas. Granted.

1141. Chase National Bank, New York to Royal Bank of Canada, Havena, Cuba, \$100,000 in currency.

Granted.

1142. Milmo National Bank, Laredo, Texas, to Compania Fundidora y Afinidora "Monterrey" Monterrey, Mexico, during February, March and April, a total of \$60,000 (\$20,000 to be shipped each month) in U. S. currency not gold certificates. Granted to end of March (40,000).

1143. W. C. Laughlin Company, of New York, via Nogales, Arizona, to same, Mexico (San Javier), during March, \$11,000 in United States gold coin or its equivalent in Mexican. Granted.

1144. Anglo & London Paris National Bank, San Francisco, to Bank of Taiwan, Shanghai, China, about \$190,000 in silver bullion. Granted.

1145. Francisco Echeguren y Cia, Sucesores, from San Francisco, via Nogales, to same, Mazatlan, Mexico, Mexican gold or silver coin, \$10,000, for account of Negociacion Minera de Guadalupe de los Reyes.

Cranted, \$10,000 in silver.

A letter of the Secretary of State transmitting
Havana newspapers containing notices of the gold embargo
was submitted for information.

1146. Riggs National Bank, \$100,000 currency (no gold certificates) to National Bank of Havana, Cuba, approved. Application filed only by Mr. Kent. (No papers received.)
