1669. Mexico Northwestern Ry. Co., El Paso, to same, Juarez, Mexico, \$8,000 gold and \$2,500 paper currency except gold certificates. Granted.

1670. Echavarria, Laredo, to Mexico, \$25,000 paper and silver. Granted.

1671. John Finnigan Company, Brownsville, Texas, to G. B. Murphy, Matamoras, Mexico, \$1,000 gold coin. Declined.

1672. U. S. Treasury, Philadelphia, to Mint Master, Bombay, \$1,975,622.74 silver bullion. (Likely a duplicate of #1655). Granted - no new license needed.

1673. Hannevig & Co., New York to Den Norske Handelsbank, Christiana, Norway, \$15,000 to \$25,000 United States bank notes. Declined.

1674. Royal Bank of Canada, New York, to same, Montreal, Canada, \$4,145 gold coin. Granted.

1675. Chase National Bank, New York to Royal Bank of Canada, San Pedro de Macoris R. D., \$50,000 paper currency. Granted.

1676. Handy & Harman, New York to Bank of British North America, Ottawa, Canada, \$4,865 gold coin. Declined.
