Telegram to Mr. Stewart, Secretary of the Federal Reserve Bank of St. Louis, stating that the Board approves the establishment without change by the bank today of the rates of discount and purchase in its existing schedule.

Approved unanimously.

Memorandum dated November 15, 1937, from Mr. Smead, Chief of the Division of Bank Operations, submitting a letter dated November 9 from Mr. Taylor, Cashier of the Federal Reserve Bank of Cleveland, Which requested approval by the Board of a change in the personnel classification plan of the bank to provide for a change in the name of the Statistical Department to Business Statistics Department; for a change of the title of "Head" of the department to "Manager"; and for a minor change in the description of work for this position.

Approved unanimously.

Memorandum dated November 10, 1937, from Mr. Smead, Chief of the Division of Bank Operations, submitting a letter dated November 5 from Mr. Schaller, President of the Federal Reserve Bank of Chicago, which requested approval by the Board of changes in the personnel classification plan of the bank to provide for increases in the maximum salaries for the positions of "Chief Exeminer" and "Assistant Exeminer", in the Bank Examination Department. The memorandum stated that the proposed changes had been reviewed and recommended that they be approved.

Approved unanimously.

Letter to Mr. Peyton, President of the Federal Reserve Bank of Minneapolis, reading as follows:

"Reference is made to your letter of November 4 stating that it appears desirable to you to suggest to your directors at their next meeting that Mr. Thomas H. Hodgson be appointed Assistant Counsel for the bank and inquiring whether such a move on your part would conflict with the Board's objectives.

"The Board appreciates your desire to cooperate with it by bringing this proposed action to its attention. If, as your letter indicates, it is your judgment that it is in the interest of efficiency of the institution to take such action at this time, the Board offers no objection. The report of the survey to which you refer has been filed with the Board but it has not yet given it consideration for the reason that the surveys of the legal divisions of the other banks have not been completed and the Board desires to canvass the situation as a whole before reaching any conclusions. Therefore, I am not in a position at this time to advise you as to what might be the Board's future."

Approved unanimously.

Letter to the board of directors of "The Citizens' State Bank of Choteau, Montana", Choteau, Montana, stating that, subject to the conditions of membership numbered 1 to 3 contained in the Board's Regulation H and the following special conditions, the Board approves the bank's application for membership in the Federal Reserve System and for the appropriate amount of stock in the Federal Reserve Bank of Minneapolis:

- "4. Such bank shall make adequate provision for depreciation in its banking house and furniture and fixtures.
- Prior to admission to membership such bank, if it has not already done so, shall charge off or otherwise eliminate estimated losses of \$1,181.04 in loans and discounts, as shown in the report of examination of such bank as of October 23, 1937, made by an examiner for the Federal Reserve Bank of Minneapolis."

Approved unanimously for transmission through the Federal Reserve Bank of Minneapolis.

Letter to Mr. Walter Lichtenstein, Secretary of the Federal Advisory Council, reading as follows:

"As we did at the last meeting, we shall take pleasure in making available to the Council when it meets here a private office and secretarial service.

"We hope that the Council will feel entirely comfortable in holding its meetings in our building."

Approved unanimously.
