

Minutes for July 8, 1966



Money market review. Mrs. Peskin reported on conditions in the Government securities market, and Mr. Axilrod reported on bank reserve utilization data. There followed a discussion of the reports, during which it was brought out that the Manager of the System Open Market Account planned to make certain proposals for dealing with excess float that might accrue due to the airline strike. Mr. Baker then reported on foreign exchange markets, and Mr. Keir concluded the review with comments on the situation of savings and loan and mutual savings institutions. Mrs. Peskin and Messrs. Axilrod and Keir included in their remarks references to distributed tables on the money and capital

markets perspective, on bank reserve utilization perspective, and on net savings flows at New York City's 15 largest mutual savings banks and at California State chartered savings and loan associations.

The meeting then adjourned.
