With reference Ilion Plant: they have several contracts with the Ordnance Department, the largest and most important of which is R 18-14063, an order for 868,460 M rifles. Their Ilion plant is one of three manufacturing this type of rifle. Up to date they have completed only 499,013. These rifles are badly needed and we are receiving urgent cabbes from General Pershing even to strip the training camps, This firm has also orders for spare parts which are being filled at their Ilion plant. These contracts are behind in delivery.

Rates of increase recommended by the Remington Arms SUBJECT: Union Metallic Cartridge Company. The Woman in Industry Service has carefully noted the recommendations of the Remington Arms Union Metallic Cartridge Company as follows. A. That at the Bridgeport works a general increase of six cents per hour be authorized for women employees heretofore earning 32¢ to 39¢ per hour inclusive, these increases to be effective as of May 1, 1918, supplementing the general wage increase at these two plants recently decided upon which put into effect a minimum wage of 32¢ per hour for women 18 years of age or over and 42¢ per hour for men 21 years of age or over, with also the general increase in hourly wage rates covering a range from 40¢ to 78¢ per hour, all of these increases being authorized to take effect on and after May 1, 1918. B. That at the Swanton works an increase of six cents per hour be given to women 18 years of age or over, heretofore earning between 25¢ per hour and 39¢ per hour inclusive, and an increase, of six cents per, hour be authorized to men 21 years of age or over, heretofore earning between 35¢ per hour and 39¢ per hour inclusive. C. That at the Remington Ilion works and U. M. C. Hoboken works an increase of six cents per hour be authorized for women 18 years of age or over, heretofore earning between 30¢ per hour and 39¢ per hour inclusive. II. - The Woman in Industry Service, after informal conference with the Acting Director of the Women's Branch of the Ordnance Department,
  - A. We believe that an award based on age classifications is not in accordance with the best policy, in that it places a premium upon the employment of young persons and does not recognize that the rates of pay should be determined for the job rather than for the age of the worker.
  - B. We assume that there are in these plants women under 18 and men under 21 who have not shared in the recent awards and who are undoubtedly the lowest paid workers in the plant. Their wages should be the concern of the government at this time.
  - C. Therefore it is recommended that the age classifications be omitted in the determination of wages; that the increases of six cents per hour according to the schedules presented be otherwise endorsed, namely, that at the U. W. C. Swanton works the women and girls earning between 25¢ per hour and 39¢ per hour inclusive be given an increase of six cents per hour; that the men and boys heretofore earning between 35¢ per hour and 39¢ per hour inclusive be given an increase of six cents per hour, and that all women and girls at the Remington Ilion works and U. M. C. Hoboken works hitherto earning between 30¢ per hour and 39¢ per hour inclusive be given increases of six cents per hour; and that the company be asked to file a statement of the numbers and occupations of workers in these plants now earning less than the minimum wage specified as hitherto prevailing for women and men of specified ages, as the basis for further consideration of the rates of the lowest paid workers. It is further recommended that to expedite the whole matter the Women's Branch of the Ordnance Department be asked to make an immediate joint inquiry with the Woman in Industry Service as to the rates for women at the Ilion, Hoboken and Swanton plants, and that conference be held by them with the National War Labor Board regarding the rates at Bridgeport.
