

This Buddhist society sought our advise as to whether their temple could be utilized for storage purposes and if financial assistance would be extended to them for the purpose of barring windows and doors during such time as the property would be used as a warehouse.

A representative of this office contacted the proper city authorities, including the Planning Commission for the purpose of determining the zoning of the property in relation to warehouse activity and also Captain Roberts of the Fire Department for the purpose of having him inspect the property to obtain clearance of that department for the necessary permit.

As a result of our efforts, the church was converted into a warehouse for personal effects of Japanese families and has been left in charge of the Caucasian minister who has been given quarters on the premises. We were unable to assist in the matter of obtaining funds to put proper bars on the windows and doors but understand that this was subsequently accomplished through the individual members.

This party was purchasing household furniture on the installment payment plan from Barker Brothers, a large home furnishing store in Los Angeles. The original cost was \$1,200 which had been reduced to \$550 by monthly payments of \$36.00. The Japanese desired to take the mattress and blankets and cooking utensils to the Assembly Center upon evacuation and agreed to return the rest of the merchandise.

Upon our advice, Barker Brothers was contacted for the purpose of obtaining an adjustment and we subsequently talked with a Mr. Ash of the Credit Department of that company who informed us that, while a loss was involved for the store, he was permitting the Japanese to take the articles desired, which apparently was satisfactory to both parties.

This family also was operating a cleaning establishment and owned a 1938 Pontiac Coupe on which \$200 had been borrowed, the remaining balance being \$80, payable at \$20 a month. We advised contact with the lien holder before removing the automobile as the family had intended and to attempt to dispose of the cleaning business. We obtained a listing of both the automobile and the cleaning business for the attention of our Property Department and subsequently received a letter from Mrs. Fujii after the family had been evacuated, informing us that the automobile and cleaning establishment had been disposed of to their entire satisfaction.
