The warehouse leased from the First National Bank of San Jose by the Federal Reserve Bank of San Francisco, at 250 South First Street in San Jose, for the storage of the Evacuees' personal and household property, was partly destroyed by fire yesterday at noon. Report of the fire was made to your office by telephone during the afternoon of May 21, 1942.

Later in the afternoon an inspection, together with the secretary of the First National Bank, Mr. Paul Rudolph, and Mr. F. L. Raineville, manager of the Rental Department of Clayton and Company, was made. We found the roof structure and the roofing of the building badly damaged and have estimated that it will take at least sixty days to reconstruct and repair this building in order that it may be in proper condition for storage.

As it is evident that the Federal Reserve Bank of San Francisco will be unable to use this warehouse, as previously contemplated, I have contacted the Pacific Gas and Electric Company, the San Jose Water Company, and the Telephone Company and have requested each of them to have their services discontinued immediately. The keys to the building have been turned back to the First National Bank.

It is evident that Mr. Lorigan does not wish to stand by his word, formerly given to Miss Noda, that she would be released from the agreement. I consider that he has taken undue advantage of her immature years and lack of business ability.

I have had conversations with both of the real estate agents, The Title Insurance Company, and Miss Noda, and I am unable to induce them to come to any settlement in this matter. In my opinion, I think that an inquiry into the motives and the good faith of these agents should be investigated and consider the assistance of the Foreign Funds Control Investigative Unit of the Treasury Department is required.

As requested we are submitting a list of properties for rent or lease which can or used to store personal property of evacuated aliens. The list follows.

1. The so-called Hennessey Warehouse located at 550-560 South First Street. This property has a frontage of 100 feet on First Street and a depth of 137.50 feet. It has concrete floors and high wide doors capable of receiving the largest loaded trucks. It was for years the headquarters of a large trucking concern. About half of this building has an upper floor so that there is about 20,000 square feet of space available for storage. This can be leased for the duration at \$200.00 per month.

2. The Bloomfield Warehouse located about 3 miles South of Gilroy on the Southern Pacific Railroad East of and near the Monterey Road (Highway 101). This building is strong and substantial and has been used for grain storage for years. Loading can be handled from the railroad spur or from a loading platform on the opposite side where trucks can load or unload. In addition the owner has a large acreage adjacent to and joining this property which could also be rented or leased. This warehouse is 40 feet by 257 (over 10,000 square feet) and the owners ask \$150.00 per month rent.



Mr. Kajloka former operated a wholesale and retail plant and seed firm in San Francisco under the name of Oriental Plants & Seed co. He reports that he was the exclusive agent in this section for a certain grower of strawberry plants in Utah. As such he took orders for strawberries and accepted a deposit on same. This deposit was forwarded to the grower, Woodrow Kasuga, Rte 1 Box 382, Sandy, Utah. Mr. Kajloka wrote to him about the first of march and advised him that the growers would not be able to accept the plants and asked him to refund the \$500.00 which he sent. As yet Mr. Kajloka has not heard from Kasuga nor recieved a check from him.

I checked one of the contracts that the Japanese signed and about the only provision in them is an agreement that lets the nursery out in event of any circumstance beyond their control. You undoubtedly have the original of one of the contracts their so you can go over same.

Mr. Kajloka says that he will be more than willing to refund the dpeosits if he is able to secure a refund from Kasuga.

AUTOMOBILE CLUBS AND ASSOCIATIONS

SUBJECT: JAPANESE EVACUEES

This Division is in receipt of information that if Japanese evacuees are unable to dispose of their motor vehicles by private sale they may turn them over to the Federal Reserve Bank. At the direction of the evacuee the Bank will either store the vehicles or sell them to the United States Army. Where the vehicles are stored the Bank will retain possession of the certificates and plates.

Where the vehicles are sold to the United States Army the Federal Reserve Bank will surrender to the nearest Branch Office of the Department the plates and certificates for cancellation only. The Bank will arrange for proper release endorsement on the Ownership Certificates. If a Japanese owner is not available they will endorse his name and countersign as agent. When accepting such for cancellation, since no transfer of registration is sought, the strict rules of endorsement need not be followed. Thus a "One and the Same Affidavit" or Power of Attorney to the Bank shall not be required.

Each office shall acknowledge receipt of plates and certificates by listing them on a Department letterhead with appropriate receipt statement and signature of receiving clerk. The receiving office shall retain a copy of the receipt, a copy shall be attached to the certificates covered by it and forwarded to Sacramento. The original copy shall be given to the Federal Reserve Bank. The receiving office shall retain the plates, making a "Turned in Plate Record" therefor, and indicating on the Registration Card the fact that the plates have been turned in. Since it is a surrender for cancellation purposes only no duplicate plate nor certificate need be applied for if lost.




