Principal property involved and scope of problem: Endo owned a store known as Endo's Cafe, 6 Soledad St., Salinas and he is selling that with fixtures and stock and good-will to Harry L. Noland for cash for \$1,250. The deal is being handled through the Monterey Co. Bank. The buyer agrees to take over his lighting contract with the Florescent Lighting Co. This deal seems to be all right and Noland and the seller appear to be satisfied.

Endo also has appointed Frank Hoddinott, Rt. 1, Box 1160 N., Salinas, near Prunedale, as his attorney in fact to represent him dealing with other properties.

This consists mainly of a lot on E. Market Street, unimproved, next to the Togo Laundry which property is clear and taxes paid. Endo is mentioned as a party to a deal with a lot of others with Mrs. Masu Y. Abe and Y. Yamashita, brother and sister and Frank Myers. This has not been settled yet. Endo's father is in custody but that does not appear to affect this situation. This boy has been in several times and I've discussed this proposed deal with his attorney over the phone but it has always been nebulous and I couldn't get the boy to give me the facts, although he kept promising to report if and when anything happened.

ACTION:

Advised this boy that this transaction seemed satisfactory, telephoned the bank and his attorney and found they were pleased, told him to put his money in the bank and leave it there and also to sell his car if he did not want to store it. There may be some trouble over transferring title of the car as the pink slip is in his father's name and it has been lost; we offered to help him with the Motor Vehicle Dept. We have copies of the transaction in his folder.


We have discussed this case with the Grand Lake Branch

## ALL MESSAGES TAKEN BY THIS COMPANY ARE SUBJECT TO THE FOLLOWING TERMS:

To guard against mistakes or delays, the sender of a message should order it repeated, and as transcribed back to the originating office for comparison. For this one-half the repeated message rate is charged in addition. Unless otherwise indicated on its face, this is an unrepeatable message and paid for as such, in consideration whereof it is agreed that the sender of the message waives the Company as follows:

1. The Company shall not be liable for mistakes or delays in the transmission or delivery, or for non-delivery, of any message received for transmission at the unrepeatable message rate beyond the sum of five hundred dollars, nor for mistakes or delays in the transmission or delivery, or for non-delivery, of any message received for transmission at the repeatable message rate beyond the sum of five thousand dollars, unless specially valued; nor in any case for delays arising from unavoidable interruption in the working of its lines.

2. In any event the Company shall not be liable for damages for mistakes or delays in the transmission or delivery, or for the non-delivery, of any message, whether caused by the negligence of its servants or otherwise, beyond the actual loss, not exceeding in any event the sum of five thousand dollars, at which amount the sender of each message represents that the message is valued, unless a greater value is stated in writing by the sender thereof at the time the message is tendered for transmission, and unless the repeated-message rate is paid or agreed to be paid, and an additional charge equal to one-tenth of one per cent of the amount by which such valuation shall exceed five thousand dollars.

3. The Company is hereby made the agent of the sender, without liability, to forward this message over the lines of any other company, when necessary to reach its destination.

4. Dear Sir:

Under date of August 5, the Commission received a letter from the Federal Reserve Bank of San Francisco through its Stockton representative, Mr. L. S. Weeks, in which he advised that you desired to have your highway common carrier certificate suspended. Your attorney, Mr. Walter Tsukamoto, is being communicated with under separate cover with respect to obtaining the suspension authority sought.

In regard to your report of gross operating revenue for the 2nd quarter of 1942, the Commission understands from Mr. Weeks' letter that you are not at the present time in a position to file this report. You have until August 15, 1942, to file this 2nd quarter report before being subject to the 25% penalty (minimum \$1).

This penalty will be assessed if the report is not received on or before August 15 unless for good cause and upon request a further extension of time be granted for filing.

In the event that the Commission authorizes suspension of your certificate you will still be required to file quarterly reports during the suspension period and pay thereon the minimum \$1 fee each quarter required by statute to be paid by carriers holding valid certificates, permits or other valid operating authority during the life of said authority.



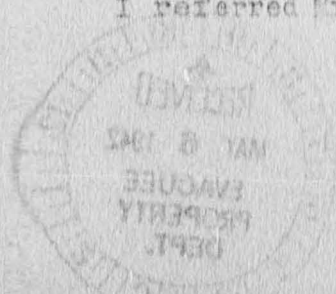
