Your letter to the Federal Reserve Bank of San Francisco. pertaining to automobiles grivately stored by evacuated Japanese, has been directed to this office for reply.

The inventorying and possible acquisition of sutomobiles and trucks privately stored by the Japanese before their evacuation has been the subject of some thought by the Rartime Civil Control Administration. As you know, the Federal Government has not yet fixed upon a policy for the acquisition of privately owned automobiles, but it is anticipated that steps may be taken in that direction at an early date. Your letter indicates that you have mode some effort to ascertain pertiment information concerning such automobile and truck storage " * " * but so far have been unable to locate any".

On the assumption that your office may have access to motor vehicle records not readily available to other agencies we should like to know whether you have been able to obtain any further information concerning the number, kind, location, ownership, and condition of storage of such vehicles. If your office does not have such records nor access thereto, could you suggest where such records might be available? This office has already contacted the Motor Vehicle Board and the Board of Insurance Underwriters but we were not able to obtain any very specific information from these sources.

MEMORANDUM TO: Mr. H. Armstrong

SUBJECT: Report of Discussion Between Mr. Polhemus of Department of Motor Vehicles and George Tiaffay.

Today the writer called on the Department of Motor Vehicles' representative, Mr. Folhemus, at 160 So. Van Ness Avenue, San Francisco.

The purpose of the visit was to inquire whether the Department of Motor Vehicles could assist us in clearing certain cases on which we have had title problems. The following cases were in question:

Motoi Fujiura, Family No. (20)-14811 Iwao Hayasa, Family No. (52)-27356 James Maruyama, Family No. (96)-32221 Shoji Morihise, Family No. (13)14007

The general condition with each of these cases was that either the owner-ship certificate or the registration card or both were missing. In view of the fact that we had made a reasonable attempt to secure the necessary certificates Mr. Polhemus referred to his instruction letter from Mr. Deems which covered the situation as follows:

"If the Japanese is not available they (Federal Reserve Bank) will indorse his name and countersign as agent"
"No affidavit or Power of Attorney is necessary"

From the latter instruction letter it seemed reasonable that the Federal Reserve Bank could, in the above cases, complete and countersign all of the necessary missing forms and thus bring about a final solution for these problems. Mr. Polhemus suggested, however, that when these duplicate forms were turned over with the license plates we should turn over any information regarding the efforts we had made to secure the original forms.

The following case which stands out singularly was also discussed:

Frank Kinei Higa, Family No. (85)-31473.

First of all by checking through the file it was found that the Power of Attorney which was given to Mr. Eicho Nakandare by Mr. Higa was limited "to sign all papers and documents that may be necessary in order to secure California registration on the following described vehicle". Mr. Polhemus brought out the point that the revised form should have been used which adds "or that may be necessary to effectuate a transfer of ownership".

However, insamuch as this was an Evacuee case the latter implication should be assumed.

The second point on this case was what would be the simplest way to dispose of this Evacuee's car to a dealer. Mr. Polhemus gave me a Department of Motor Vehicles' form "Affidavit Repossession, Lease Contract Only" to be used in this case. He suggested that we write to the Legal Owner, advise him of the situation and request that he fill out this form and send it to us with the ownership certificate. Upon receipt of this we would then make arrangements to sell to the dealer providing for the funds to be remitted first to the Legal Owner and the balance to the Evacuee.


