Findings: 1. This hearing was on complaint against licensee who holds A and P licenses at 527 5th Avenue, and A and P licenses at 421 Market Street, San Diego. The complaint alleges that licensee is doing business in violation of Board Order 145-N, that he is of the Japanese race. The records and files show that licensee is operating a cafe at each of the above locations.

2. The licensee stated that he was born in San Diego on June 13, 1913, of Japanese parentage; that he now has a wife and three children; that he owns the cafe properties, which he is now selling to other parties, and desires to transfer his licenses to the purchasers. He states that he has creditors to whom he owes about \$4,000, and if his licenses are revoked that his loss will be approximately \$7,500. A broker stated that he now has purchasers for each of the cafes.

3. The attorney for licensee requested a transcript of evidence, the original of which is hereto attached, so that he might present to the Board an application to transfer the above licenses.

4. Under the order of the Board, I find that I have no alternative but to recommend revocation. However, the Board has power to modify the application of its order should it see fit to do so.

Recommendation: Revocation.

I hereby certify that the foregoing constitutes my findings of ultimate fact and recommendations in the above entitled matter as a result of the hearing held before me at the above time and place.

Please refer to Petition for Dismissal of Proceedings by James B. Abbey, attorney, in the Matter of E. R. Simmermacher, District Liquor Control Administrator, vs. Alfred Y. Obayashi.

Pursuant to the instructions of your Board, and with particular reference to Petitioner's paragraph No. 8, we desire, after an exhaustive and comprehensive investigation and perusal of the facts and circumstances, to request your especial consideration to the merits of this petition.

Obviously embraced in the prayer of the Petitioner for dismissal and reinstatement for transfer purposes is the salient fact that such action by your Board would effect and accomplish the following:

1. Salvage the cash sales price for the purchase of the two businesses as set forth in Paragraph 4.
2. Permit the Japanese to retire in full a considerable amount of unpaid vendor's claims and liens owing Caucasian American Citizens.
3. Conserve and preserve a portion of the investment of the Japanese-American Citizen, Obayashi, evacuated under authority of the U. S. Army Civilian Exclusion Order.
4. Permit the continuance of established service to known clientele of San Diego citizens by successors, thus salvaging the "good will" of Obayashi's business.

April 29, 1942

5. Lending by your special dispensation in this case an effectual act of cooperation to cause painless results to all parties interested, i.e., the Japanese seller, an evacuee, the purchasers, the creditors, and the public.

Our interest in this matter is as "amicus curiae". Quite naturally we anticipate your Board will lend such aid and relief as the exigencies permit.

With reference to the above matter which you telephoned me about, I wish to advise you that today the State Board of Equalization approved the recommendation of the State Liquor Administrator canceling or revoking all licenses where questions of Japanese or alien enemy ownership was involved.

For your information, in the limited number of cases where, as in the above case, the Federal Reserve Bank or a federal agency has indicated a desire to have a transfer approved, you should avail yourself of the provisions of Section 45 of the Alcoholic Beverage Control Act and within ten days after official notice apply for a de novo hearing where the Board can consider the merits of the case and grant relief where justified. The action taken today will expedite rather than hinder progress in this matter.






Dear Sirs:





Gentlemen:

I am writing to you in regards to the action taken by the California State Board of Equalization to revoke the liquor licenses of American-born Japanese on charges that we are of the Japanese race disregarding our rights as American citizens.

Our federal government has been repeatedly reassuring us that our property will be protected and advising us to "sit tight" and not sell at a sacrifice. I have always maintained complete faith in the fairness and justice of this government, and so am now appealing to you to protect my property, the bulk of which is represented by the two liquor licenses which I own and the loss of which would render my business almost worthless. If I were guilty of some act which would justify the revocation of my licenses, I would not appeal to you, however, in all fairness, does the accident of birth to Japanese parents constitute a crime for which my property can be confiscated with no chance to sell or transfer?

I had been planning to sell my liquor licenses, using the proceeds towards the voluntary evacuation of my family so as not to cause our government any trouble or expense. I sincerely believed that this was my opportunity to show my loyalty in a small way, by cooperating with whatever orders the government issued through our President's emergency war powers.

Will you please, as the custodian to protect the interests of evacuees, look into this matter and help me in any way possible? I have been notified to appear before the local State Board of Equalization this Friday, March 20th., at which time my licenses will be revoked because I am of the Japanese race. If there is anything you can do to protect my rights as an American citizen, please notify me immediately before such an action is taken. Any protection you can afford me will be greatly appreciated. Thank you for your kind consideration in this matter.





We are forwarding herewith information in connection with two cases that are living in the Oceanside territory, and in case #1, Okima Masanori, P.O. Box 547, Oceanside, California, problem concerns a refrigerator which this party purchased for \$265.00, remaining contract \$80.00; also, 1936 International Truck-cost, \$545.00, contract \$440.00. This party called at this office on April 1, regarding what to do about his property and I thought perhaps you could chase it down further from your office.

Case #2 is Okasaki, Masato, General Delivery, San Marcos, California. This party has a five year lease to operate eight acres. The lease calls for payments of \$200.00 per year, and has one more year to go. Okasaki built a small home on this property that is worth about \$150.00. He also has other equipment worth about \$100.00, such as irrigation pipe, etc. The owner in fee, W. C. Burnlin, is now demanding Okasaki pay the \$200.00 for the next year's lease which he will not be able to use by reason of evacuation. Burnlin is threatening to attach building and personal property to enforce payment on this lease. I understand this party is a toughy. Suggest you contact if you desire.

Gentlemen:

Referring to our telephone conversation this morning in regard to our purchase of 99 crates of cauliflower from George Segawa, of Nestor, California, and five acres of cauliflower from Kazukiyo Oto, of Palm City, California, note you say that the market price on cauliflower was around \$1.00 a crate.

We will agree with you that this is correct, but in explanation want you to know that \$1.00 per crate in the shipping market means that the cauliflower is packed in a wooden crate, hauled to shipping point and loaded on the car, and this \$1.00 takes into consideration the cost of the cauliflower to the farmer, the cost of the packing, cost of the hauling, cost of the crate and cost of the loading, which will total approximately 95¢ per crate when paying the farmer 50¢ for the cauliflower. In other words, the \$1.00 price does not mean that the farmer gets \$1.00 for his cauliflower.

We also might mention that we were handling cauliflower in other districts and paid the farmers 50¢ per crate for their cauliflower, we standing all packing costs, hauling, crate material and loading costs.

In regard to the purchase of five acres of cauliflower from Kazukiyo Oto, we had an agreement with several cauliflower growers in the Palm City district that we would buy their entire acreage at \$80.00 an acre, less cost of surveying. We secured a licensed surveyor, William O. Heathcote, of San Diego, Calif., to survey the different patches of cauliflower, and we paid each one of the growers on the basis of the agreed price, as mentioned above.

Therefore, we are unable to understand why Mr. Oto, or anyone representing him, should have any question concerning this transaction. The only thing the writer can say is that evidently the party who made the complaint is not familiar with the produce business and did not understand, as in the case of Segawa, that the price made to the farmer for the commodity alone does not constitute selling price when loaded on board cars, as there are many operations to be taken into consideration between.

This letter refers to report mailed to you March 23, regarding the property and scope of problem of one Martin Ito. Further investigation has disclosed facts that might necessitate "blocking" this property.

At the time of my interview with Martin Ito it was not disclosed that he had a father that has been interned as an enemy alien, and that the transactions as disclosed were with the father and not the son.

Martin Ito, the son, is a U.S. citizen, of age, and legal owner of the rental property where he raised avocados and various truck vegetables for sale. The father operated a produce business by lease on the property known as 2004 Midway Drive, San Diego, California. Mrs. E. G. Heath is the legal owner. During the fall of 1941, the father sold his lease and produce business to one Richard C. Day of La Jolla, California. At this time the lease still had about two years to go and called for a total payment of \$940.00. Mr. Day operated the business at a loss for about two months and closed up, defaulting on the lease. After the father was interned Mrs. Heath threatened action against Martin Ito for unpaid balance on lease. This office settled this controversy to the satisfaction of both parties by encouraging Ito to leave his some minor fixtures that Mrs. Heath wanted.

Attorney Edward L. Bracklow of San Diego, acting at the request of Mr. Day, now appears and advises that he is filing suit on behalf of Mr. Day against Martin Ito claiming damages for \$2820.77 as a result of a fraudulent transaction, and that they intend to attach property. This improved property in the Escondido district is considered worth about \$1,000.00 per acre.

In accordance with instruction letter No. 2, I am referring this matter to you for further action.

Mr. Watkins, of the Los Angeles office, telephoned me Tuesday afternoon regarding a certain inquiry from Shimizu Ono. Please advise Mr. Watkins that I have contacted Ono and that the transaction he inquired about will go through satisfactorily.

The Jones-Cavanaugh Company agreed to purchase ninety-nine crates of cauliflower from one George Segawa, Nestor, California, and five acres of cauliflower from one Kawakiyo Ota of Palm City, California. The Japanese in question were evacuated before the transaction could be completed, and instructed Jones-Cavanaugh Company to make payments to friends who were appointed attorneys in fact.

At the time the transactions were entered into, the going market price for cauliflower was around \$1.00 per crate, however, after considerable delay the Jones-Cavanaugh Company remitted checks to the attorneys in fact for amount of about 50% of the going market value.

We acknowledge with thanks your letter of April 2nd, 1943 confirming an agreement for rental of 10,000 square feet at \$400 per month and the hauling of evacuees in San Diego County at the rate of \$2.50 per hour for truck and one man and \$3.50 per hour for truck and two men.

We previously advised that the 10,000 square feet to be furnished would be in two of our warehouses and that a floor space of 65 feet by 100 feet would be made available in one warehouse and later approximately 35 feet by 100 feet would be made available in the other warehouse. Until it is actually determined that the entire 10,000 square feet will be required, we will furnish you only with the 65 feet by 100 feet at a rental of \$200 monthly, and a separate agreement will be entered into in the event that additional space is required.

The floor space to be furnished is located in our building at 410 Market Street, San Diego, and the rental of \$200 per month shall commence April 10, 1943 and shall terminate July 10, 1943 with the understanding that the rental agreement will be renewed at the same price for an additional three 3-months periods provided, of course, that the household effects of the evacuees will at the time be in the custody of the Federal Reserve Bank.

In the event the balance of the 10,000 square feet (or 3,500 square feet more or less) is rented, such rent shall commence on the date that a separate agreement is entered into.

At the time that the effects are received by our van at the residence we will use any form furnished by you for the purpose of checking the items received and in addition thereto we will make an itemized list on our own

form of the items actually received. All such items received in the warehouse can then be checked by your representative. At the time that we haul the effects from the warehouse, the items will then be checked out against our inventory as well as your own form and a signature will be obtained from the owner or his authorized representative stating, in effect, that all of the property originally received from the owner has again been delivered in like order and condition except as otherwise noted.

In further accordance with our verbal understanding it is to be agreed that no liability is to be attached to the undersigned in the event of any loss or damage to the effects by fire and that the Federal Reserve Bank of San Francisco will hold us free and harmless in the event of any loss or damage occasioned by fire.

In the event that the above is not in accordance with your understanding or if there is any additional information required, do not hesitate to advise us.





- (e) The representative of the Federal Reserve Bank of San Francisco will check all numbers on the form and if found to be correct will acknowledge receipt of the motor vehicle by signing one copy of the form and delivering it to the evacuee.

If the motor vehicle described in this form is lost, damaged, or destroyed as the result of negligence while it is in the possession or custody of the United States, or any agency acting for it, the Congress of the United States will be asked to take appropriate action for the benefit of the owner.




Dear Sirs:

The case of M. Suzawa and the San Diego Consolidated Gas and Electric Co., involving the contract for Electric service entered into by Mr. Suzawa and which now will be come impossible for him to carry out, owing to his having to leave this area.

The Electric Company contends that Mr. Suzawa must recompense them for the service charge for the balance of one year on the contract. However, in going over the facts with the Oceanside office we find that the contract calls for six equal payments of \$8.75 a month beginning June 1, 1942. Owing to it being impossible for Mr. Suzawa to continue operating the acreage which is supplied with water from the well that the power service is furnished under, the Electric Company contract, Mr. Suzawa does not feel he should be obligated for the service charge.

There is also a deposit of \$50 to the credit of Mr. Suzawa held by the San Diego Consolidated Gas and Electric Co., to guarantee the payment of electric power used in pumping plant but as there is now no bills owing, Mr. Suzawa is asking the return of this deposit, which the Company continues to hold.

This office would appreciate it if you would take this matter up with the head office in San Diego, as any adjustment must come from them.
