

Dear Madam:

Reference is made to your letter dated March 15, 1942 regarding the leasehold interest of your father, R. Ruffino, and his partner, E. Bonino.

We believe it is highly questionable as to whether the evacuation order would excuse a lessee from his lease-hold obligations and the responsibilities incident to them, but suggest that your attorney will be in a position to provide you with more detailed information along that line, as well as the information you request regarding the necessity of service of notice from the lessors. Where evacuation is in prospect, we have been suggesting that lessees endeavor to work out some equitable arrangement with their lessors and so far as possible endeavor to find some means of protecting any equities they may enjoy in the properties involved.

We are uncertain from the subject matter of your letter whether the lease has already been surrendered or whether such a step is merely in prospect. If the latter is the case you may wish to explore the possibilities of finding someone to take over the leasehold before any steps are taken toward evacuation, inasmuch we understand that no time limit has yet been set in that connection.

The Evacuee Property Department of this bank is establishing a Field Representative at the office of the U.S. Employment Service, 7 Matividad Street, Salinas, California. We suggest that you may wish to contact that office for a further discussion of your problem. A copy of your letter and of our reply are going forward to that office for its information.

Further will it be necessary for the lessors to serve notice of the circumstances together with their inability to carry out the terms of the lease and ask for a specific release from further obligations?

I presume you are the proper authority to answer these questions, and if not, will you kindly refer the letter to the proper authorities. Thank you.
