

Pursuant to the provisions of Civilian Exclusion Order No. 38, this Headquarters, dated May 3, 1942, all persons of Japanese ancestry, both alien and non-alien, will be evacuated from the above area by 12 o'clock noon, P. W. T., Friday, May 8, 1942.

No Japanese person living in the obove area will be permitted to change residence after 12 o'clock noon, P. W. T., Sunday, May 3, 1942, without obtaining special permission from the representative of the Commanding General, Southern Land Frontier Sector, at the Civil Control Station located at:

1921 East Washington Street, Phoenix, Arizona,

61 East Pennington Street, Tueson, Arizona.

Such permits will only be granted for the purpose of uniting members of a family, or in cases of grave emergency.

The Civil Control Stations are equipped to assist the Japanese population affected by this evacuation in the following ways:

- 1. Give advice and instructions on the evacuation.
- 2. Provide services with respect to the management, leasing, sale, storage or other disposition of most kinds of property, such as real estate, business and professional equipment, household goods, boats, automobiles and livestock.
  - Provide temporary residence elsewhere for all Japanese in family groups.
- Transport persons and a limited amount of clothing and equipment to their new residence.

#### THE FOLLOWING INSTRUCTIONS MUST BE OBSERVED:

- 1. A responsible member of each family, preferably the head of the family, or the person in whose name most of the property is held, and each individual living alone, will report to either one of the Civil Control Stations to receive further instructions. This must be done between 8:00 A. M. and 5:00 P. M. on Monday, May 4, 1942, or between 8:00 A. M. and 5:00 P. M. on Tuesday, May 5, 1942.
- 2. Evacuees must carry with them on departure for the Reception Center, the following property:
  - (a) Bedding and liners (no mattress) for each member of the family;
  - (b) Toilet articles for each member of the family;
  - (c) Extra clothing for each member of the family;
  - Sufficient knives, forks, spoons, plates, bowls and enps for each mem-(d) ber of the family;
  - (e) Essential personal effects for each member of the family.

All items carried will be securely packaged, tied and plainly marked with the name of the owner and numbered in accordance with instructions obtained at the Civil Control Stations. The size and number of packages is limited to that which can be carried by the individual or family group.

- 3. No pets of any kind will be permitted.
- No personal items and no household goods will be shipped to the Reception Center.
- 5. The United States Government through its agencies will provide for the storage, at the sole risk of the owner, of the more substantial household items, such as iceboxes, washing machines, pianos and other heavy furniture. 

SUBJECT: INVESTIGATION OF ACTIVITIES OF PERSONS DMALING WITH EVACUETS

In addition to the freezing powers available to this bank under special Regulation No. 1, set forth in Evacuee Property Department Circular No. 1, for the protection of evacuees, which is ordinarily set in motion at the request of the evacuee, this bank has at its disposal the assistance of the Foreign Funds Control Investigative Unit of the Treasury Department for the investigation of transactions where such a step seems appropriate.

You may encounter cases which, in your opinion, demand inquiry into the motives and good faith of persons dealing with evacuees, even though the evacuee may be satisfied with the arrangement he contemplates or may already have made. Oases of this character should be referred to the office of this bank with which you are associated, in order that they may be brought to the attention of the Investigative Section to which they should properly be presented, rather than enforcement agencies whose interest therein might be doubtful.

It is not intended that all transactions which involve the question of exercise of the freezing power be so submitted, but it is our thought that we should make use of this facility where the services of an investigative agency would be warranted, particularly where fraud or disnonesty might be involved. This step should certainly be taken where illegality is suspected.



# INSTRUCTIONS TO ALL PERSONS OF JAPANESE ANCESTRY

#### LIVING IN THE FOLLOWING AREA:

All that portion of the County of Los Angeles, State of California, within the boundary beginning at the point where the Los Angeles-Ventura County line meets the Pacific Ocean; thence northeasterly along said county line to U. S. Highway No. 101; thence easterly along said Highway No. 101 to Sepulveda Boulevard; thence southerly along Sepulveda Boulevard to Wilshire Boulevard; thence westerly on Wilshire Boulevard to the limits of the City of Santa Monica; thence southerly along the said city limits to Pico Boulevard; thence easterly along Pico Boulevard to Sepulveda Boulevard; thence southerly on Sepulveda Boulevard to Manchester Avenue; thence westerly on Manchester Avenue and Manchester Avenue extended to the Pacific Ocean; thence northwesterly across Santa Monica Bay to the point of beginning.

Pursuant to the provisions of Civilian Exclusion Order No. 7, this Headquarters, dated April 20, 1942, all persons of Japanese ancestry, both alien and non-alien, will be evacuated from the above area by 12 o'clock noon, P.W.T., Tuesday, April 28, 1942.

No Japanese person living in the above area will be permitted to change residence after 12 o'clock noon, P.W.T., Monday, April 20, 1942, without obtaining special permission from the representative of the Commanding General, Southern California Sector at the Civil Control Station located at:

2422 Lincoln Boulevard Santa Monica, California

Such permits will only be granted for the purpose of uniting members of a family, or in cases of grave emergency.

The Civil Control Station is equipped to assist the Japanese population affected by this evacuation in the following ways:

- 1. Give advice and instructions on the evacuation.
- 2. Provide services with respect to the management, leasing, sale, storage or other disposition of most kinds of property, such as real

estate, business and professional equipment, household goods, boats, automobiles and livestock.

- 3. Provide temporary residence elsewhere for all Japanese in family groups.
- 4. Transport persons and a limited amount of clothing and equipment to their new residence.

#### THE FOLLOWING INSTRUCTIONS MUST BE OBSERVED:

- 1. A responsible member of each family, preferably the head of the family, or the persor, in whose name most of the property is held, and each individual living alone, will report to the Civil Control Station to receive further instructions. This must be done between 8:00 A. M. and 5:00 P. M. on Tuesday, April 21, 1942, or between 8:00 A. M. and 5:00 P. M. on Wednesday, April 22, 1942.
- 2. Evacuees must earry with them on departure for the Reception Center, the following property:
  - (a) Bedding and linens (no mattress) for each member of the family;
  - (b) Toilet articles for each member of the family :
  - (c) Extra clothing for each member of the family;
  - (d) Sufficient knives, forks, spoons, plates, bowls and cups for each member of the family;
  - (e) Essential personal effects for each member of the family.

All items carried will be securely packaged, tied and plainly marked with the name of the owner and numbered in accordance with instructions obtained at the Civil Control Station. The size and number of packages is limited to that which can be earried by the individual or family group.

- 3. No pets of any kind will be permitted.
- 4. The United States Government through its agencies will provide for the storage at the sole risk of the owner of the more substantial household items, such as iceboxes, washing machines, pianos and other heavy furniture. Cooking utensils and other small items will be accepted for storage if crated, packed and plainly marked with the name and address of the owner. Only one name and address will be used by a given family.
- 5. Each family and individual living alone will be furnished transportation to the Reception Center. Private means of transportation will not be utilized. All instructions pertaining to the movement will be obtained at the Civil Control Station.
- Go to the Civil Control Station between the hours of 8:00 A. M. and 5:00 P. M., Tuesday, April 21, 1942, or between the hours of 8:00 A. M. and 5:00 P. M., Wednesday, April 22, 1942 to receive further instructions.

#### Civilian Exclusion Order No. 8

1. 

2. A responsible member of each family and each individual living alone in the above described area will report between the hours of 8:00 A. M. and 5:00 P. M., Tuesday, April 21, 1942, or during the same hours on Wednesday, April 22, 1942, to the Civil Control Station located at:

Any person subject to this order who fails to comply with any of its provisions or with the provisions of published instructions pertaining hereto or who is found in the above area after 12 o'clock noon, P.W.T., of Tuesday, April 28, 1942, will be liable to the criminal penalties provided by Public Law No. 503, 77th Congress, approved March 21, 1942, entitled "An Act to Provide a Penalty for Violation of Restrictions or Orders with Respect to Persons Entering, Remaining in, Leaving, or Committing any Act in Military Areas or Zones," and alien Japanese will be subject to immediate apprehension and internment.

#### Civilian Exclusion Order No. 9

1. Pursuant to the provisions of Public Proclamations Nos. 1 and 2, this Headquarters, dated March 2, 1942, and March 16, 1942, respectively, it is hereby ordered that from and after 12 o'clock noon, P.W.T., of Tuesday, April 28, 1942, all persons of Japanese ancestry, both alien and non-alien, be excluded from that portion of Military Area No. 1 described as follows:


All that portion of the County of Los Angeles, State of California, within the boundary beginning at the point where the Santa Clara River crosses the Los Angeles-Ventura County line, and following said river in an easterly direction to its intersection with U. S. Highway No. 6; thence along U. S. Highway No. 6 to its intersection with an unimproved road at a point at or near Vincent (about six miles south of Palmdale); thence southerly along the unimproved road, through the San Gabriel Mountains to its junction with California State Highway No. 2 (Angeles Crest Highway); thence southerly along California State Highway No. 2, following Verdugo Road and Glendale Avenue to its intersection with Los Feliz Boulevard; thence westerly on Los Feliz Boulevard to Western Avenue; thence southerly on Western Avenue to its intersection with Franklin Avenue (Hollywood); thence westerly on Franklin Avenue to its intersection with Cahuenga Boulevard; thence northwesterly and westerly on Cahuenga Boulevard and Ventura Boulevard (also known as U. S. Highway No. 101) to the Los Angeles-Ventura County line; thence following said county line to the point of beginning.

2. A responsible member of each family and each individual living alone in the above described area will report between the hours of 8:00 A. M. and 5:00 P. M., Tuesday, April 21, 1942, or during the same hours on Wednesday, April 22, 1942, to the Civil Control Station located at:
