
A Japanese internee, one Fred Azuma, we understand has recently been transferred from Fort Missoula to Fort Sill.


On April 2nd, his son mailed him at Fort Missoula the certificate of title to his automobile for endorsement, but to date it has not been received back and has evidently been lost in transit. Attached is an affidavit for duplicate title which should be signed by Fred Azuma in two places, once on the face on the line designated signature of legal owner, and once on the back on line 1 as indicated.

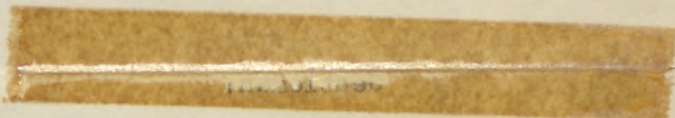

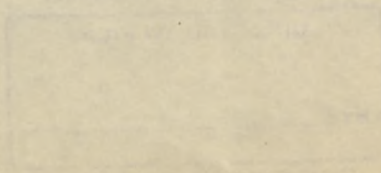
