Pursuant to the provisions of Public Proclamations Nos. 1 and 2, this Headquarters, dated March 2, 1942, and March 16, 1942, respectively, it is hereby ordered that from and after 12 o'clock noon, P.W.T., of Wednesday, June 3, 1942, all persons of Japanese ancestry, both alien and non-alien, be excluded from that portion of Military Area No. 1 described as follows:

All the Counties of Lincoln, Polk, Marion, Benton and Linn, and all that portion of the Counties of Jefferson and Deschutes, State of Oregon, lying west of U. S. Highway No. 97.

2. A responsible member of each family, and each individual living alone, in the above described area will report between the hours of 8:00 A. M. and 5:00 P. M., Wednesday, May 27, 1942, to either one of the Civil Control Stations located at:

American Legion Hall,  
North Cottage and Chemeketa Streets,  
Salem, Oregon.

357 Jefferson Street,  
Corvallis, Oregon.

3. Any person subject to this order who fails to comply with any of its provisions or with the provisions of published instructions pertaining hereto or who is found in the above area after 12 o'clock noon, P.W.T., of Wednesday, June 3, 1942, will be liable to the criminal penalties provided by Public Law No. 503, 77th Congress, approved March 21, 1942, entitled "An Act to Provide a Penalty for Violation of Restrictions or Orders with Respect to Persons Entering, Remaining in, Leaving or Committing any Act in Military Areas or Zones," and alien Japanese will be subject to immediate apprehension and internment.

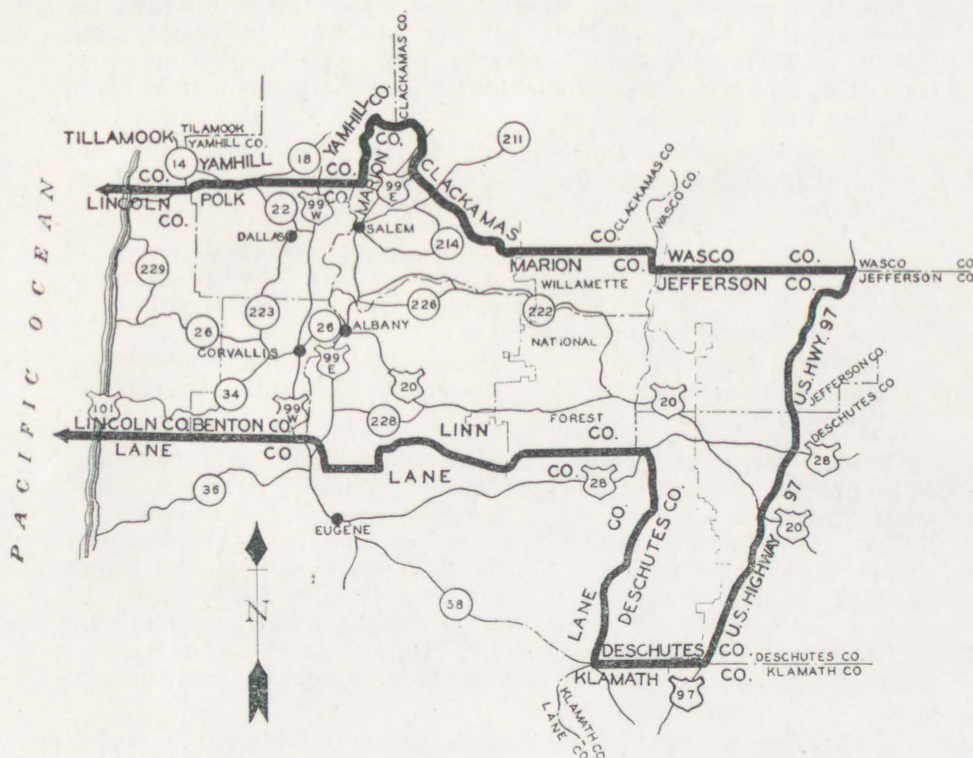

**LIVING IN THE FOLLOWING AREA:**

All the Counties of Lincoln, Polk, Marion, Benton and Linn, and all that portion of the Counties of Jefferson and Deschutes, State of Oregon, lying west of U. S. Highway No. 97.

Pursuant to the provisions of Civilian Exclusion Order No. 91, this Headquarters, dated May 23, 1942, all persons of Japanese ancestry, both alien and non-alien, will be evacuated from the above area by 12 o'clock noon, P.W.T., Wednesday, June 3, 1942.

No Japanese person will be permitted to move into, or out of, the above area after 5:00 A. M., P.W.T., Saturday, May 23, 1942, without obtaining special permission from the representative of the Commanding General, Northwestern Sector, at either one of the Civil Control Stations located at:

American Legion Hall,  
North Cottage and Chemeketa Streets,  
Salem, Oregon.

357 Jefferson Street,  
Corvallis, Oregon.

Such permits will only be granted for the purpose of uniting members of a family, or in cases of grave emergency.

The Civil Control Stations are equipped to assist the Japanese population affected by this evacuation in the following ways:

1. Give advice and instructions on the evacuation.
2. Provide services with respect to the management, leasing, sale, storage or other disposition of most kinds of property, such as real estate, business and professional equipment, household goods, boats, automobiles and livestock.
3. Provide temporary residence elsewhere for all Japanese in family groups.
4. Transport persons and a limited amount of clothing and equipment to their new residence.



## **THE FOLLOWING INSTRUCTIONS MUST BE OBSERVED:**

1. A responsible member of each family, preferably the head of the family, or the person in whose name most of the property is held, and each individual living alone, will report to either one of the Civil Control Stations to receive further instructions. This must be done between 8:00 A. M. and 5:00 P. M. on Wednesday, May 27, 1942. Should such individual reside over 30 miles from the nearest Civil Control Station and be unable to provide transportation to such Civil Control Station, he will telegraph or telephone on Tuesday, May 26, 1942, to the Manager of the nearest Civil Control Station for instructions.

2. Evacuees must carry with them on departure for the Reception Center, the following property:

- (a) Bedding and liners (no mattress) for each member of the family;
- (b) Toilet articles for each member of the family;
- (c) Extra clothing for each member of the family;
- (d) Essential personal effects for each member of the family.

All items carried will be securely packaged, tied and plainly marked with the name of the owner and numbered in accordance with instructions obtained at the Civil Control Station. The size and number of packages is limited to that which can be carried by the individual or family group.

3. No pets of any kind will be permitted.

4. No personal items and no household goods will be shipped to the Reception Center.

5. The United States Government through its agencies will provide for the storage, at the sole risk of the owner, of the more substantial household items, such as iceboxes, washing machines, pianos and other heavy furniture. Cooking utensils and other small items will be accepted for storage if crated, packed and plainly marked with the name and address of the owner. Only one name and address will be used by a given family.

6. Each family, and individual living alone, will be furnished transportation to the Reception Center. Private means of transportation will not be utilized. All instructions pertaining to the movement will be obtained at the Civil Control Station.

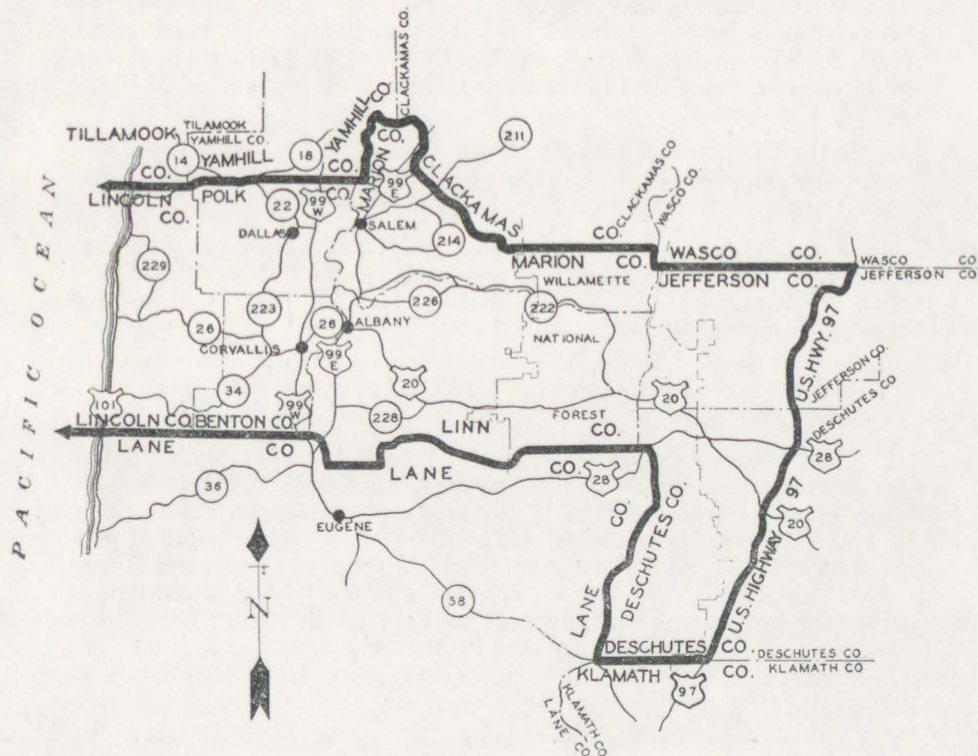

# INSTRUCTIONS TO ALL PERSONS OF JAPANESE ANCESTRY

## LIVING IN THE FOLLOWING AREA:

All the Counties of Lincoln, Polk, Marion, Benton and Linn, and all that portion of the Counties of Jefferson and Deschutes, State of Oregon, lying west of U. S. Highway No. 97.

Pursuant to the provisions of Civilian Exclusion Order No. 91, this Headquarters, dated May 23, 1942, all persons of Japanese ancestry, both alien and non-alien, will be evacuated from the above area by 12 o'clock noon, P.W.T., Wednesday, June 3, 1942.

No Japanese person will be permitted to move into, or out of, the above area after 5:00 A. M., P.W.T., Saturday, May 23, 1942, without obtaining special permission from the representative of the Commanding General, Northwestern Sector, at either one of the Civil Control Stations located at:

American Legion Hall,  
North Cottage and Chemeketa Streets,  
Salem, Oregon.

357 Jefferson Street,  
Corvallis, Oregon.

Such permits will only be granted for the purpose of uniting members of a family, or in cases of grave emergency.

The Civil Control Stations are equipped to assist the Japanese population affected by this evacuation in the following ways:

1. Give advice and instructions on the evacuation.
2. Provide services with respect to the management, leasing, sale, storage or other disposition of most kinds of property, such as real estate, business and professional equipment, household goods, boats, automobiles and livestock.
3. Provide temporary residence elsewhere for all Japanese in family groups.
4. Transport persons and a limited amount of clothing and equipment to their new residence.



**THE FOLLOWING INSTRUCTIONS MUST BE OBSERVED:**

1. A responsible member of each family, preferably the head of the family, or the person in whose name most of the property is held, and each individual living alone, will report to either one of the Civil Control Stations to receive further instructions. This must be done between 8:00 A. M. and 5:00 P. M. on Wednesday, May 27, 1942. Should such individual reside over 30 miles from the nearest Civil Control Station and be unable to provide transportation to such Civil Control Station, he will telegraph or telephone on Tuesday, May 26, 1942, to the Manager of the nearest Civil Control Station for instructions.

2. Evacuees must carry with them on departure for the Reception Center, the following property:

- (a) Bedding and linens (no mattress) for each member of the family;
- (b) Toilet articles for each member of the family;
- (c) Extra clothing for each member of the family;
- (d) Essential personal effects for each member of the family.

All items carried will be securely packaged, tied and plainly marked with the name of the owner and numbered in accordance with instructions obtained at the Civil Control Station. The size and number of packages is limited to that which can be carried by the individual or family group.

3. No pets of any kind will be permitted.

4. No personal items and no household goods will be shipped to the Reception Center.

5. The United States Government through its agencies will provide for the storage, at the sole risk of the owner, of the more substantial household items, such as iceboxes, washing machines, pianos and other heavy furniture. Cooking utensils and other small items will be accepted for storage if crated, packed and plainly marked with the name and address of the owner. Only one name and address will be used by a given family.

3. Any person subject to this order who fails to comply with any of its provisions or with the provisions of published instructions pertaining hereto or who is found in the above area after 12 o'clock noon, P.W.T., of Wednesday, June 3, 1942, will be liable to the criminal penalties provided by Public Law No. 503, 77th Congress, approved March 21, 1942, entitled "An Act to Provide a Penalty for Violation of Restrictions or Orders with Respect to Persons Entering, Remaining in, Leaving or Committing any Act in Military Areas or Zones," and alien Japanese will be subject to immediate apprehension and internment.

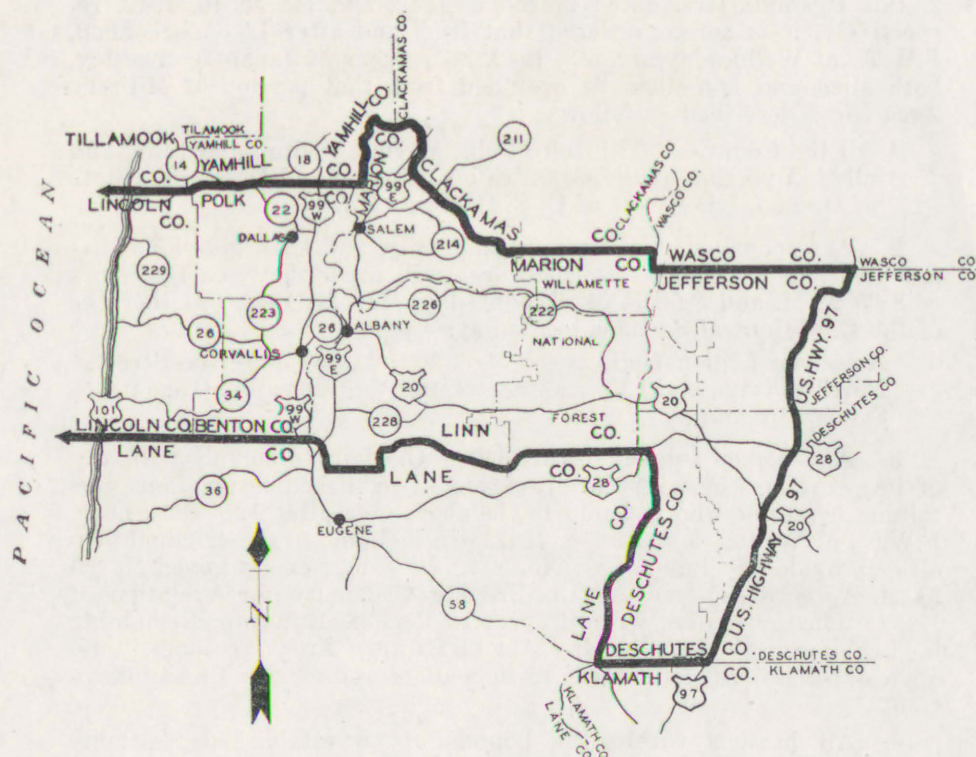

# INSTRUCTIONS TO ALL PERSONS OF JAPANESE ANCESTRY

## LIVING IN THE FOLLOWING AREA:

All the Counties of Lincoln, Polk, Marion, Benton and Linn, and all that portion of the Counties of Jefferson and Deschutes, State of Oregon, lying west of U. S. Highway No. 97.

Pursuant to the provisions of Civilian Exclusion Order No. 91, this Headquarters, dated May 23, 1942, all persons of Japanese ancestry, both alien and non-alien, will be evacuated from the above area by 12 o'clock noon, P.W.T., Wednesday, June 3, 1942.

No Japanese person will be permitted to move into, or out of, the above area after 5:00 A. M., P.W.T., Saturday, May 23, 1942, without obtaining special permission from the representative of the Commanding General, Northwestern Sector, at either one of the Civil Control Stations located at:

American Legion Hall,  
North Cottage and Chemeketa Streets,  
Salem, Oregon.

357 Jefferson Street,  
Corvallis, Oregon.

Such permits will only be granted for the purpose of uniting members of a family, or in cases of grave emergency.

The Civil Control Stations are equipped to assist the Japanese population affected by this evacuation in the following ways:

1. Give advice and instructions on the evacuation.
2. Provide services with respect to the management, leasing, sale, storage or other disposition of most kinds of property, such as real estate, business and professional equipment, household goods, boats, automobiles and livestock.
3. Provide temporary residence elsewhere for all Japanese in family groups.
4. Transport persons and a limited amount of clothing and equipment to their new residence.



**THE FOLLOWING INSTRUCTIONS MUST BE OBSERVED:**

1. A responsible member of each family, preferably the head of the family, or the person in whose name most of the property is held, and each individual living alone, will report to either one of the Civil Control Stations to receive further instructions. This must be done between 8:00 A. M. and 5:00 P. M. on Wednesday, May 27, 1942. Should such individual reside over 30 miles from the nearest Civil Control Station and be unable to provide transportation to such Civil Control Station, he will telegraph or telephone on Tuesday, May 26, 1942, to the Manager of the nearest Civil Control Station for instructions.

2. Evacuees must carry with them on departure for the Reception Center, the following property:

- (a) Bedding and liners (no mattress) for each member of the family;
- (b) Toilet articles for each member of the family;
- (c) Extra clothing for each member of the family;
- (d) Essential personal effects for each member of the family.

All items carried will be securely packaged, tied and plainly marked with the name of the owner and numbered in accordance with instructions obtained at the Civil Control Station. The size and number of packages is limited to that which can be carried by the individual or family group.

3. No pets of any kind will be permitted.

4. No personal items and no household goods will be shipped to the Reception Center.

5. The United States Government through its agencies will provide for the storage, at the sole risk of the owner, of the more substantial household items, such as iceboxes, washing machines, pianos and other heavy furniture. Cooking utensils and other small items will be accepted for storage if crated, packed and plainly marked with the name and address of the owner. Only one name and address will be used by a given family.

6. Each family, and individual living alone, will be furnished transportation to the Reception Center. Private means of transportation will not be utilized. All instructions pertaining to the movement will be obtained at the Civil Control Station.

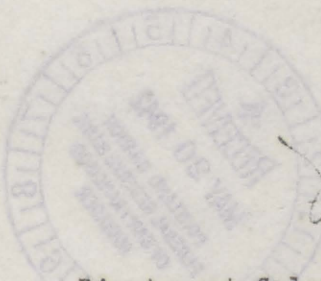

June 1, 1942

Conclusion: The Japanese interviewed consisted of 14 students attending Oregon State College. There were no Japanese families or Japanese businesses in this district. There were two individuals who wish to store three items each. Evacuees agreed to deliver these storage items to the Silver Wheel Trucking Company Depot at 2nd and Van Buren Streets, where arrangements were made with this trucking company to forward the items to the Oregon Transfer Company warehouse No. 5 at 733 N. W. Everett St., Portland, Oregon.

At noon of May 28th, being certain that all business had been taken care of, I reported by telephone to Mr. Risberg at headquarters. Mr. Risberg instructed me to return to Portland. I took the bus leaving Corvallis at 3:05 p.m. and arrived at Portland at 5:50 p.m.


