

NATIONAL MONETARY COMMISSION.

MARCH 15, 1912.

It has been decided that the Report of the National Monetary Commission, together with the Preliminary Plans submitted by the Chairman in January, 1911, and December, 1911, be included in volume 1 with the Interviews on Banking in Europe. Pursuant to this purpose, a new title-page for volume 1 has been prepared and is inclosed, together with the three documents mentioned.

It is suggested that the "Tabular Summary of the Laws, Practices, and Statistics of the Principal Banks of the Leading Countries" (2 sheets), which is also inclosed, should be attached to the inside of the cover of volume 23, "Financial Diagrams" (Senate Document No. 509). In connection therewith a new title-page for this volume has been prepared, of which a copy is also inclosed.

These rearrangements will obviate the necessity of volume 24, listed in a former circular, and for which a provisional title-page was distributed.
