Checks on Certain Nonmember State Banks in North Carolina Temporarily Unacceptable For Collection

To all Member Banks in the Second Federal Reserve District:

For the present, checks drawn on those nonmember State banks located in North Carolina listed on the following page cannot be accepted by us for collection through the Federal Reserve Bank of Richmond. This is due to a temporary restraining order which these institutions have obtained from the Superior Court for Union County, North Carolina, as plaintiffs, in an injunction suit against the Federal Reserve Bank of Richmond. The temporary order restrains that bank from returning as dishonored any check drawn upon any one of the banking institutions named, or upon any other nonmember State bank within the jurisdiction of North Carolina joining the suit, which the drawee bank refuses to pay except in exchange at less than par.

The restraining order does not, however, apply to checks drawn on or before February 5, 1921, nor to checks on any banks which have not become parties to the suit.

The Federal Reserve Bank of Richmond advises us that it will move to dissolve the injunction.
