NEW COUNTERFEITS

To Member Banks in the Second Federal
Reserve District and others concerned:

At the request of the Secret Service Division of the Treasury Department, New York District, we are forwarding to all member banks in the Second Federal Reserve District the following information which we have received from the Secret Service Division describing new counterfeit notes which have recently appeared in circulation in the New York District:

\$10 FEDERAL RESERVE NOTE

On the FEDERAL RESERVE BANK OF KANSAS CITY, MISSOURI, Series of 1928 B, Check Letter 'F,' Face Plate No. 41, Back Plate No. 8, Serial No. J 10403456 A, bearing signatures of W. O. WOODS and A. W. MELLON, portrait of HAMILTON. This note is printed on one sheet of paper of good quality from excellently etched photo-mechanical plates, the workmanship resembling somewhat that described in Circular #641. This note is a dangerous reproduction calculated to deceive the unwary handler of currency.

\$10 FEDERAL RESERVE NOTE

On the FEDERAL RESERVE BANK OF NEW YORK, N. Y.; Series of 1928 B, Check Letter 'B,' Face Plate No. 32, back plate number indistinct, appears to be 136, Serial No. B 26509138 A, bearing signatures of W. O. WOODS and A. W. MELLON, portrait of HAMILTON. This counterfeit is printed on one sheet of paper from photo-etched plates of fair workmanship. Its general appearance is smudgy and dark, and it should be readily detected by persons familiar with currency.

\$10 FEDERAL RESERVE NOTE

On the FEDERAL RESERVE BANK OF PHILADELPHIA, PENNSYLVANIA; 1928 B Series; Check Letter 'A,' Face Plate No. 25, Back Plate No. 48; Serial No. C25232847A; signatures of W. O. WOODS and A. W. MELLON, portrait of HAMILTON. This note is a photo-mechanical reproduction printed on one sheet of paper of fair quality.

\$10 FEDERAL RESERVE NOTE

On the FEDERAL RESERVE BANK OF RICHMOND, VIRGINIA; Check Letter 'A,' Face Plate No. 25, Back Plate No. 48. Same workmanship as the Philadelphia \$10 note above described, and bearing same check letter and plate numbers.

\$20 FEDERAL RESERVE NOTE

On the FEDERAL RESERVE BANK OF CLEVELAND, OHIO; 1928 B Series; Check Letter 'C,' Face Plate No. 14; back plate number indistinct; Serial No. D11922732A; signatures of W. O. WOODS and A. W. MELLON; portrait of JACKSON. This note represents the same workmanship as the two above described \$10 notes on the Richmond and Philadelphia FEDERAL RESERVE BANKS.

The Treasury Department, Secret Service Division, requests that banks and others to whom counterfeit Government obligations may be presented endeavor when practicable to obtain information regarding their source and history.
