Nomination and Election of Directors

(By member banks in Group 3 only, that is, member banks with capital and surplus of less than \$301,000).

To Member Banks in the Second Federal Reserve District:

In accordance with the provisions of section 4 of the Federal Reserve Act, as amended, and circular No. 1701, dated September 30, 1936, in regard to election of directors of this bank for terms of office from January 1, 1937, to December 31, 1939, to succeed Cecil R. Berry, class A director, and Robert T. Stevens, class B director, whose terms expire December 31, 1936, there are given on pages 3 and 4 the names of the candidates nominated for such directors, indicating by whom nominated.

As indicated in circular No. 1701, dated September 30, 1936, section 4 of the Federal Reserve Act, as amended by section 3(b) of the Banking Act of 1933*, provides in effect that whenever any two or more member banks within the same Federal reserve district are affiliated with the same holding company affiliate (as that term is defined in section 2(c) of the Banking Act of 1933 as amended by section 301 of the Banking Act of 1935)** participation by such member banks in the election of directors of Federal reserve banks shall be confined to one of such banks, and the holding company affiliate may designate the bank to participate in such election. Consequently, the ballot of any bank in Group 3 so affiliated cannot be counted as valid unless there is on file with me a certified copy of a resolution of the holding company affiliate of such bank, designating such bank to participate in this election. If such certified copy of resolution has not yet been filed with me, it may be sent to reach me at or before the time the enclosed ballot is cast by the bank designated in such resolution. Copies of a form of such resolution were sent with the above mentioned circular to each bank in Group 3 and additional copies will be furnished upon request.

To each bank in Group 3, except banks affiliated with holding company affiliates which have designated another bank to participate in this election, the following are being sent with this circular:

- (a) Preferential ballot for use in voting for candidates for class A director and class B director.
- (b) Colored ballot envelope in which the ballot is to be sealed.

- ** Section 2 (c) of the Banking Act of 1933, as amended by section 301 of the Banking Act of 1935, defines the term "holding company affiliate" as follows:
 - (c) The term "holding company affiliate" shall include any corporation, business trust, association, or other similar organization—
 - (1) Which owns or controls, directly or indirectly, either a majority of the shares of capital stock of a member bank or more than 50 per centum of the number of shares voted for the election of directors of any one bank at the preceding election, or controls in any manner the election of a majority of the directors of any one bank; or
 - (2) For the benefit of whose shareholders or members all or substantially all the capital stock of a member bank is held by trustees.

Notwithstanding the foregoing, the term "holding company affiliate" shall not include (except for the purposes of section 23A of the Federal Reserve Act, as amended) any corporation all of the stock of which is owned by the United States, or any organization which is determined by the Board of Governors of the Federal Reserve System not to be engaged, directly or indirectly, as a business in holding the stock of, or managing or controlling, banks, banking associations, savings banks, or trust companies.

^{*} Section 4 of the Federal Reserve Act, as amended by section 3 (b) of the Banking Act of 1933, provides, in part, as follows:

with the same holding company affiliate, participation by such member banks in any such nomination or election shall be confined to one of such banks, which may be designated for the purpose by such holding company affiliate.

- (c) Certificate envelope bearing on its face the certificate in regard to the vote.
- (d) Addressed envelope in which all of the foregoing should be returned to me.

The ballot and certificate on the certificate envelope must be executed by an officer who has been authorized to cast the vote. A list showing the officers designated for this purpose by the respective member banks in Group 3 was attached to the above mentioned circular dated September 30, 1936, and a similar list amended to October 26, 1936, is attached to this circular beginning at page 5. In order that the ballot may be secret, the name of the bank and the name and title of the voting officer should not be written on the ballot, but should be written only on the certificate envelope.

- (1) After the preferential ballot has been marked,
- (2) It should be placed in the colored ballot envelope and that envelope sealed.
- (3) Then the sealed colored ballot envelope should be placed within the certificate envelope, and the certificate envelope should be sealed and the certificate thereon executed.
- (4) Then the certificate envelope containing the sealed colored ballot envelope should be returned to me in the enclosed addressed envelope.

The law provides that the ballot shall be cast within 15 days after receipt of the list transmitted herewith. The polls will open on October 29, 1936, and will close at 12 o'clock noon on Friday, November 13, 1936, and in order to be counted as valid the ballot must be received by me at or before the latter time. Upon the closing of the polls the ballot box will be opened in the board room of this bank, the sealed envelopes containing the ballots will be opened, the votes counted and checked by tellers and the results of the election announced. The candidates are invited to be present or represented on this occasion.

The banks in Groups 1 and 2 will not vote in this election, and this circular is sent to them without forms for their information only.
