Nomination and Election of Directors

To Member Banks in the Second Federal Reserve District:

In accordance with the provisions of section 4 of the Federal Reserve Act, as amended, and Circular No. 3943, dated February 2, 1953, in regard to an election of directors of this Bank to fill three vacancies in its board of directors, there are shown on the following pages the names of the candidates nominated for such directors, and by whom nominated. The three vacancies in the board of directors of this Bank to be filled are as follows:

1. In the office of class A director for the unexpired portion of the term ending December 31, 1955, to which W. RANDOLPH BURGESS was elected on November 14, 1952, but which he did not assume. Mr. Burgess was elected by member banks in Group 1 and his successor will be chosen by this group.
2. In the office of class B director for the unexpired portion of the term ending December 31, 1953, from which MARION B. FOLSOM resigned. Mr. Folsom was elected by member banks in Group 2 and his successor will be chosen by this group.
3. In the office of class B director for the unexpired portion of the term ending December 31, 1954, from which JAY E. CRANE resigned. Mr. Crane was elected by member banks in Group 3 and his successor will be chosen by this group.

The following are being sent with this circular to the member banks in the respective groups, except banks affiliated with holding company affiliates that have designated another bank to participate in this election:*

- (a) Preferential ballot for use in voting for candidates as follows:
 - (i) By each bank in Group 1, for candidate for class A director;
 - (ii) By each bank in Group 2, for candidate for class B director for the unexpired portion of the term ending December 31, 1953;
 - (iii) By each bank in Group 3, for candidate for class B director for the unexpired portion of the term ending December 31, 1954.
- (b) Ballot envelope in which the ballot is to be sealed.
- (c) Certificate envelope bearing on its face the certificate in regard to the vote.
- (d) Addressed envelope in which all of the foregoing should be returned to me.

* As indicated in Circular No. 3943, dated February 2, 1953, section 4 of the Federal Reserve Act, as amended, provides that whenever any two or more member banks within the same Federal reserve district are affiliated with the same holding company affiliate, participation by such member banks in the election of directors of Federal reserve banks shall be confined to one of such banks, and the holding company affiliate may designate the bank to participate in such election. Consequently, the ballot of any bank in Group 1, 2, or 3 so affiliated with one or more other banks in the same group cannot be counted as valid unless there is on file with me evidence that such bank has been so designated.

The ballot and certificate on the certificate envelope must be executed by an officer who has been authorized to cast the vote. Lists of the officers designated for this purpose by the respective member banks in Groups 1, 2, and 3 were shown in the above mentioned circular dated February 2, 1953, and similar lists amended to March 2, 1953, are shown in this circular. In order that the ballot may be secret, the name of the bank and the name and title of the voting officer should not be written on the ballot, but should be written only on the certificate envelope.

- (1) After the preferential ballot has been marked,
- (2) It should be placed in the ballot envelope and that envelope sealed.
- (3) Then the sealed ballot envelope should be placed within the certificate envelope, and the certificate envelope should be sealed and the certificate thereon executed.
- (4) Then the certificate envelope containing the sealed ballot envelope should be returned to me in the enclosed addressed envelope.

The law provides that the ballot shall be cast within 15 days after receipt of the list of candidates transmitted herewith. The polls will open on March 5, 1953, and will close at 12 o'clock noon, on Friday, March 20, 1953, and in order to be counted as valid the ballot must be received by me at or before the latter time. Upon the closing of the polls, the ballot box will be opened in the board room of this Bank, the sealed envelopes containing the ballots will be opened, the votes counted and checked by tellers, and the results of the election announced. The candidates are invited to be present or represented on this occasion.

N. BAXTER JACKSON was born in Nashville, Tennessee, on December 3, 1890, and graduated from Vanderbilt University in 1911. His affiliation with banking began immediately upon graduation when he became a clerk in the First National Bank of Nashville; later he became, successively, cashier of the Cumberland Valley National Bank and vice president of the American National Bank, both of Nashville. Mr. Jackson has been with the Chemical Bank & Trust Company (and its predecessor, the Chemical National Bank of New York) since 1920. He joined the institution as assistant cashier, later becoming vice president, executive vice president, first vice president, president, and, in 1947, chairman. He is also a director of the French American Banking Corporation, Home Life Insurance Company of New York, General Reinsurance Corporation, North Star Reinsurance Corporation, American Chicle Company, McCrory Stores Corporation, United Stores Corporation, Chemical Safe Deposit Company, Interchemical Corporation, Western Electric Co. Inc., and Aluminium Co. Ltd. Mr. Jackson is a trustee of The Roosevelt Hospital and of the Beekman-Downtown Hospital; a member of the board of Vanderbilt University and of the national board of the Young Women's Christian Association of America. He is also a member of the Government Borrowing Committee of the American Bankers Association and a past chairman of Group VIII of the New York State Bankers Association. He has served as a member of the Federal Advisory Council representing the Second Federal Reserve District.

He was treasurer of The Grand Union Company in 1928, becoming vice president in 1929, which position he held through 1947 when he was elected president, the position he now holds. He is a director and member of the executive committee of the American Re-insurance Company and American Reserve Insurance Company; director and past chairman of the National Association of Food Chains; director of the Super Market Institute; and a member of the board of trustees of the American Retail Federation. Mr. Shield is vice chairman of the board of trustees, life trustee, and member of the executive committee of Rutgers University. He was awarded the Honor Medal of the Freedom Foundation in 1951.

JOHN E. BIERWIRTH was born in Brooklyn on April 21, 1895. He was educated at Hotchkiss School, Lakeville, Connecticut, and received the degree of A.B. from Yale University in 1917. From 1919 through 1929, he was vice president and director of Thompson-Starrett Company, Inc. He became affiliated with The New York Trust Company as a vice president in 1929 and became president and trustee in 1941, which positions he held until 1949. Since 1949, he has been the president and a director of the National Distillers Products Corporation. Mr. Bierwirth is a director of Avco Manufacturing Corporation, Bell Aircraft Corporation, Container Corporation of America, General Time Instrument Corporation, National Shares Corporation, Owens Corning Fiberglas Corporation, Panhandle Eastern Pipe Line Company, Trans World Airlines, Inc., National Petro-Chemicals Corporation, Mercantile Stores Company, and Presbyterian Hospital of the City of New York.

Mr. Bierwirth is a director of The New York Trust Company, New York, New York, but will resign as such if elected a class B director of the Federal Reserve Bank of New York.
