Nomination and Election of Directors

(By member banks classified in Group 3 on October 10, 1960, that is, member banks with capital and surplus of \$1,000,000 or less, on that date)

To Member Banks of the Second Federal Reserve District:

In accordance with the provisions of section 4 of the Federal Reserve Act, as amended, and Circular No. 4944, dated October 10, 1960, on the election of directors of this Bank for terms of office from January 1, 1961, to December 31, 1963, to succeed CYRUS M. HIGLEY, class A director, and AUGUSTUS C. LONG, class B director, whose terms expire December 31, 1960, there are shown on pages 2 and 3 the names of the candidates nominated for such offices, and by whom nominated.

To each bank classified in Group 3 on October 10, 1960, except banks affiliated with holding company affiliates which have designated another bank to participate in this election,* the following are being sent with this circular:

- (a) Preferential ballot for use in voting for candidates for class A director and class B director.
- (b) Colored ballot envelope in which the ballot is to be sealed.
- (c) Certificate envelope bearing on its face the certificate in regard to the vote.
- (d) Addressed envelope in which all of the foregoing should be returned to me.

The ballot and the certificate on the certificate envelope must be executed by an officer who has been authorized to cast the vote. A list of the officers designated for this purpose by the respective member banks in Group 3 formed a part of the above mentioned circular dated October 10, 1960, and a similar list revised to date forms a part of this circular. In order that the ballot may be secret, the name of the bank and the name and title of the voting officer should not be written on the ballot, but should be written only on the certificate envelope.

- (1) After the preferential ballot has been marked,
- (2) It should be placed in the colored ballot envelope and that envelope sealed.
- (3) Then the sealed colored ballot envelope should be placed within the certificate envelope, and the certificate envelope should be sealed and the certificate thereon executed.
- (4) Then the certificate envelope containing the sealed colored ballot envelope should be returned to me in the enclosed addressed envelope.

The law provides that the ballot shall be cast within 15 days after receipt of the list of candidates transmitted herewith. The polls will open at 9 a.m., November 17, 1960, and will close at 12 o'clock noon, on Friday, December 2, 1960, and in order to be counted as valid the ballot must be received by me at or before the latter time. Upon the closing of the polls the ballot box will be opened in the board room of this Bank, the sealed envelopes containing the ballots will be opened, the votes counted and checked by tellers, and the results of the election announced. The candidates are invited to be present or represented on this occasion.

Because banks in Groups 1 and 2 will not vote in this election, this circular is sent to them without forms and for their information only.

* As indicated in Circular No. 4944, dated October 10, 1960, section 4 of the Federal Reserve Act, as amended, provides that whenever any two or more member banks within the same Federal reserve district are affiliated with the same holding company affiliate, participation by such member banks in the election of directors of Federal reserve banks shall be confined to one of such banks, and the holding company affiliate may designate the bank to participate in such election. Consequently, the ballot of any bank in Group 3 so affiliated cannot be counted as valid unless there is on file with me evidence that such bank has been so designated.

A. LEONARD MOTT was born on June 9, 1913, in Locke, New York. He is a graduate of the Bentley School of Accounting and Finance, Boston, Massachusetts. He entered banking 25 years ago with The First National Bank of Moravia, becoming President in 1949. He is a member of the New York State Bankers Association's Council of Administration and Administrative Board, serving as a Member At Large from Group IV. He has been Chairman, Vice Chairman, and Secretary-Treasurer of the Group. For several years, he was a member of the Association's Committee on Bank Management and Research and served as its chairman 1959-1960.

Mr. Mott is a director of The Highway Materials Corporation of South Lansing, New York, and of Chronicle Guidance Publications, Inc., of Moravia, New York. In community and social service, he is past president of the Moravia Chamber of Commerce, vice president of the United Fund of Cayuga County, and a member of the executive committee of the Cayuga County Council of the Boy Scouts of America.

Candidate for Class B Director

AUGUSTUS C. LONG, NEW YORK, N. Y.
Chairman, Board of Directors, Texaco Inc., New York, N. Y.

AUGUSTUS C. LONG was born on August 23, 1904, in Starke, Florida. After being graduated from the United States Naval Academy in 1926, he served in the Navy before joining The Texas Company (now Texaco Inc.) on January 1, 1930.

Mr. Long has served with Texaco both here and abroad, and in 1949 was elected vice president in charge of Foreign Operations — Eastern Hemisphere. He was named a director of the Company a year later. In 1951, he was elected executive vice president; in 1953, president; and in 1956, chairman of the board of directors and chief executive officer.

Mr. Long is a director of the Freeport Sulphur Company and the Equitable Life Assurance Society of the United States. He is also a board member of the American Petroleum Institute, and a member of the Business Advisory Council of the Department of Commerce. He is a trustee of the Presbyterian Hospital in the City of New York.

Mr. Long has been serving as a class B director of the Federal Reserve Bank of New York since May 1957.
