Results of the last offering of Treasury bills (91-day bills to be issued January 4, 1962, representing an additional amount of bills dated October 5, 1961, and maturing April 5, 1962, and 182-day bills dated January 4, 1962, maturing July 3, 1962) are shown on the reverse side of this circular.
