# COLLECTION OF CASH ITEMS Changes in New York Head Office Time Schedule

To the Member Banks of the Second Federal Reserve District, and Others Concerned:

Enclosed is a copy of the First Supplement, effective July 1, 1974, to Appendix No. 1 (New York Head Office Time Schedule) to Operating Circular No. 5, Revised effective July 1, 1974.

This Bank's Circular No. 7394, dated May 17, 1974, entitled "Check Collection Services," transmitted certain operating circulars that had been revised, effective July 1, 1974, to reflect several changes in the Federal Reserve System's check collection policy. Among the documents revised was the New York Head Office Time Schedule (Appendix No. 1 to Operating Circular No. 5).

Effective July 1, 1974, the following changes have been made in paragraph 2 of Appendix No. 1:

- (a) Credit for cash items payable in Miami bearing routing symbol 0670 will be given two business days after receipt, rather than two calendar days after receipt.
- (b) Credit for cash items drawn on or payable at banks participating in the Philadelphia RCPC will be given two business days after receipt, rather than two calendar days after receipt.
- (c) In addition to the Philadelphia RCPC, credit for cash items drawn on or payable at banks participating in the following Regional Check Processing Centers will be given two business days after receipt: Atlanta RCPC, Birmingham RCPC, Jacksonville RCPC, Nashville RCPC, and New Orleans RCPC.
- (d) Credit for cash items drawn on or payable at the Maine RCPC and the Oklahoma RCPC will be given two calendar days after receipt.
