## Presentment of Checks and Other Cash Items To Ohio Depository Institutions

To All Depository Institutions, and Others Concerned, in the Second Federal Reserve District:

Our Circular No. 9838, dated April 16, 1985, contained a list of Ohio depository institutions to which presentment of checks and other cash items could not at that time be made, as a result of the March 15, 1985 proclamation of the Governor of Ohio, together with a list of Ohio institutions to which such presentment had been resumed. In subsequent circulars, we amended those lists as the situation changed.

For your convenience, printed below is an updated list of Ohio depository institutions to which presentment of checks and other cash items cannot yet be made, together with a list (on the reverse side) of Ohio institutions to which such presentment has been resumed.

This circular supersedes our Circulars Nos. 9838, 9840, 9843, 9845, 9847, 9865, 9867, and 9870. In addition, it reflects the reopening of Molitor Loan & Building Company as a branch of The Central Trust Company, NA, Cincinnati, Ohio (Routing No. 0420-0039-8).
