The schedules reflect **new Systemwide standard terminology** for all check products, and some price increases in cash letter fees, forward collection and return item products, and large dollar return item notification fees. There are no changes in fees for the payor bank services products.

#### **Footnotes**

- Windsor Locks requires separate cash letters for NWNE (routing numbers 0116, 0117, 2116, 2117) and SWNE (routing numbers 0111, 0118, 0119, 0211, 2111, 2118, 2119, 2211). Tiered pricing will be offered at both the regular and premium deposit options. In the pricing exhibit, the NWNE fee is shown first. For example, under the RCPC regular deadline, the NWNE blended fee is 2.4 cents, while the SWNE fee is 2.2 cents.
- Windsor Locks also offers a tiered RCPC fine sort pricing option. Similar to the RCPC unsorted products, the NWNE and SWNE zones show different fees. In this case, the deposit deadlines are also different: NWNE has a 0315 deadline, while SWNE shows a 0400 deadline.
- The New York Office does not accept interterritory deposits. Instead, items drawn on New York City depository institutions should be deposited with East Rutherford.
- 4/ All offices in the New York District charge a special \$1.00 per item fee for non-standard non-machineable deposits.
- 5/ East Rutherford offers a premium group sort at 0300 for 3.1 cents per item, and a premium group plus at 0600 for 4.1 cents per item.
- 6/ Philadelphia also offers three payor group sort deposit options priced at 0.7, 0.9, and 0.5 cents per item with deposit deadlines of 0030, 0230, and 0400.

In the Cleveland Office, RCPC fine sort depositors have an extra 15 minutes to deposit fine sort work provided the accounting data is in electronic format.
- The Cleveland Office offers two premium group sort options at 0415 with per item fees of 1.0 and 0.9 cents, and a payor group option at 0430 with a per item fee of 0.8 cents. The other offices in the Cleveland District offer similar group sort options.
- 10/ In addition to the 0930 city group sort option, Cleveland also offer a forward collection option (Sort Fourth), which accepts all Fourth district city and HDGS items in a single cash letter at 0300. Fees are \$5.25 cash letter, 1.8 cents Cleveland city, 2.4 cents other Fourth district city, 4.4 cents Cleveland RCPC, and 25.0 cents for all HDGS endpoints.
- 11/ Columbus offers two city group sort products: one at 0745 for 0.8 cents/item, and a payor group sort at 0900 for 0.5 cents/item.

- The Chicago Office offers two regular and two premium group sort deposit options a 0719 option and a 0711/0712 option. The first fee shown is the 0719 product, while the second fee is the 0711/0712 product. In addition, Chicago offers a 0300 deadline priced at 6.0 cents per item. Contact the Chicago Office for information concerning these group sorts.
- 16/ In addition to the two premium group sort products, Chicago also offers an electronic cash letter (ECL) deposit product with a 0300 deadline and a per item fee of 2.1 cents. Contact the Chicago Office for more details concerning the ECL product.
