This pamphlet contains the facsimile signatures of the Chairman and Deputy Chairman of the Board of Directors of the Federal Reserve Bank of New York and of the officers authorized to sign on behalf of this Bank and its Buffalo Branch. It supersedes the pamphlet issued in March 1993, and the First through Fourth Supplements thereto.

Evidence of the signing authority of other Bank employees — including Bank personnel who have authority to sign correspondence and reconcilements and those who have authority to sign documents “per procuracy” or to sign on behalf of the Bank as fiscal agent of the United States, Government agencies, or international organizations — may be obtained upon written request directed to our Personnel Department, or to the departments of this Bank with responsibility for the activities to which the documents relate.

All checks or drafts payable in foreign countries, and all foreign correspondence authorizing payments or transfers of funds, or delivery of securities or other property, must bear the authorized signatures of two officers, and one of such signatures must be that of the President, the First Vice President, an executive vice president, a senior vice president, a vice president, an assistant vice president, or any other officer of equivalent rank.

All instruments, documents, correspondence, and other papers in connection with the transaction of domestic business need bear but one authorized signature.
