1974 STATE PERSONAL INCOME

Per capita personal income in 1974 ranged from \$7,023 in Alaska and \$6,471 in Connecticut to \$3,764 in Mississippi, compared with the U.S. average of \$5,434 according to the Bureau of Economic Analysis, an agency of the Social and Economic Statistics Administration of the United States Department of Commerce.

Per capita income gained the most in 1974 in Alaska (18-1/2 percent), the District of Columbia (14 percent), Idaho (12-1/2 percent), New Hampshire (11-1/2 percent), and West Virginia, Rhode Island, and Kentucky (10-1/2 percent each). These gains compare with the national increase in consumer prices of over 11 percent. Per capita income declined in South Dakota (11-1/2 percent), Nebraska (8 percent), North Dakota (3-1/4 percent), and Iowa (3/4 percent).

States with high per capita incomes are concentrated in the Northeast and Far West. Those with low incomes are generally located in the Southeast. Per capita income in 1974 topped the national average by 15 percent to 30 percent in 6 States and trailed the national average by 20 percent to 30 percent in 6 States (see tables A and B and map).

Total personal income changes in 1974 ranged from a gain of more than 20 percent in Alaska to a loss of 11-1/2 percent in South Dakota. The nationwide increase was 8-1/2 percent, almost 3 percentage points below the national advance in consumer prices. Gains in total income equaled or exceeded the national rise in consumer prices in the District of Columbia and in 11 States: Alaska, Idaho, New Hampshire, South Carolina, Florida, Wyoming, Kentucky, Arizona, Washington, Oregon, and Utah. In 35 States, the 1973-74 total personal income gains ranged from 1-1/2 percent to 10-3/4 percent. Total personal income declined in South Dakota ( 11-1/2 percent), Nebraska ( 7-1/4 percent), North Dakota ( 3 percent), and Iowa ( 1 percent). These declines reflected very sharp drops in farm income.

Disposable personal income -- personal income less personal tax and nontax payments to all governments -- moved very much in line with personal income. Alaska led again, with 1974 gains of 20 percent and 17-3/4 percent in total and per capita disposable personal income, respectively. (See table below.) South Dakota had the sharpest drop in both categories.

The national total of State disposable income gained nearly 8 percent from 1973 to 1974, compared with a runup of over 11 percent in consumer prices. Income changes cannot be compared with price changes on a State level because personal consumption expenditure deflators are not available for States.

Total personal income, from the fourth quarter 1973 to the fourth quarter 1974, rose in 45 States and fell in 5 States. During the decline in general economic activity, the rise in income was particularly sharp, 12 percent or more, in Alaska, Idaho, and West Virginia, the only States where income gains topped or matched price increases. In 42 States and the District of Columbia, the rise in income ranged from 1-3/4 percent to 11-1/2 percent. Personal income fell sharply in South Dakota and Nebraska, and moderately in North Dakota, Iowa, and Kansas. For the Nation as a whole, total personal income rose 7-1/2 percent, but consumer prices increased somewhat more than 12 percent from the fourth quarter of 1973 to the fourth quarter of 1974.

Much of the recent weakness in total personal income is directly traceable to agriculture. The Nation's farm income, which peaked in the fourth quarter of 1973, fell about 40 percent by the fourth quarter of 1974. In each of the five States where income was off, developments in farming played the key role.

Farm income usually changes independently of the national business cycle and these frequently erratic changes obscure underlying cyclical developments. Effects of the national business cycle can be seen more clearly in the estimates of nonfarm income.

Nonfarm income increases ranged from 7-3/4 percent in Michigan to nearly 25 percent in Alaska (table C), compared to the national increase of 9-3/4 percent from the fourth quarter of 1973 to the fourth quarter of 1974. In most fast-growing States, nearly all major income components expanded rapidly, while in States where income growth was sluggish, most components were weaker than their national counterparts.

The smallest nonfarm income gains, all 8-1/2 percent and under, were registered in nine States: Michigan, Delaware, Indiana, Georgia, Vermont, North Carolina, New Jersey, New York, and Maine. Their manufacturing payrolls were down, or lagged well behind the national average gain. In Michigan, Delaware, Indiana, and New Jersey, the weakness centered in durable goods manufacturing and, except in New Jersey, largely reflected the decline in auto production. In North Carolina, Georgia, and New York, the weakness centered in nondurable goods manufacturing, mainly in textiles and apparel. In most of the slow-growing States, contract construction payrolls also declined sharply. While large increases in unemployment compensation cushioned the weaknesses in manufacturing and construction, most major local service-type industries grew at below-average rates.

The largest gain in nonfarm income was in Alaska, up 25 percent. Gains of 12 to 15 percent were registered in 6 States: Idaho, Wyoming, North Dakota, West Virginia, New Mexico, and South Dakota. A sharply higher demand for domestically produced energy was the principal cause of these large gains. In Alaska, Wyoming, West Virginia, and New Mexico, mining payrolls rose markedly. In Alaska, contract construction payrolls surged as work started on the oil pipeline.

In the seven fast-growing States, construction advanced rapidly and, except in South Dakota, so did manufacturing. As a result of the advances made in these basic (export) industries, gains in most local-service industries were also strong.

Note:--Per capita personal income equals total personal income divided by total population.

Total personal income consists of private and government wage and salary payments in cash and in kind, other labor income, farm and nonfarm proprietors' income, interest, net rents, dividends, and transfer payments, less personal contributions for social insurance. It is measured before the deduction of personal income and other personal taxes and is reported in current dollars (no adjustment is made for price changes).

Estimates of total and per capita personal income for each region and State, along with rates of change, are shown in table A. This table also shows the State composition of each region. A ranking of the States and regions by per capita income for 1974 is shown in table B. A ranking of percent changes in nonfarm personal income and total income from the fourth quarter 1973 to the fourth quarter 1974 is shown in table C. The map shows per capita income in the States and regions in 1974.
