This publication serves as a guide to the reader who wishes to follow over time the data series published in the *Federal Reserve Bulletin* and the *Annual Statistical Digest*.

Unless otherwise noted, the tables in the *Federal Reserve Bulletin* referred to here are published each month, and they contain the latest annual, quarterly, monthly, or weekly data available as of the date of publication. Changes in the form or content of tables during 1990 have been noted.

Because the frequency of the data shown may vary among the publications listed, the frequencies for each table are shown in parentheses, as are other pertinent differences.

Generally speaking, titles of tables in the *Annual Statistical Digest* do not indicate the period covered, and no attempt has been made to include such information unless, in the case of the *Digest* for 1980-89, the period is different from ten years, or, in the case of the *Digests* for 1981 through 1988, it is different from one year.

Because the sequence is established by the order of the *Bulletin* tables, the table numbers for the *Digests* are not necessarily consecutive.
