JOINT RESOLUTION [S.J. Res. 55]

To print the monthly publication entitled "Economic Indicators"

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the Joint Economic Committee be authorized to issue a monthly publication entitled "Economic Indicators," and that a sufficient quantity be printed to furnish one copy to each Member of Congress; the Secretary and the Sergeant at Arms of the Senate; the Clerk, Sergeant at Arms, and Doorkeeper of the House of Representatives; two copies to the libraries of the Senate and House, and the Congressional Library; seven hundred copies to the Joint Economic Committee; and the required numbers of copies to the Superintendent of Documents for distribution to depository libraries; and that the Superintendent of Documents be authorized to have copies printed for sale to the public.

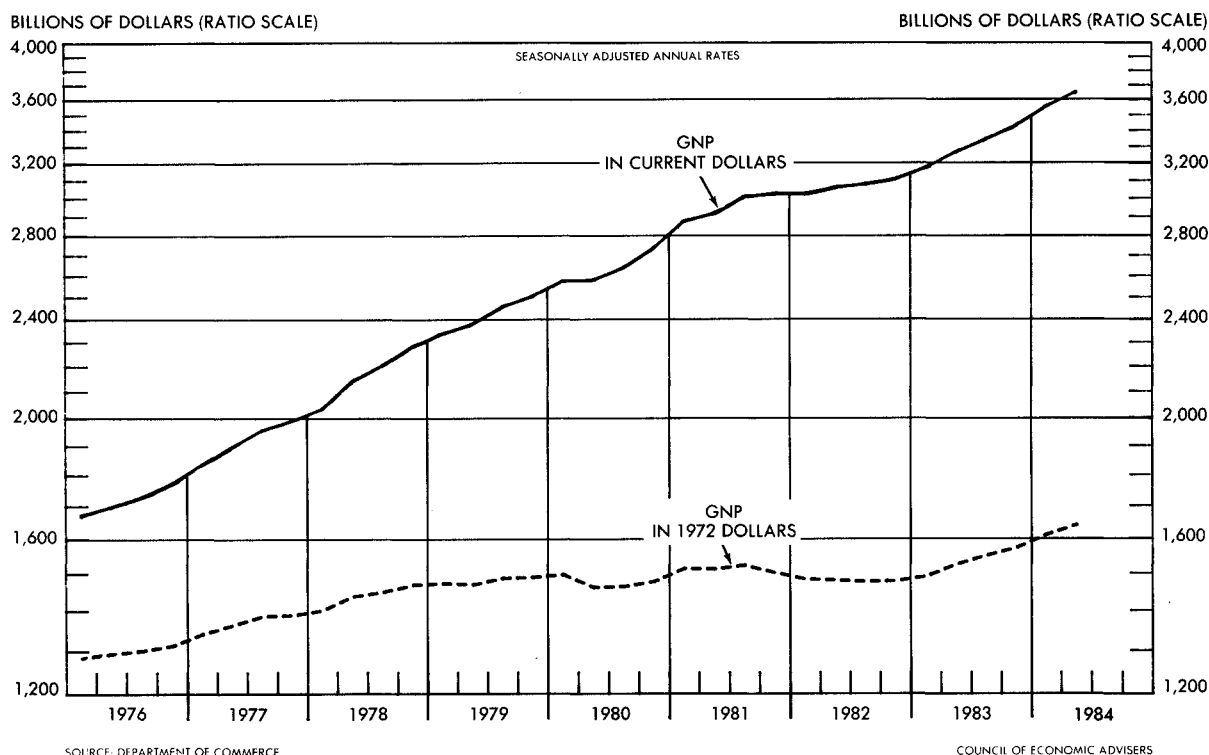

TOTAL OUTPUT, INCOME, AND SPENDING

GROSS NATIONAL PRODUCT

According to revised estimates for the second quarter of 1984, gross national product rose \$94.8 billion or 11.1 percent, both at annual rates. Real output (GNP adjusted for price changes) rose 7.6 percent (annual rate) and the implicit price deflator rose 3.2 percent (annual rate).

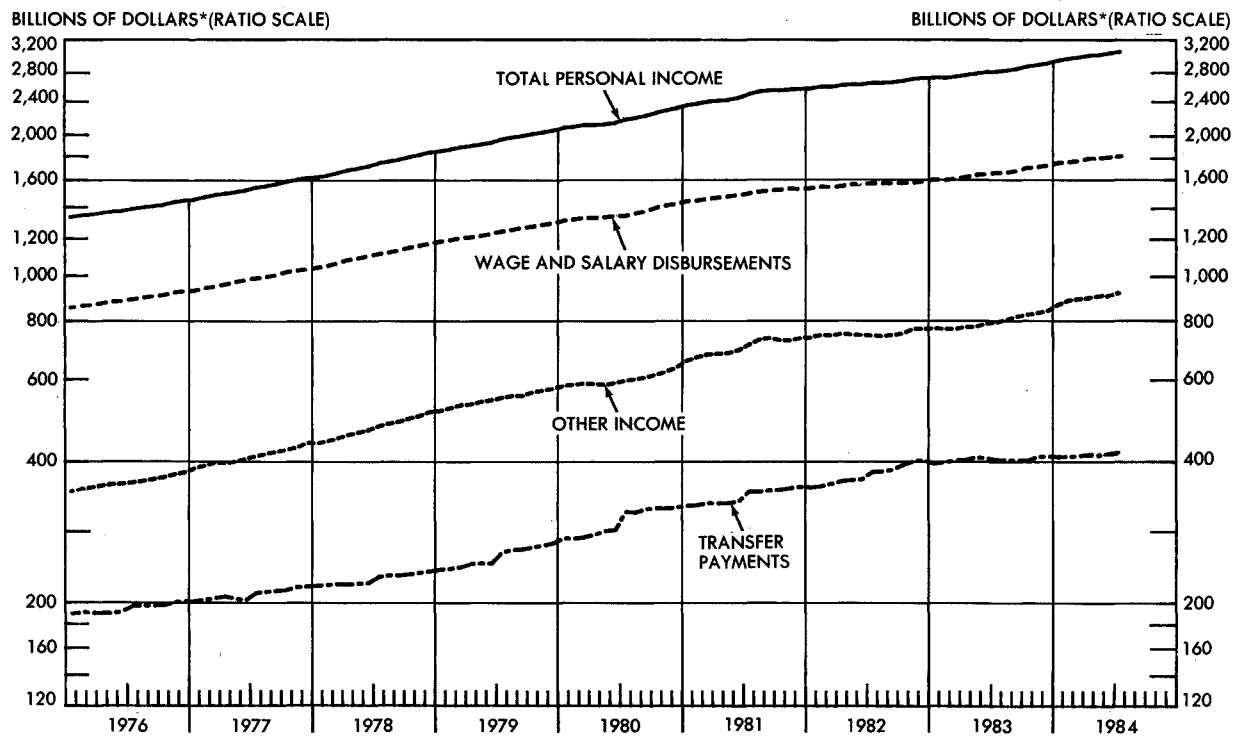

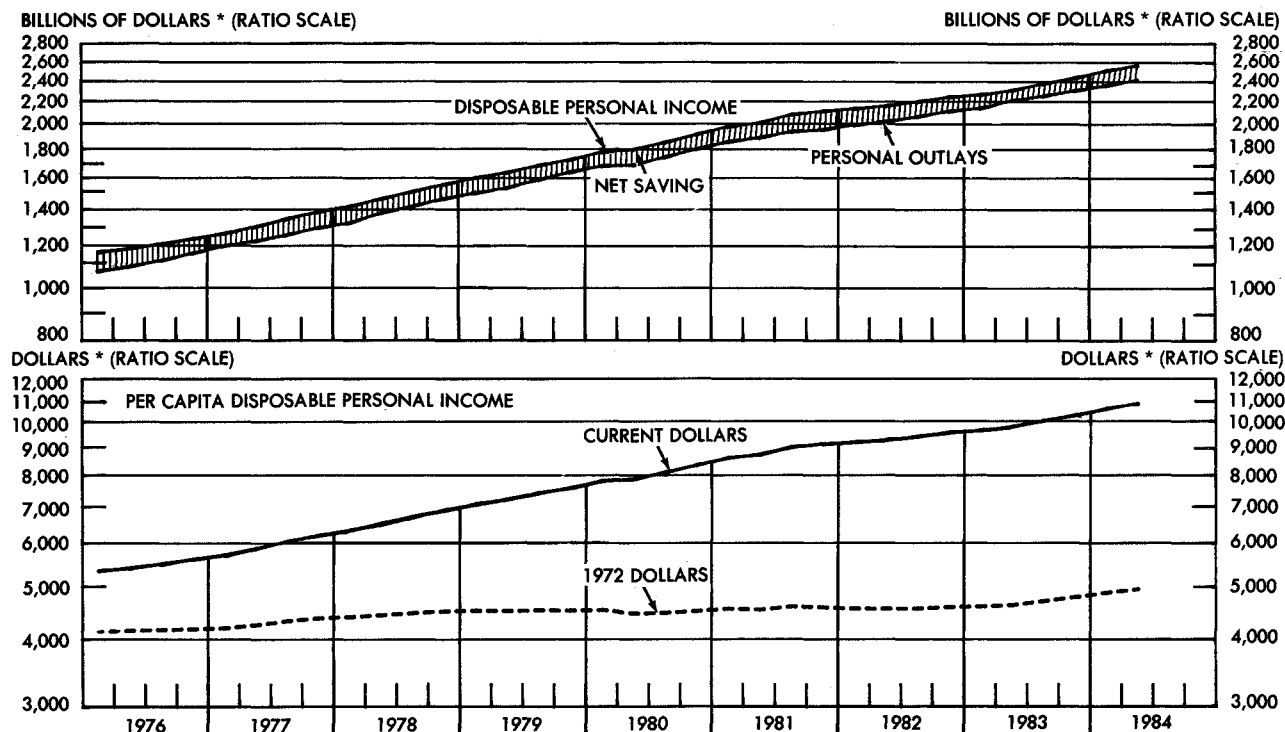

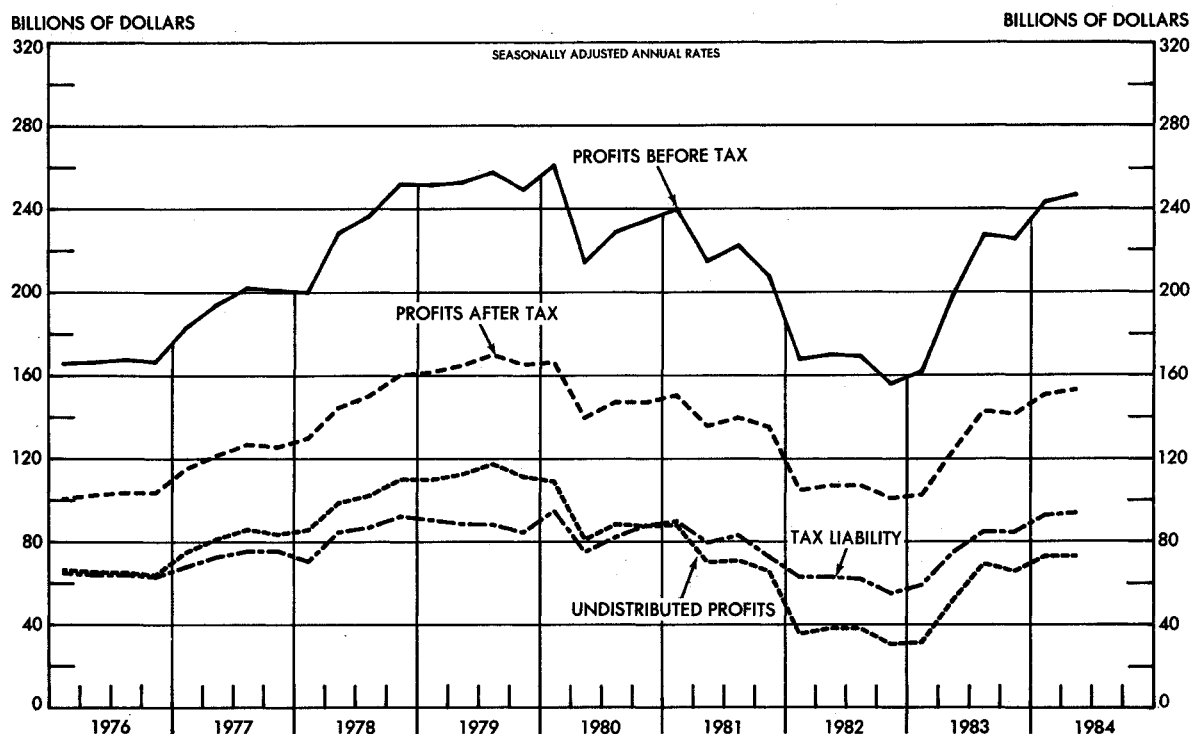

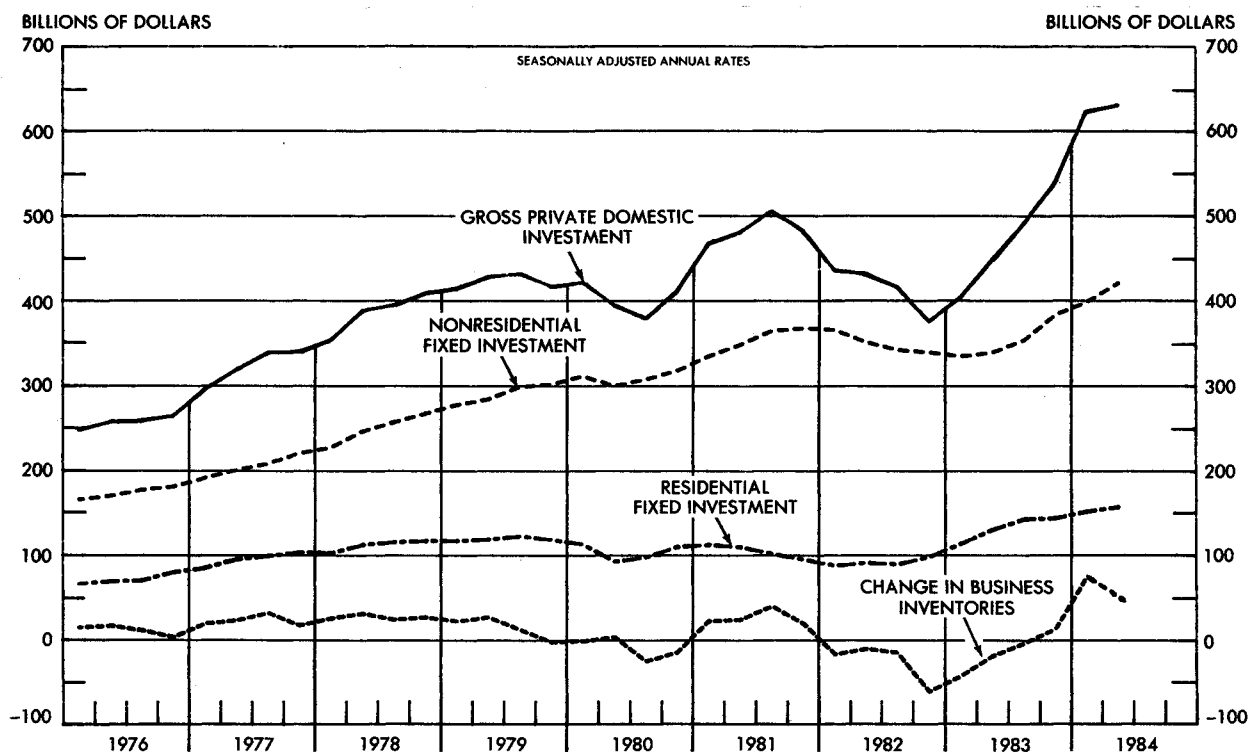

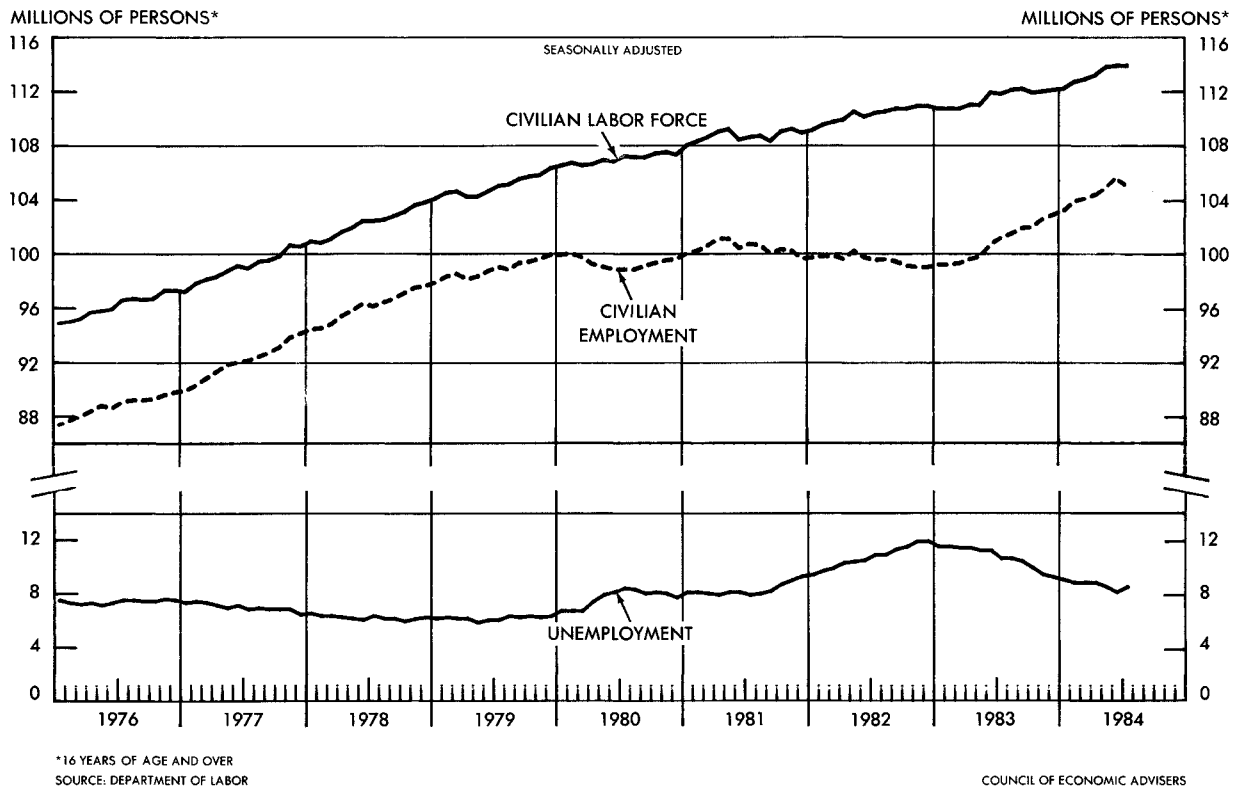

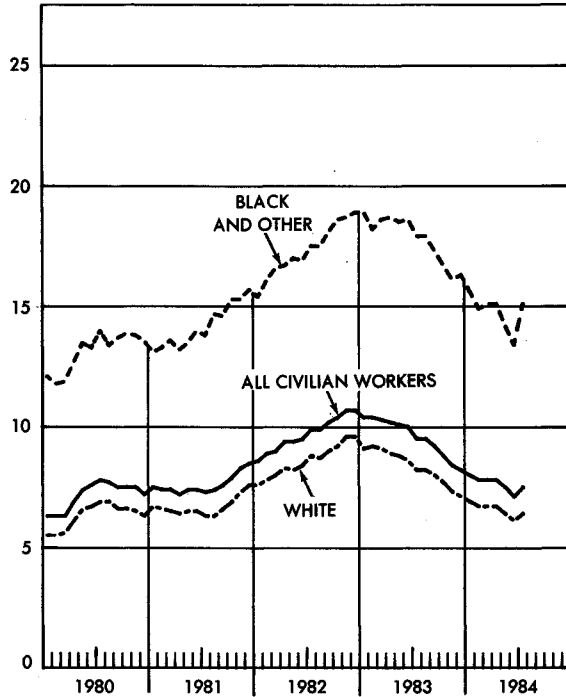

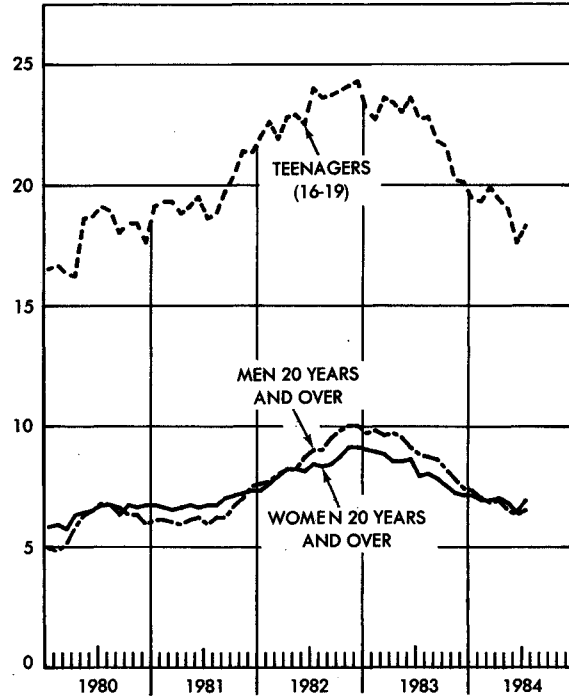

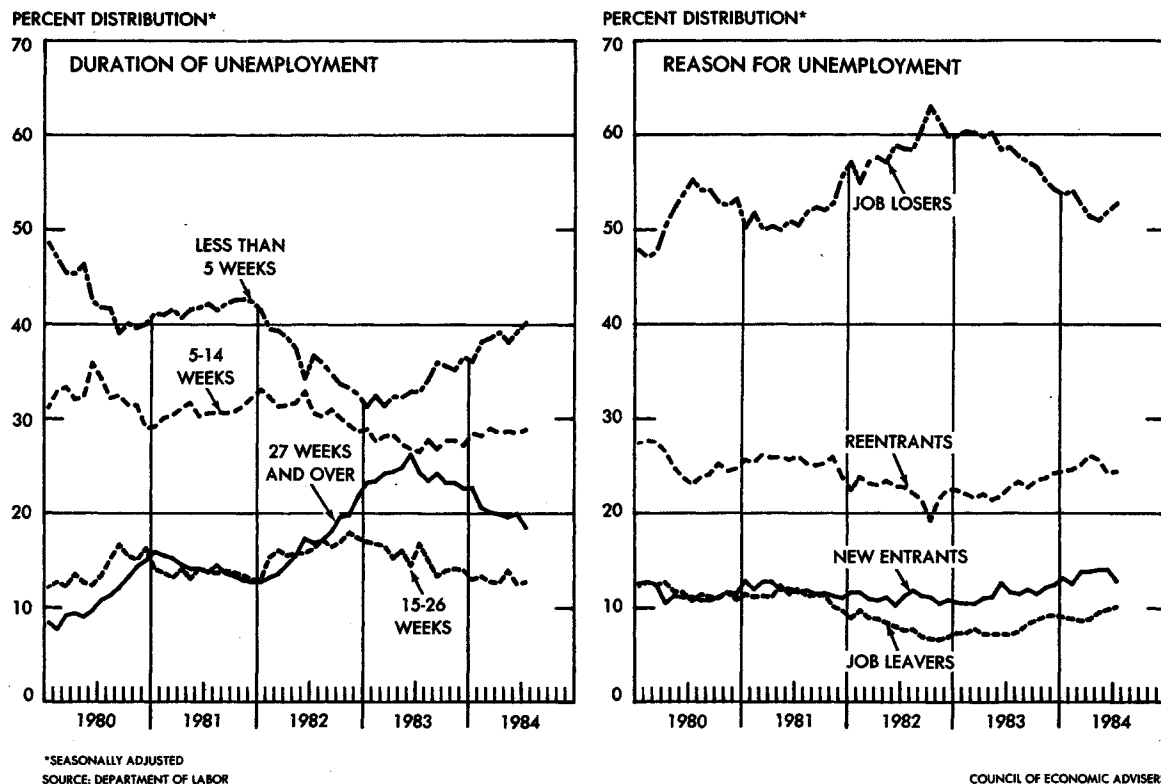

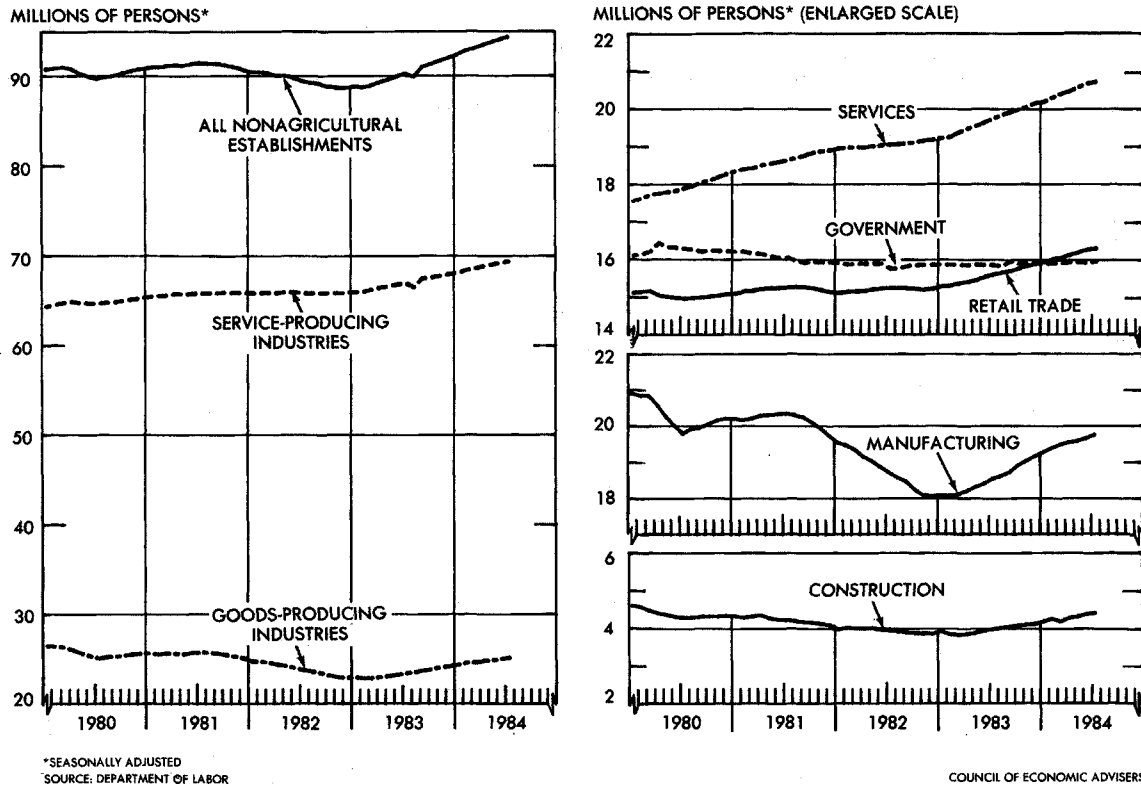

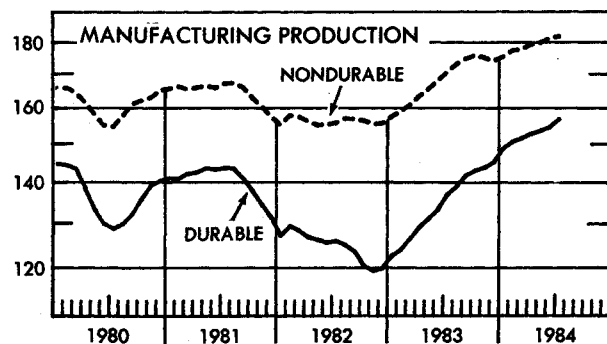
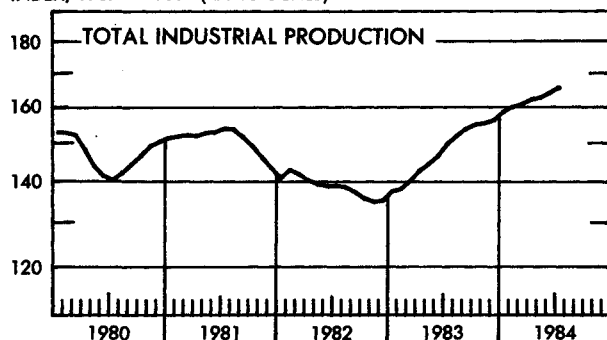

INDUSTRIAL PRODUCTION AND CAPACITY UTILIZATION

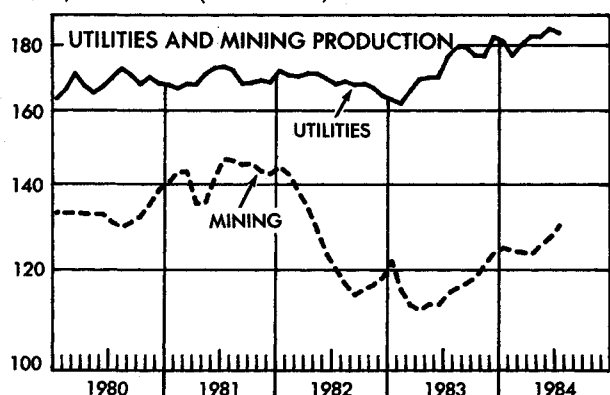
Industrial production rose 0.9 percent in July following a similar increase in June. The index for July was 10.6 percent above its year earlier level.

INDEX, 1967 = 100* (RATIO SCALE)

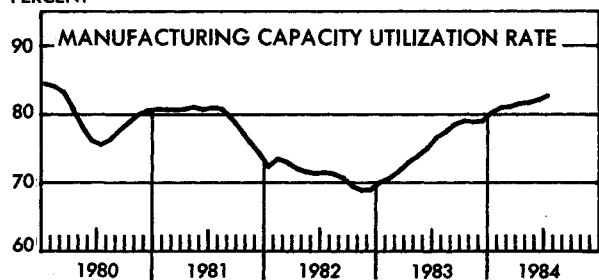

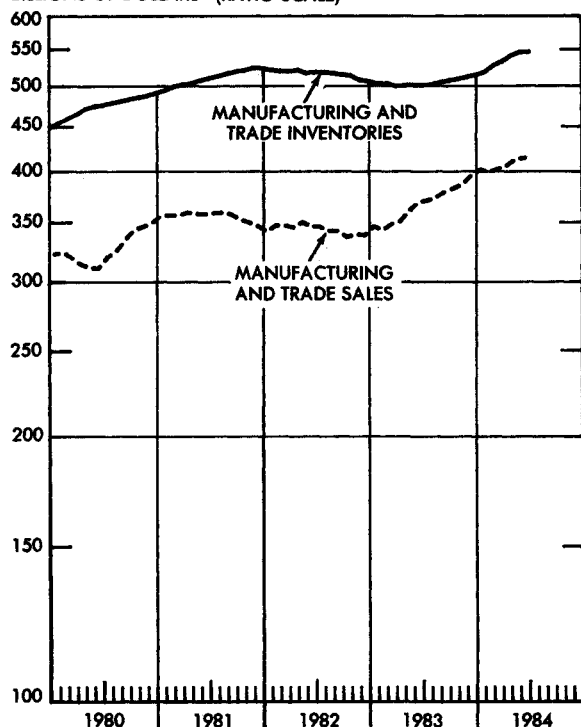

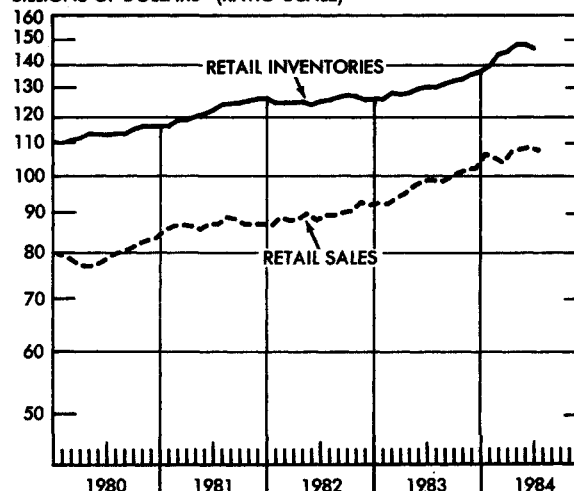
BUSINESS SALES AND INVENTORIES—Manufacturing and Trade

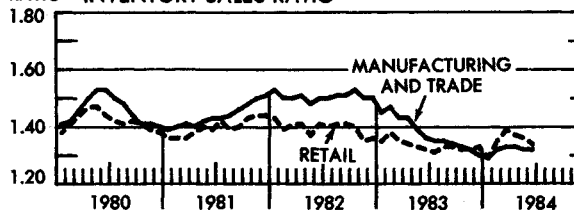
BILLIONS OF DOLLARS* (RATIO SCALE)

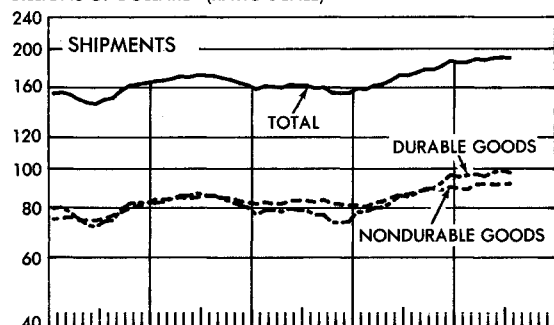

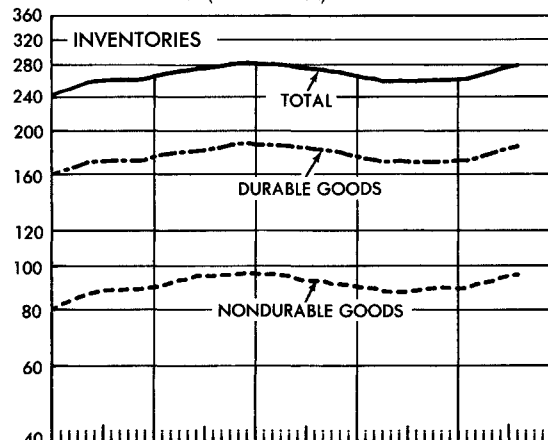

In July, manufacturers' inventories and orders rose while shipments fell.

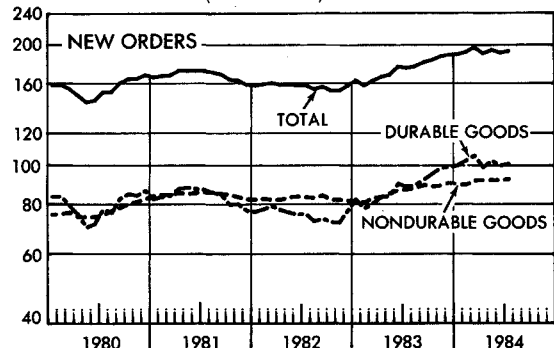
BILLIONS OF DOLLARS* (RATIO SCALE)



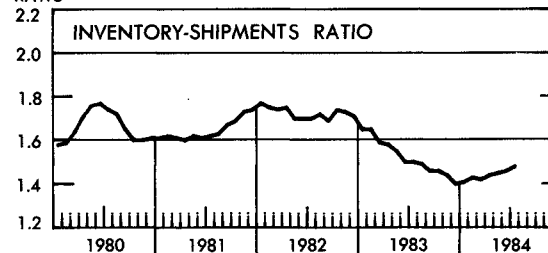
BILLIONS OF DOLLARS* (RATIO SCALE)

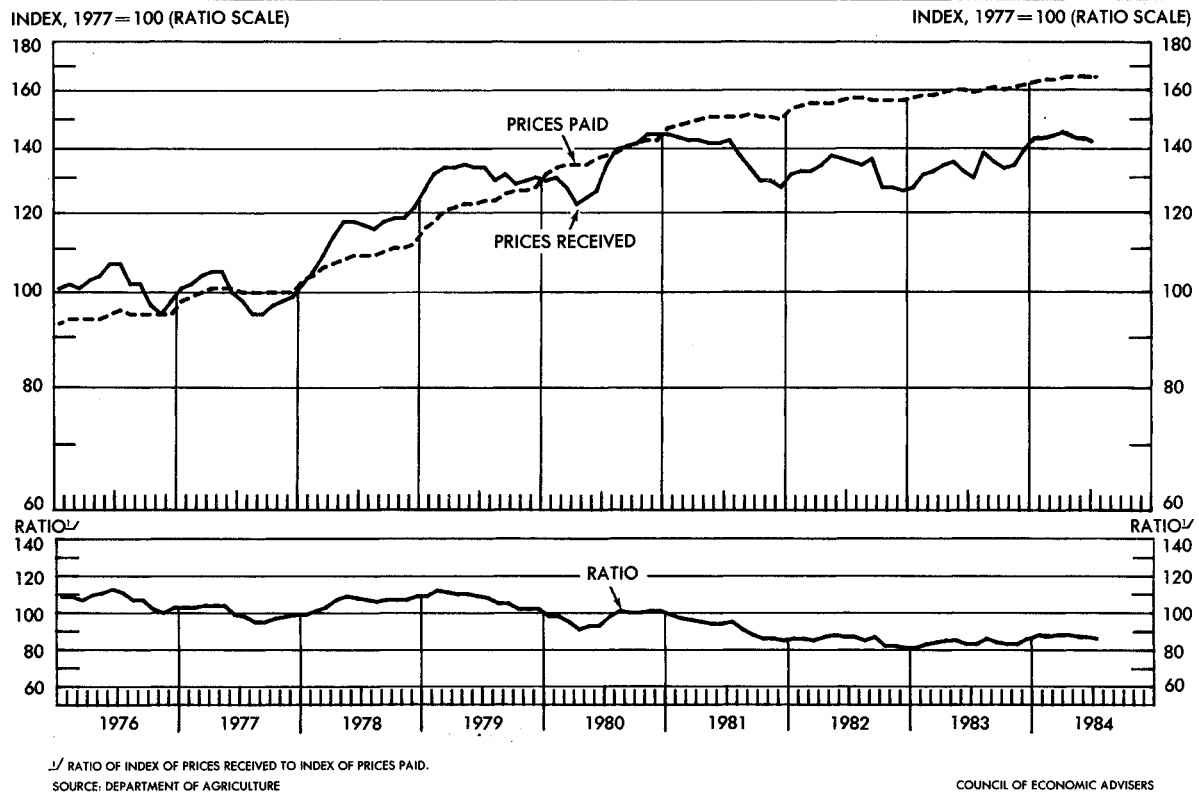

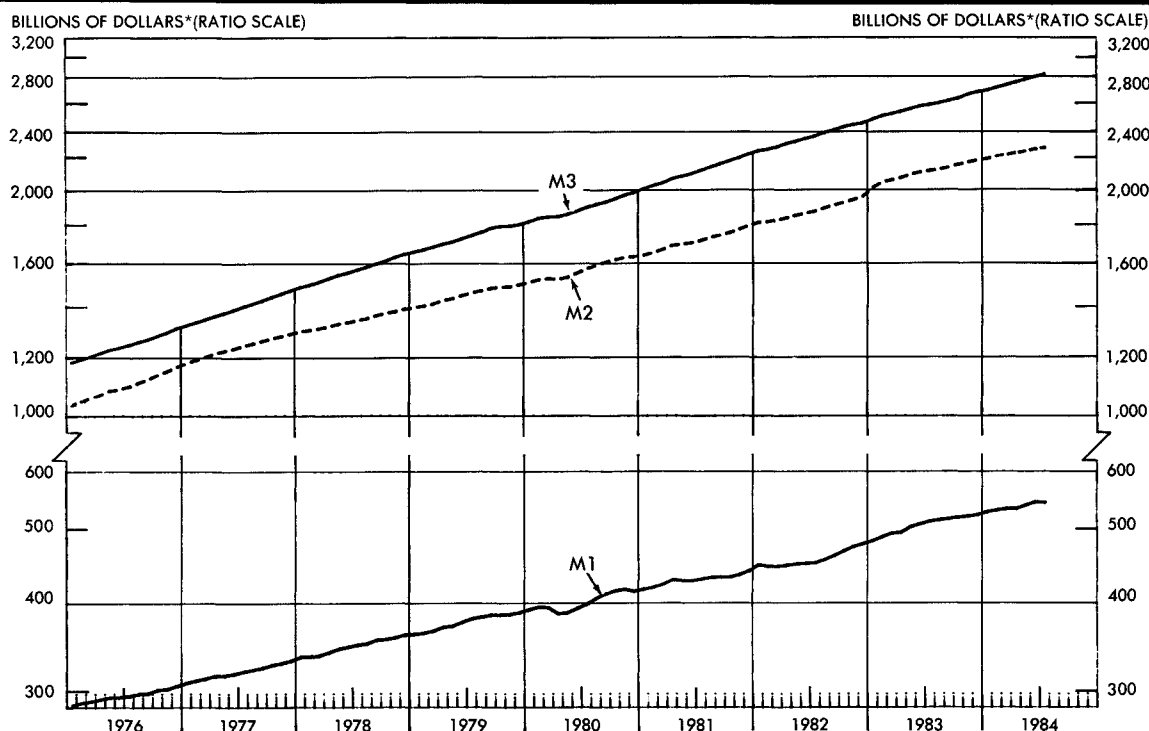

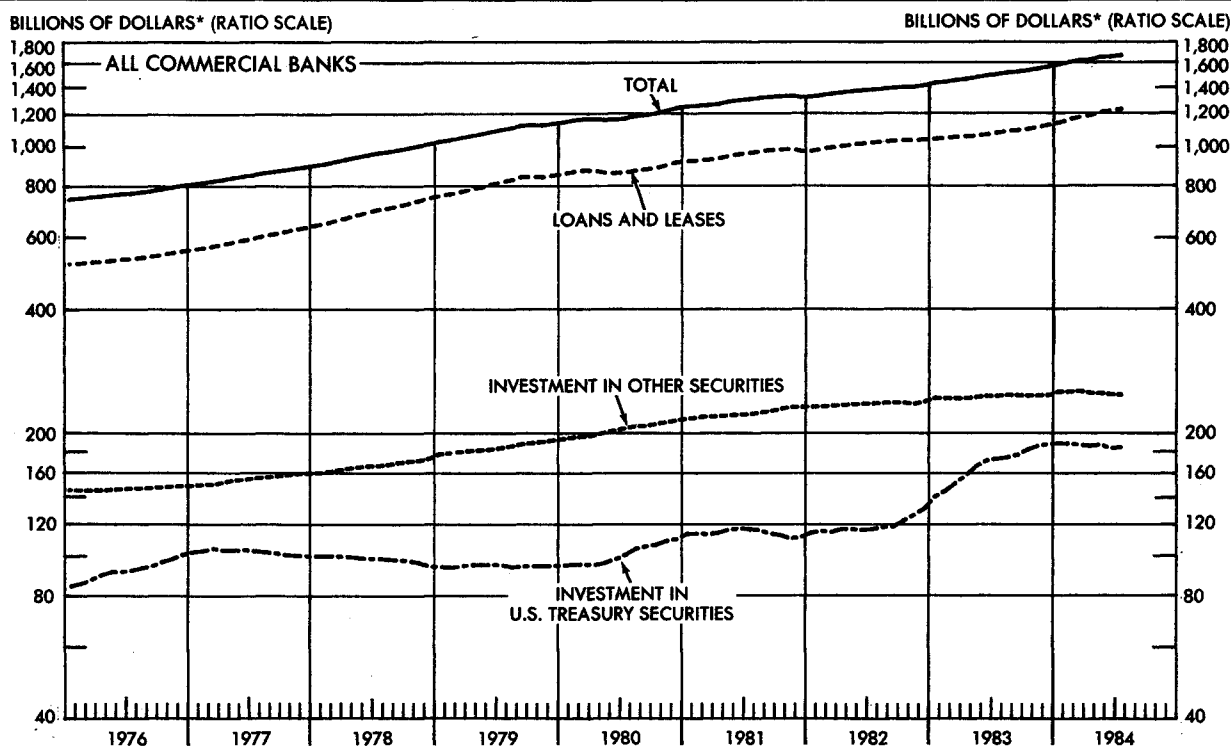

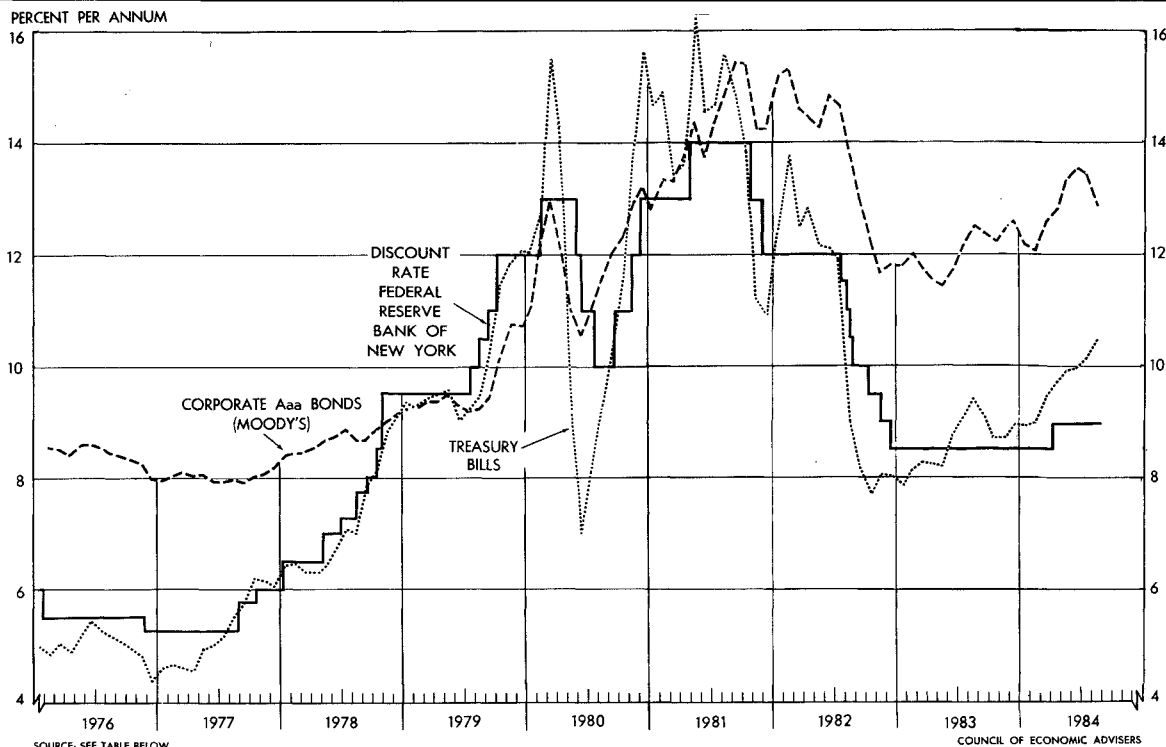

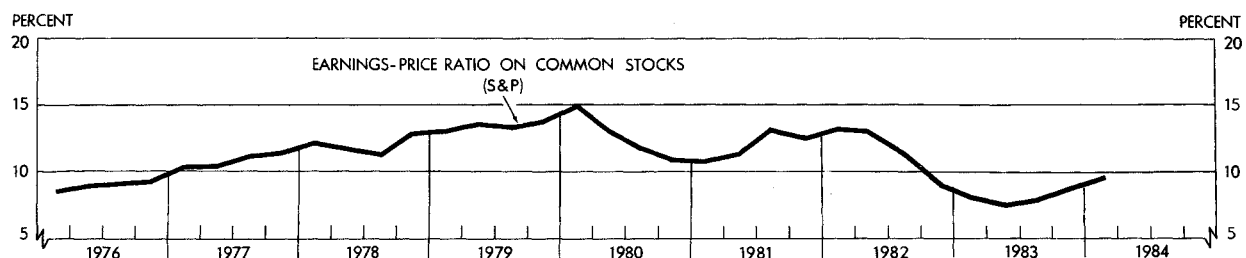
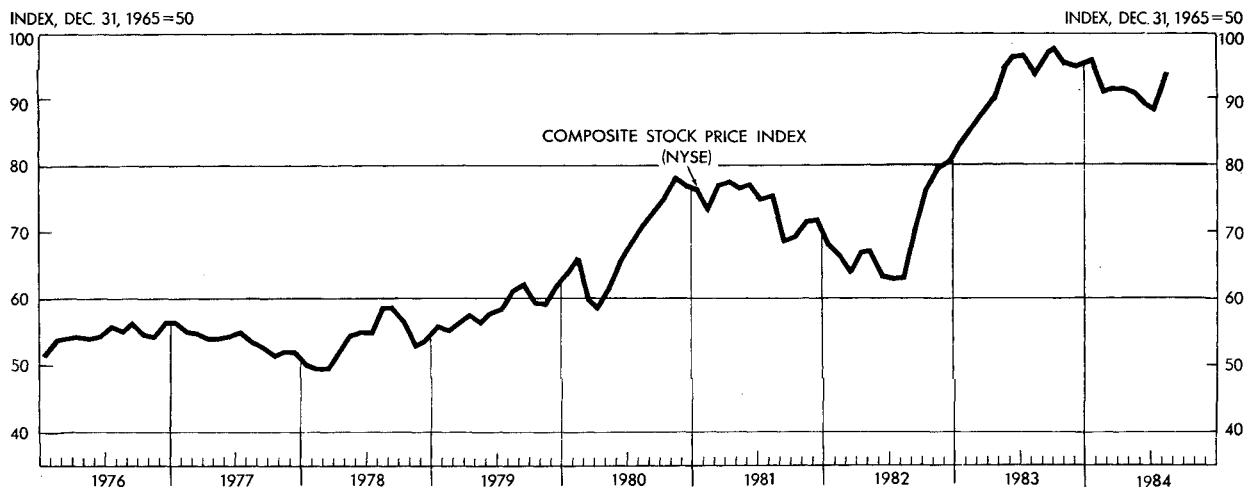

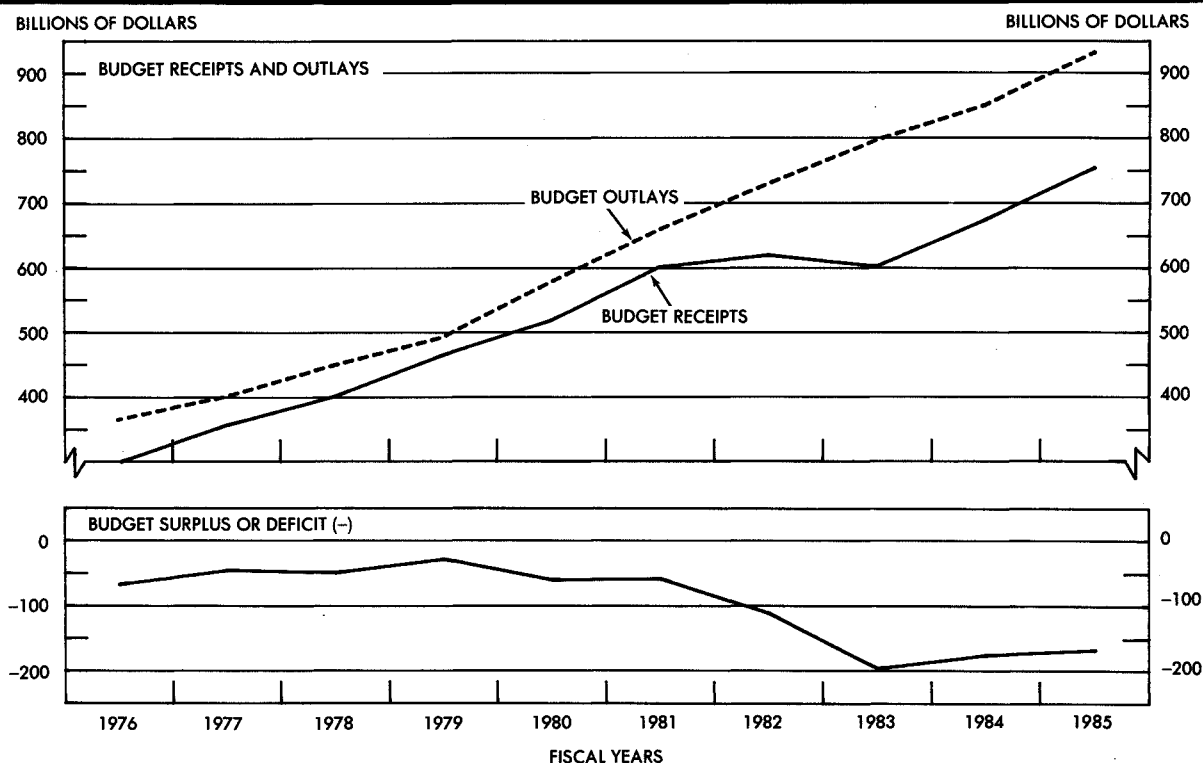

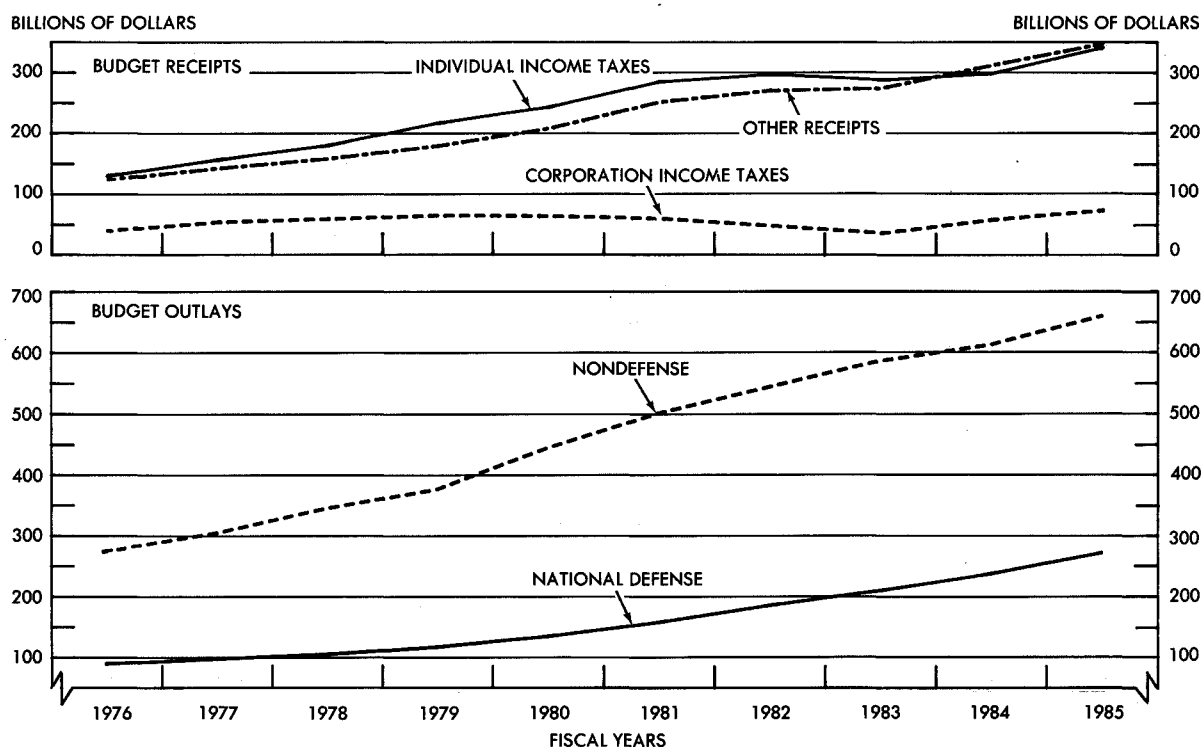

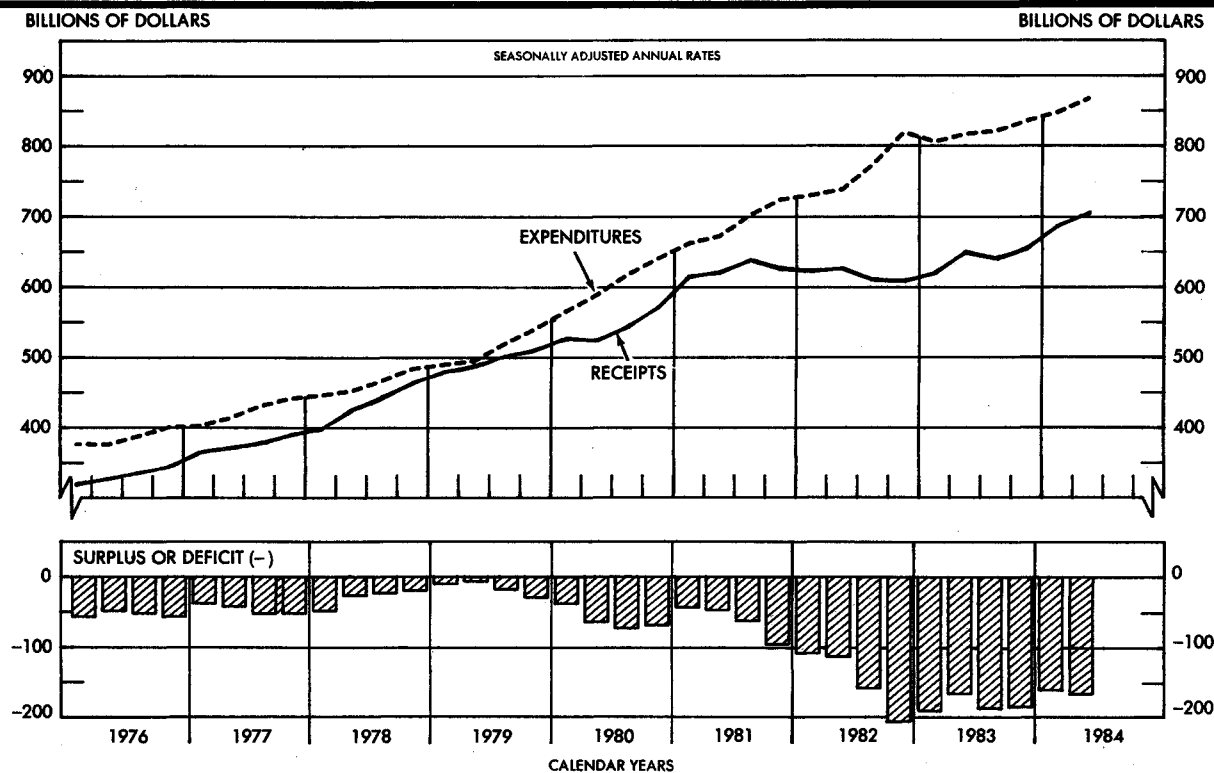

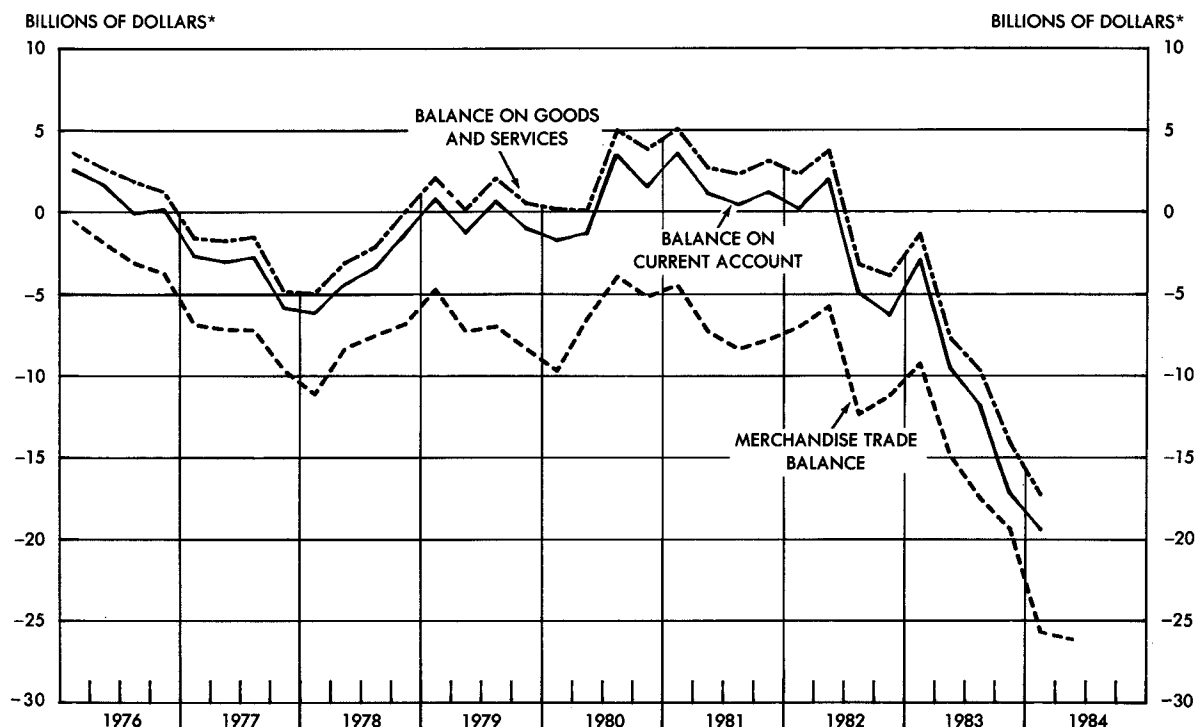

Liabilities to foreigners and international financial institutions reported by U.S. banks (including U.S. Treasury securities) increased \$11.3 billion compared with a \$24.0 billion increase in the fourth quarter.
